



LYON COUNTY SHERIFF'S OFFICE MEDIA RELEASE

- On the evening of Sunday, September 28, 2025, around 6:45pm the Lyon County Sheriff's Office received a complaint regarding threats made to the high school from a student which were separate from the incident last Friday. Deputy Bobby Beeler, SRO Deputy Cory Jessup, and school administrators collaborated to identify the suspect and any witnesses to these threats.

Following a multi-hour investigation, it was determined the juvenile had made one alarming statement and one threatening statement to fellow students during the lockdown period following Friday's incident. Juveniles who overheard these statements reported it to their family members on Sunday evening, resulting in calls to school administrators and the Sheriff's Office.

In the early morning hours of Monday, September 29, 2025, a 15-year-old juvenile male was taken into custody by Deputy Bobby Beeler. The juvenile student was charged with Terroristic Threatening - 2nd Degree. He was been lodged in the McCracken Regional Juvenile Detention Center in Paducah.

It is unknown at this time if these incidents are related to the threat received on Friday; however, the Kentucky State Police and the Lyon County Sheriff's Office are continuing to investigate.

- On Tuesday, September 30, 2025, just before 7pm, Sheriff's Office personnel were dispatched to a burglary in progress complaint on Wilderness Road. In addition, the Eddyville Police Department and Kentucky State Police also responded due to the caller reporting up to five (5) people being involved in the burglary event. Upon arrival, no persons, except Jacob G. Buchanan (30) of Kuttawa, were present. The investigation determined Buchanan was under the influence of Methamphetamine and was hallucinating while in the presence of law enforcement officers. Buchanan was found to be in possession of illegal drugs and firearms. He was arrested and charged with the following offenses:

- Possession of Controlled Substance-1st Degree, 2nd Offense (Meth)

- Possession of Marijuana
- Drug Paraphernalia-Possession
- False Report an Incident to Law Enforcement (Felony Offense)
- Possession of Firearm by a Convicted Felon

Buchanan was lodged in the Crittenden County Detention Center.

- On Wednesday, October 1, 2025, around 10:23am, Sheriff Brent White received a complaint from court security deputies regarding an adult female who appeared intoxicated in Lyon District Court. Sheriff White located the female in the courtroom and after she concluded her business with the Court, he spoke to her and determined she was manifestly under the influence of Methamphetamine. She was identified as Sandra K. Randall (53) of Joelton, TN. Randall was arrested and charged with Public Intoxication (Controlled Substance). She was lodged in the Crittenden County Detention Center.
- On Wednesday, October 1, 2025, around 4:35pm, Deputy Josh Travis served a McCracken County criminal summons on Avinash Shirkrisin (27) of Suwanee, charging him with Theft by Unlawful Taking-Shoplifting as it pertained to an incident in Paducah on August 23, 2025. Shirkrisin was summoned to appear in McCracken District Court in October.
- On Thursday, October 2, 2025, around 1:30pm, Chief Deputy Sam Adams responded to an animal complaint on East Ridge Road whereby the 9-1-1 caller stated a vicious dog would not allow her to leave her home without being bitten. Chief Deputy Adams located the dog and its owner. He charged Cynthia E. Sanbourn (67) of Eddyville on a citation for Harboring a Vicious Animal. She will appear in Lyon District Court in October.
- On Thursday, October 2, 2025, around 4:35pm, Deputy Josh Travis and an Eddyville Police Department officer located Caleb M. Wellborn (30) of Eddyville at a home on KY 293. Wellborn was the subject of a bench warrant from Lyon District Court whereby he failed to appear in court and failed to pay child support. Wellborn was arrested on the warrant by Deputy Travis and lodged in the Crittenden County Detention Center.
- On Friday, October 3, 2025, around 12:30pm, Chief Deputy Sam Adams arrested Mae N. Frazier (51) of Kuttawa after she voluntarily surrendered herself at the Sheriff's Office following the issuance of a bench warrant from Fayette District Court where she stands charged with Receiving Stolen Property < \$1,000. Frazier posted a \$500 cash bond and was released from custody.
