

LYON COUNTY SHERIFF'S OFFICE MEDIA RELEASE

- On Monday, October 13, 2025, around 8pm, and following a burglary and theft complaint earlier in the day at a construction site on Tarryon Too Drive in Kuttawa, the Sheriff's Office and KSP were dispatched to the same location for another trespassing complaint. Upon arrival, Troopers and Deputy Bobby Beeler located a vehicle on the property which had driven beyond signage which warned against trespassing. Further investigation led to the arrest of a man and woman at the construction site. The man was identified as Justin A. Mayhugh (36) of Kuttawa and a woman identified as Amanda Rowlands Overbaugh (35) of Kuttawa. Mayhugh was a fugitive from Livingston County at the time of his arrest. KSP Troopers served a bench warrant from Livingston Circuit Court upon Mayhugh for probation violation for felony offense. In addition, Deputy Bobby Beeler arrested and charged both Mayhugh and Overbaugh with Criminal Trespassing-2nd Degree. They were both lodged in the Crittenden County Detention Center. The investigation into the thefts and burglary at this location continues. If anyone has information concerning these crimes, they are asked to contact Sheriff Brent White at 270.388.2311.
- On Tuesday, October 14, 2025 just after 9:30pm, Deputy Bobby Beeler responded to Kuttawa for a two-vehicle, non-injury collision. His investigation revealed a 2019 Western Star semi, driven by Todd L. Hanzlik (45) of Gillette, WY collided with a parked 2026 Peterbilt owned by Annett Holdings of Des Moines, IA. No injuries were reported in the collision.
- On Thursday, October 16, 2025, around 9:15am first responders were dispatched to a two-vehicle injury collision at the intersection of KY 93 South, KY 293 and KY 1055. The investigation by Chief Deputy Sam Adams revealed a 2007 Kia, driven by Kimberly D. Fralicx (61) of Eddyville was South on KY 93 when she attempted to turn left onto KY 293. Fralicx failed to yield the right-of-way and was apparently blinded by the sun, when she pulled into the path of a North bound semi, owned by Stephanie Perry of Vinson Farms in Cadiz.

Fralicx was trapped in her vehicle and had to be extricated by the Eddyville Fire Department. She was later airlifted by AirEvac to an out-of-state hospital where she remains in ICU. After colliding with Fralicx's vehicle, the semi next collided

with a guardrail before exiting the roadway and going down a steep embankment. The driver of the semi, Jorge Huerta Mercado (45) from Cadiz, was not injured and refused medical transport at the scene.

The following agencies assisted the Sheriff's Office at the scene: AirEvac, Eddyville Fire Department, Eddyville Police Department, Eddyville Street Department, Kentucky State Police, KY Environmental Protection Cabinet, KYEM District 1-Emergency Management, KYTC/Department of Highways, Moore's Towing and Stinnett's Towing.

- On Thursday, October 16, 2025, just after 1pm, deputies charged Ashley M. Fraliex (42) of Greenville on five (5) Muhlenberg District Court bench warrants for non-payment of fines, fees, and court costs. Fraliex is pending extradition back to Muhlenberg County.
- On Thursday, October 16, 2025, around 3:53pm, deputies charged Jennifer D. Villareal (42) of Owensboro on a Daviess Circuit Court indictment warrant charging her with Theft by Unlawful Taking. Villareal is pending extradition back to Daviess County.
- On Thursday, October 16, 2025, just after 10pm, Deputy Josh Travis conducted a traffic stop on a 2014 Ford F150 after receiving complaints about the vehicle's operator driving erratically. The driver was identified as Aimee R. Hampton (48) of Golconda, IL. She was charged with Operating on a Suspended/Revoked License, Possession of Marijuana, and Drug Paraphernalia-Possession.
- On Sunday, October 19, 2025, around 11:15am, Sheriff Brent White served a
 Lyon Circuit Court bench warrant on Christopher A. Hollingworth of Delphi, IN
 after he was extradited from Carroll County, Indiana back to Kentucky to face a
 probation violation for felony offense charge. Hollingworth was originally
 convicted of defrauding a secured creditor in Lyon Circuit Court. He was lodged
 in the Crittenden County Detention Center after being extradited from Indiana.
