



LYON COUNTY SHERIFF'S OFFICE MEDIA RELEASE

- On Monday, October 20, 2025, just before noon, SRO Deputy Jason Young responded to a disturbance in the school cafeteria between two-students. Due to the cafeteria being full and one of the students engaging in violent and threatening behavior, a 16-year-old male student was charged with Disorderly Conduct-1st Degree and removed from the school.
- On Monday, October 20, 2025, just before 1:30pm, Chief Deputy Sam Adams responded to a two-vehicle collision in Kuttawa. His investigation revealed a 2013 Lexus RX350, driven by Sandra L. Rhude (61) of Minneapolis, MN collided with a parked and unoccupied 2020 Ram 5500 work truck, owned by Kenenergy Cooperative of Owensboro. There were no injuries in the collision.
- On Monday, October 20, 2025, just before 6pm, Deputy Bobby Beeler responded to a two-vehicle collision in Suwanee. His investigation revealed a 2013 Ram 1500 truck, driven by Jonathan E. Havlik (33) of Eddyville was stopped in traffic on US 62 Eastbound when a 2005 Dodge Ram truck, driven by Caleb A. Dukes (24) of Elkton collided with the Havlik vehicle in a rear-end fashion. No injuries were reported in the collision.
- On Tuesday, October 21, 2025, just before 10am, Deputy Josh Travis responded to a vandalism complaint at Indian Point Campground. His investigation revealed that sometime between October 18th and 21st, unknown person(s) intentional cut a Wi-Fi cable and three of four tires on a nearby parked SUV, resulting in over \$800.00 in damages. - On Tuesday, October 21, 2025, around 12:30pm, Deputy Josh Travis served a criminal summons on Patricia Creekmur (52) of Eddyville, charging her with Theft by Unlawful Taking/Shoplifting. She stands accused of stealing items from Fivestar in Eddyville without paying for same. The incident was investigated by the Eddyville Police Department.

- On Wednesday, October 22, 2025, around 4pm, Chief Deputy Sam Adams responded to a two-vehicle collision on US 62 near Kuttawa. His investigation revealed a 2020 Ford F250 truck, driven by Michael C. Maynard (45) of Almo was West on US 62 with a trailer in tow, when a piece of plywood, which was not secured, blew off the trailer and collided with a 2024 Harley Davidson FLT motorcycle, driven by Ronald E. McGill (63) of Eddyville. No injuries were reported in the collision.

- On Thursday, October 23, 2025, around 3:20pm, Deputy Josh Travis served a criminal summons on Nicole Thames (40) of Paducah. On October 18th, Deputy Travis responded to animal complaints on Robertson Road and Chestnut Oak Road as it pertained to five pit-bull mixed dogs. His investigation revealed Thames owned the dogs and repeatedly ignored directives to keep the dogs confined at night while unattended. She was charged with one count of Confinement and Control of Dogs At Night. She will appear in Lyon District Court in November.

- On Friday, October 24, 2025, around 11:19am, Deputy Josh Travis responded to a two-vehicle collision on US 62 in Kuttawa. His investigation revealed a 2025 GMC Sierra was West on US 62 when the driver, Thomas J. Sanes (48) of Poplarville, MS changed lanes and collided with a West bound 2025 Honda Pilot, driven by Susan R. Robinson (75) of Kuttawa, which was in the lane next to Sanes, in which he did not see. There were no injuries reported in the collision.

- On Friday, October 24, 2025, around 4pm, Deputy Josh Travis conducted a traffic stop on US 62 East on a 2000 GMC Sonoma truck. Following a roadside investigation and probable cause search of this vehicle, Deputy Travis arrested two occupants of the vehicle and charged them as follows:

- Drug Paraphernalia-Possession

Both Roman and Harris were later lodged in the Crittenden County Detention Center.

- On Saturday, October 25, 2025, around 12:25am, Deputy Shannon Oliver responded to a three-vehicle collision at a Kuttawa business. His investigation revealed a 2020 Peterbilt semi, driven by Andrii Trinchuk (37) of Brooklyn, NY was driving through the Huck's Travel Center parking lot when his semi collided with a parked, 2023 Freightliner, owned by Ryder Truck Rental. This collision caused a secondary collision whereby the Ryder Truck then collided with a parked, 2022 Volvo, owned by Speedtech Logistics of Saskatoon, CD. No injuries were reported in the collision events.
- On Saturday, October 25, 2025, around 12:50pm, Deputy Josh Travis responded to a two-vehicle collision on US 62 in Kuttawa. His investigation revealed a 2003 Chevrolet Tracker, driven by Caden A. Guess (18) of Kuttawa, was at the intersection of KY 93 North and US 62 West, when he failed to yield the right of way, and pulled into the path of a 2006 Chevrolet Cobalt, driven by Michael H. Greene (34) of Dycusburg. No injuries were reported in the collision.
