



## LYON COUNTY SHERIFF'S OFFICE MEDIA RELEASE

- On Monday, December 1, 2025, at 9am, Sheriff Brent White arrested James D. Hughes (50) of Princeton and served him with a Marshall County Circuit Court indictment warrant for Trafficking in Controlled Substance-1<sup>st</sup> Degree, 1<sup>st</sup> Offense (Methamphetamine). He was lodged in the Marshall County Detention Center.
- On Monday, December 1, 2025, at 9:30am, Sheriff Brent White arrested Bryan J. Dennis (37) of Missouri and charged him with being a Fugitive from Justice. Dennis was wanted out of St. Louis County, Missouri for felony obstruction. Dennis was lodged in the Crittenden County Detention Center.
- On Tuesday, December 2, 2025, at 3:47am, the Kentucky State Police dispatch center received a 9-1-1 call from a resident on McKinney Road off KY 819. Deputies Bobby Beeler and Sam Adams responded to the scene and located Rickie A. McKinney (62) of Hopkinsville. McKinney was suspected to be heavily under the influence of an intoxicating substance. He reported multiple persons on the property were trying to kill him; however, no other persons were located. Through investigation, it was determined the call was fictitious and McKinney was arrested by Deputy Beeler and charged with False Report of an Incident to Law Enforcement. He was lodged in the Crittenden County Detention Center.
- On Tuesday, December 2, 2025, at 12:54am, Deputy Lori Francis served a Boyd District Court bench warrant on Kimberly D. Moore (33) of Flatwoods for failure to appear in court on a contempt charge. Moore is awaiting extradition back to Boyd County.
- On Wednesday, December 3, 2025, at 4:19pm, Deputy Josh Travis served a Whitley Circuit Court bench warrant on Milton A. Harris (64) of Corbin for non-payment of court costs, fees, or fines. Harris awaits extradition back to Whitley County.

He was charged with a Lyon District Court bench warrant for contempt of court on a child support case. He was lodged in the Crittenden County Detention Center.
