However, any direct disposition arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the same statement we provide describing the direct disposition goods and services you selected.

TERMS OF PAYMENT

Payment is due in full prior to cremation services being rendered. We accept American Express Visa, Discover, and MasterCard, Cash and Check.

BASIC SERVICES OF DIRECT DISPOSER AND STAFF, AND OVERHEAD: \$400.00

This fee is for our basic services and overhead. It will be added to the total cost of the arrangements you select. (This fee is already included in our charges for direct cremation) This fee includes responding to the initial request for service; conducting the arrangement conference; preparing the biographical and statistical data; preparing and filing papers; permits and authorization; coordination with those providing other services and retaining and caring for remains prior to commencement of post death activities.

DIRECT CREMATION \$670-\$675

Includes the basic services of a direct disposer and staff, the collection of the decedent from a hospital or medical examiner's office, nursing home or funeral home, sheltering the decedent in the refrigeration of up to 10 days including the day the decedent was brought into our care, an alternative cremation container, a cardboard urn, and cremation permit. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard.
