### "ARTICLE III BOARD OF DIRECTORS

Management of this Chamber shall be vested in the Board of Directors, to be a minimum of nine (9) and a maximum of twelve members (12), who shall be nominated by a committee of five Chamber members (non-directors) to submit recommendations to the board of directors to be voted on. Terms shall be January-December and each term is for three (3) years. One-third (1/3) of the directors shall be elected at each annual meeting. The initial terms, after the adoption of these by-laws, shall be adjusted accordingly."(SIC)
