Data Controller

Elite Football Trials Group Limited is the data controller responsible for your personal data.

As the data controller, we determine the purposes and means of processing your personal data.

What data do we collect?

Elite Football Trials Group Limited collects the following data:

- Personal identification information (Name, address, date of birth, email address, phone number)

How do we collect your data?

You directly provide Elite Football Trials Group Limited with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.
- Use our social media accounts

Elite Football Trials Group Limited may also receive your data indirectly from the following sources:

- Klarna Bank
- PayPal
- Stripe Bank
- MoonClerk
- Any other service that enables us to provide you with our services

How will we use your data?

We use your personal data to:

- Provide football consultancy services, including player evaluations and trial coordination
- Communicate with you regarding your application and services
- Manage payments and records
- Improve our services and website functionality
- Send marketing communications where you have consented

We may share your personal data with selected third parties where necessary to provide our services and operate our business.

These include:

- Football clubs, scouts, and technical staff, for the purpose of arranging training-trial placements, evaluations, and football-related opportunities
- Payment service providers (including PayPal, Stripe, Klarna and similar providers) to securely process transactions and prevent fraudulent activity
- Technology and cloud-based service providers (such as secure data storage, email, and communication platforms) who support the operation of our business
- Partner organisations within our business group, including:
 - Elite Club Competitions Limited
 - Elite Betting Consultants Limited
 - Only Elite Football Limited
 - Elite Football Trials (Thailand) Co., Ltd.
- Marketing partners, where you have provided your consent to receive promotional communications. We will only share your data where it is necessary and will ensure that appropriate security measures and safeguards are in place to protect your personal data.

Providing your personal data is necessary for us to deliver our services. If you choose not to provide certain information, we may be unable to process your application or provide our services.

Lawful Basis for Processing

We rely on the following lawful bases for processing your personal data:

- Contract: Where processing is necessary to provide you with our services, including player evaluations, consultancy, and coordination of training-trial placements.
- Consent: Where you have given clear consent for us to process your personal data for specific purposes, such as receiving marketing communications or sharing your information with partner organisations.
- Legitimate Interests: Where it is necessary for our legitimate business interests, such as improving our services, promoting opportunities to relevant football clubs, and maintaining

internal records, provided these interests do not override your rights.

- Legal Obligation: Where we are required to process personal data to comply with applicable laws and regulations. You have the right to withdraw consent at any time where consent is the lawful basis for processing.

How do we store your data?

Elite Football Trials Group Limited stores your personal data securely using trusted cloud-based systems and secure communication platforms and in accordance with our Data Retention section below.

International Data Transfers

Some of the third-party service providers we use (including payment processors and cloud-based systems) may transfer and store your personal data outside of the United Kingdom. Where this occurs, we ensure that appropriate safeguards are in place to protect your personal data, including:

- Use of countries deemed to provide an adequate level of data protection by the UK government; or
- Implementation of standard contractual clauses or equivalent legal mechanisms. By using our services, you acknowledge that your data may be transferred internationally in accordance with this policy.

Data Retention

- We will retain your personal data only for as long as necessary to fulfil the purposes for which it was collected, including providing our services, maintaining ongoing professional relationships, and complying with legal obligations. Due to the nature of our services, we may retain client data for an extended period where it is relevant to:
- Monitoring player development and career progression
- Maintaining ongoing communication regarding opportunities
- Providing future consultancy or placement services
- We will periodically review the data we hold and ensure that it remains relevant and necessary. Data that is no longer required will be securely deleted or anonymised. Where required by law, certain data (such as financial records) will be retained for a minimum period of up to 6 years.

What are your data protection rights?

Elite Football Trials Group Limited would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request Elite Football Trials Group Limited for copies of your personal data. This is a free service.

The right to rectification - You have the right to request that Elite Football Trials Group Limited correct any information you believe is inaccurate. You also have the right to request Elite Football Trials Group Limited to complete information you believe is incomplete.

The right to erasure - You have the right to request that Elite Football Trials Group Limited erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that Elite Football Trials Group Limited restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Elite Football Trials Group Limited's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Elite Football Trials Group Limited transfer the data that we have collected to another organisation, or directly to you, under certain conditions.
