Pursuant to section 7(e)(2) of the Open Meetings Act, the President of the Board of Health has determined that an in-person meeting is not practical or prudent because of the declared disaster. Pursuant to Executive Order 2020-10, as extended by Executive Order 2020-39, and the Attorney General's Public Access Bureau Opinion 2020 PAC 62329, an opportunity for public comment will be provided to all those persons who are physically present and wish to do so, subject to time parameters in the Macon County Board of Health By-Laws (maximum of 3 minutes per speaker; total of 15 minutes).
