REPORTS TO COUNCIL

- A. Council received the Public Works Foreman Convex Mirror Report. Public Works Foreman identified possible vehicle sight restrictions at the intersection of Yonge St and Ontario and at the intersection of Syples and Yonge St. Council discussed the size of the convex mirror and the location before approving the installation of the convex mirrors at all locations stated in the Public Works Foreman Report.
- B. Council received the Public Works Foreman Gazebo Report. Public Works Foreman recommended location A identified in the report.
- C. Council received the Public Works Foreman Winter Sand Tender Report. Council discussed the only tender received, which was over budget. Council advised the Public Works Foreman to re-tender.
- D. Council received the Public Works Foreman Fire Association Shipping Container Report. Council discussed the cost and current bylaw enforced by the Village.
- E. Council received the Arena Manager Report for the Month of August. Arena Manager gave a summary of the operations as it related to the report. Highlights included the scoreboard now installed, summer ice rentals and fall ice rentals have increased. Arena Manager took a moment to thank Public Works staff for the help and explained to Council with the increase rentals staff are increasingly busy and may not sustain the same level of productivity.
