58. PUBLIC BREAK

1. Question from Mr.Scott Bevan

"At the next Community Council meeting will Councillors please detail the consultation undertaken by the Community Council with users and residents before releasing control over the Cae Fardre and Parc Canol children parks to Rhondda Cynon Taf County Borough Council?"

Response made by Community Councillor A.Green, Chair of Leisure & Amenities Committee

"Thank you for your question relating to Cae Fardre and Parc Canol play areas. These are two of the five playgrounds owned by RCTCBC that have been looked after by this Community Council since 2013.

These two playgrounds have been included, by the County Borough Council in their £672k Capital Improvement Programme for 2022/23. The children and users will benefit from substantial investment in new equipment and safety features. The Community Council had been informed that RCT will resume responsibility for these areas. We are satisfied that such a seamless transfer ill not affect users. Residents will be relieved of the direct cost for renewing the equipment in these playgrounds which would otherwise fall to the Community Council precept.

In these circumstances there is no consultation process that is relevant or meaningful, that could affect the outcome. I am aware that the County Borough Council has a number of open consultation streams including its Area Groups and Citizens Advice Panel that all residents can access."

2. Question from Mr.Lyndon Walker

"Would this Council on humanitarian grounds offer Ty Illtud as a location for the use of Ukraine Refugees in the coming months as the Council has recently refurbished the facility and it is next to the school, play facilities and good transport links and at present is not used to its full capacity?"

Response made by Community Councillor A.Green, Chair of Leisure & Amenities Committee

"Thank you for your question relating to services provided for Ukrainian refugees in the local area.

Although the Community Council has no direct responsibility for assisting refugees arriving in Wales. I am pleased to report that our Chair, Councillor David Stone and the Labour Group co-hosted a Welcome Reception Event for Ukrainian families in Llantwit Fardre Sports and Social Club recently. The Event, co-hosted by our Senedd Member, Mick Antoniw and Member of Parliament, Alex Davies-Jones was very successful. It was well attended by refugee families and their sponsors who were also able to meet with Police Commissioner, Alun Michael and a group of Community Police and Support Officers.

The Chair, who provided the buffet, at no expense to the public purse, and Members present were able to discuss with families what assistance they required and everyone was impressed with the resolution and spirit they displayed.

I know that our Senedd Member is developing plans to continue helping with the adjustment to life in South Wales. I also understand that domestic accommodation is completely catered for at the moment.

With regards to Ty Illtud. The Hall is in daily use by local Community groups, and it would not be appropriate or necessary to consider a change of use, at this time which would require planning permission and also the building has no shower facilities.

Between Ty Illtud and the Carnegie Parish Hall there are usually a few vacant slots available for booking.

The Community Council will respond to any requests from the Ukrainian families group for facilities or other assistance as they continue to cope with the traumatic impact the Russian invasion of their country has had on their lives".

66. PROPOSED NEW BUILD – LLANILLTUD FAERDREF SCHOOL – LICENCE FOR ACCESS AND DEED OF EASEMENT FOR FOUL WATER DRAINAGE

With reference to Minutes Nod.85 and 37 of the Council Meetings held on the 27th September, 2021 and 30th May, 2022 respectively, the Clerk informed Members that following the signing of the `Licence for Access`, a request had been received by the Unitary Authority from the Construction Company who had been appointed to undertake the works at the above school to amend the licence.

Attached to the report at Appendix A was a copy of the amended `Licence for Access` and at Appendix B to the report was a copy of the `Deed of Easement` for foul water drainage, which had been drafted in order to secure permission for the Council, its successors in title and those authorised by them to use the foul water drainage once installed and to access the Community Council's land in order to retain, inspect, maintain, repair, alter, renew, replace, fill-in and remove the foul water drainage, provided always that reasonable prior notice will be given to this Council.

Following a discussion where some concerns were raised by Members, it was **RESOLVED** – that the Clerk arranges a meeting with Officers of RCTCBC, representatives of the Construction Company together with the Chair of the Community Council and the Chair of the Leisure and Amenities Committee to discuss the concerns as referred to at the meeting and following a satisfactory outcome, the amended Licence for Access as shown at Appendix A to the report and the Deed of Easement as shown at Appendix B to the report be signed by the Clerk on behalf of the Community Council.

67. PARC NANT CELYN PLAY AREA, EFAIL ISAF

In accordance with Minute No.4(6) of the meeting of the Leisure and Amenities Committee held on the 23rd June, 2022, the Clerk attached to her report the Safeguarding Report following the inspection that was carried out on the 1st July, 2022.

The Clerk also gave her observations on the annual inspection that was carried out at the park on the 8th July, 2022 together with the update from the Unitary Authority in respect of the taking back of the play area in the 2023/24 financial year.

Following a discussion, it was **RESOLVED** -

 to remove the equipment that is deemed to be in a dangerous condition and as recommended by the Accredited RPII Inspector, as a matter of urgency; 2. to refer the matter back to the Leisure and Amenities Committee for further consideration.

68. PLAY AREA AT THE RIDINGS, TONTEG – NOTICE OF ENTRY

In her report, the Clerk reported on the formal Notice of Entry that had been received from Welsh Water in respect of surface water sewer repairs that need to be undertaken at The Ridings, Tonteg resulting in the play area having to be closed as the works will obstruct access to the park.

Following the observations of the Clerk, it was **RESOLVED** -

- 1. to note the Notice of Entry that has been served on the Council by Welsh Water;
- 2. to authorise the Clerk to arrange the transfer of the land at The Ridings into the ownership of this Council and noting that RCTCBC has instructed Welsh Water to deal only with this Council;
- 3. to note that the Clerk had not been given confirmation of the date of commencement of works;
- 4. to note the rate of occupation which is to be paid to the Council by Welsh Water for the use of part of the park area for a compound;
- to agree that the relevant notices be published on the Council's website and Facebook page as well as the park itself, informing the public, when known, the date in which the park is to be closed;
- 6. to agree to the purchase of the concrete barge boards at a cost of £206.50 to assist in the installation of the fence at the adjoining property to the play area.
