



## **Waiver & Release of Liability and Assumption of Risk Agreement**

**Date of Event:** August 22, 2026

**Location:** Hopkins High School, Hopkins, MN (Tennis Courts)

**Sanctioned by:** US Club Soccer

In consideration of being allowed to participate in any way in the Tonka Street Soccer Cup, sanctioned by US Club Soccer and hosted by Tonka United Soccer Association ("Tonka United"), the undersigned Coaches/Manager, Parents (children under the age of 18), and Adults (18 years old or older) agree to the following on behalf of their team, players, coaches, and spectators:

**Assumption of Risk:** undersigned Coaches/Manager, Parents (children under the age of 18), and Adults (18 years old or older) acknowledge and understand that participation in the Tonka Street Soccer Cup involves inherent risks, including but not limited to physical contact, equipment failure, weather conditions, and court hazards, which could result in serious injury, disability, or death. I voluntarily assume all such risks, known and unknown, even if arising from the negligence of the Releases.

**Compliance with Safety Protocols:** undersigned Coaches/Manager, Parents (children under the age of 18), and Adults (18 years old or older) certify that all participants under the team's registration will follow all rules, instructions, and safety guidelines provided by Tonka United, US Club Soccer, referees, and event staff. Participants will remove any individuals under their supervision who exhibit unsafe behavior or fail to comply with tournament rules.

**Release of Liability:** undersigned Coaches/Manager, Parents (children under the age of 18), and Adults (18 years old or older) agree hereby release and hold harmless Tonka United Soccer Association, Hopkins High School, Hopkins Public Schools District, US Club Soccer, their officers, directors, agents, employees, volunteers, sponsors, vendors, and event staff ("Releasees") from any and all liability for injuries, disability, death, or loss or damage to person or property incurred while participating in the event, whether caused by negligence of the Releasees or otherwise.

**Media Release:** undersigned Coaches/Manager, Parents (children under the age of 18), and Adults (18 years old or older) agree that photographs, videos, or other recordings taken during the event may be used by Tonka United Soccer Association for promotional or marketing purposes without compensation.

**Medical Responsibility:** undersigned Coaches/Manager, Parents (children under the age of 18), and Adults (18 years old or older) certify that all players on the team are in good health and physically able to participate. The undersigned acknowledge that Tonka United Soccer Association does not provide medical insurance and that it is the responsibility of each participant to carry personal medical coverage.

**Team Manager Responsibility:** As team manager, I confirm that all participants and their legal guardians (if under 18) are aware of and have agreed to the risks outlined in this waiver. I accept responsibility for conveying all tournament rules, safety protocols, and expectations to my team.
