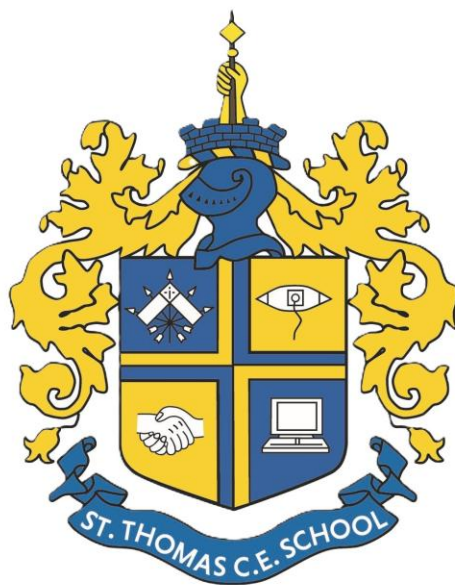

1. Aims

This Accessibility Plan outlines how St Thomas CE Primary School will increase access to the curriculum, improve the physical environment, and enhance the availability of accessible information in compliance with the Equality Act 2010 and SEND Code of Practice

2. Legislation and Guidance

This plan is based on the Equality Act 2010, SEND Code of Practice, and DfE guidance on accessibility planning.

3. Roles and Responsibilities

The Headteacher, Governors, SENDCo, and SBM are responsible for implementing and monitoring this plan.

4. How the School Provides Accessibility

Curriculum Access

Actions:

1. Provide differentiated resources and lesson plans.
2. Implement assistive technology (e.g., speech-to-text software).
3. Deliver annual staff training on inclusive teaching strategies.

Measurable Targets:

- All teaching staff trained by July.
- At least 80% of SEND pupils achieve expected progress by end of academic year.

Physical Environment

Actions:

1. Use of calm areas in every classroom.
2. Sensory equipment and tools available to meet pupils' sensory needs.
3. Classroom layout adjusted where necessary to meet mobility needs.

Measurable Targets:

- Complete audit of physical environment with pupil involvement by February.
- Implement at least 2 major improvements per year.

Access to Information

Actions:

1. Offer parents accessible formats of the newsletter.
2. During induction meetings, offer families who have English as an Additional Language for communication to be translated.
3. Offer a video version of the SEND Information Report for parents.
4. Update school website for screen reader compatibility.

Measurable Targets:

- Accessible formats available within 5 working days of request.
- Website compliance check completed by January 2026.
