Finance Director Amy Perkins asked that at the request of the Auditor, the committee be advised of the \$11,400 in budget 101-51800, Dixie Youth Baseball. That amount was approved in the 2025-26 budget. The formula in excel did not include that field. The 3,993,329 million on the statement of expenditures report was understated. The correct amount is \$4,004,729.
