NOTES ON MOVE-OUT PROCEDURE

If your move out date is mid-month (not on the last day of the month) you will only be responsible to make a payment of the pro-rated amount. The Appfolio system always shows on your tenant ledger that the full month is due. We can't change that but in the case of move-out during the month you will only pay the pro-rated amount and the rest will get balanced by our bookkeeper after move out.

Proration is always calculated as follows:

Monthly rent amount divided by 30 equals the daily rate. It doesn't matter if there are 29 or 31 days in the month, the calculation is always based on 30. Then take the daily rate times the number of days of tenancy in the month.

Example:

If your rent is \$1,000.00 and your last day is on the 12th of the month the calculation would be as follows:

Rent: \$1,000.00 divided by 30 = \$33.33 per day.

Number of days of tenancy in the month: 12 times \$33.33 = pro-rated amount due is: \$399.96

RETURN OF SECURITY DEPOSIT

Security deposits are sent out to the forwarding address you provide on the Intent to Vacate form. They are sent within 21 days of the move-out date.
