All final votes, actions, or decisions will be taken in open session.

RIGHTS OF THE PUBLIC

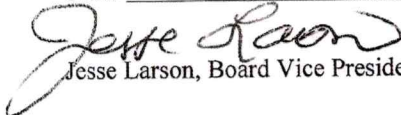
