## Bartow-Pell Mansion Museum



### Thursday, September 18, 2025

We'll begin the day with a docent-led tour of the gracious 19th-century Federal-style Bartow-Pell Mansion, with stunning views of the Long Island Sound. We'll then enjoy conversation and light refreshments—tea, scones and biscuits, and finger sandwiches—in the historic mansion's Orangerie, followed by free exploration of the gardens and grounds.

The Bartow-Pell estate's long history began in 1654, when Thomas Pell, an English physician from Connecticut bought about 50,000 acres from the native Lenape people. In His heir and nephew, Sir John Pell, completed the house after 1670. It served four generations of Pells before it burned down during the American Revolution. In 1836, the property was purchased by a Pell descendant, the publisher Robert Bartow, who built the present gray stone Greek Revival mansion. The house and grounds are now owned by the City of New York and operated by the Bartow-Pell Conservancy.
