Beware of Nevada Orthopedic & Spine Center which includes **Dr. Michael Bradford** and his partners. The office and the individual doctors have low ratings and a lot of negative reviews.

- **Note:** Prior to 2006, Nevada Orthopedic & Spine Center was named Advanced Orthopedic Care Assoc. They changed their business name to Nevada Orthopedic & Spine Center on December 27, 2006.

On Yelp, Nevada Orthopedic has 2.4 stars, but keep in mind that **42% of positive reviews are fake**, so the rating is likely much lower. A few of the negative comments are displayed at the bottom of this page. Go to Yelp to learn more about the bad experiences at Nevada Orthopedic.

Remember that businesses (including doctors) will often delete their Yelp page when they get too many negative reviews. See below for the statistics relating to the doctors at Nevada Orthopedic, including Dr. Michael Bradford who shows only 3 reviews on Yelp even though he has been a doctor for 39 years. It is very telling that the doctors at Nevada Orthopedic have no reviews or only a small

number of reviews on Yelp (even though most of them have been practicing medicine for many years).

Shortly after the bad surgery on June 17, 2025, Dr. Bradford lost his position as Chief of Surgery at Sunrise Hospital.

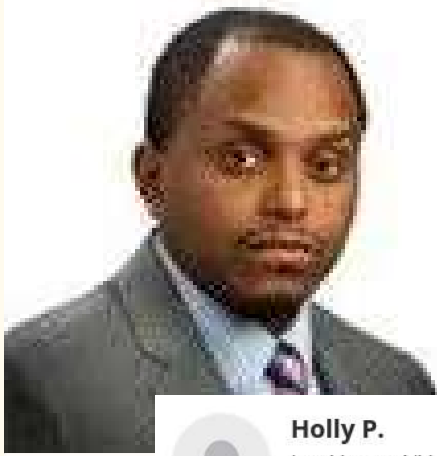

My phone and everyone's phone in the waiting room did not work and then when you get back to the rooms, service was nonexistent. I cannot contact my husband or mother who had my kids the entire time. I was not expecting to be there until 6 PM and me and my son were both starving since we did not have food since around noon/lunchtime. The x-ray tech guy was nice and quick though. But outside of that, it was not a good experience as far as wait time went. Also, my son's bone still crooked after they put the cast on and took an x-ray... They said it would be fine, but I don't really trust too many healthcare workers in Nevada. And after the experience beforehand, who the heck knows. I will write a follow up review after our next check-in appointment.
