People were shouting "call the news!!" in horror.

He was finally told that if he didn't get off the ground where he had collapsed due to blood loss, they would kick him out.

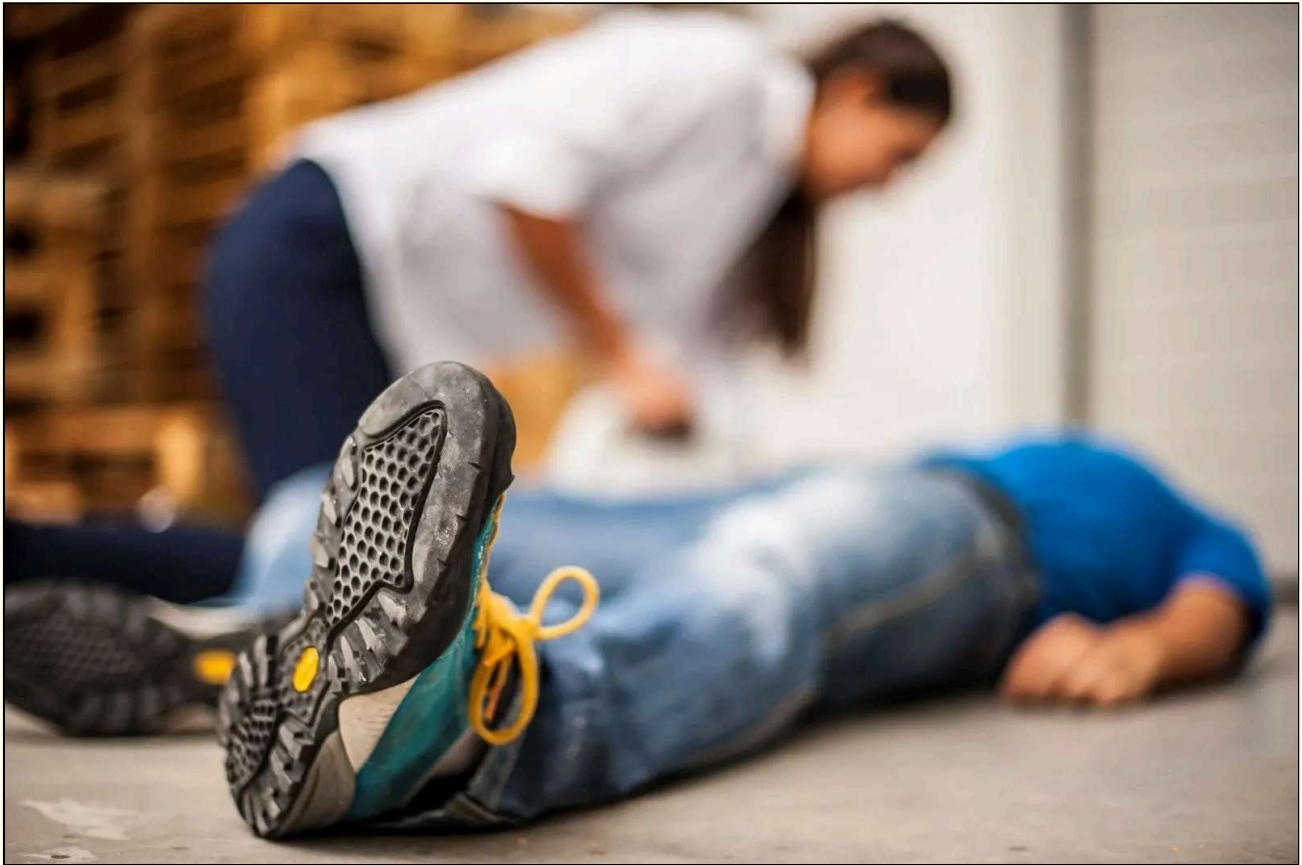
Realizing their incompetence was going to kill him, I fled the hospital -- pushing him in a wheelchair with an IV still in his arm, literally within his final moments of life, and desperately called friends to come help.

An unemotional retelling of this story would go like this:

Shame on you, Sunrise Hospital!!

Be cautious, fellow Las Vegans. Drive out of your way to go to Summerlin Hospital (or another hospital) because these bad people could cost you your life.
