Then I was humiliated and in tears asking when I would be going in for surgery.

They didn't know. There were no answers. No assistance and no help for patients!!

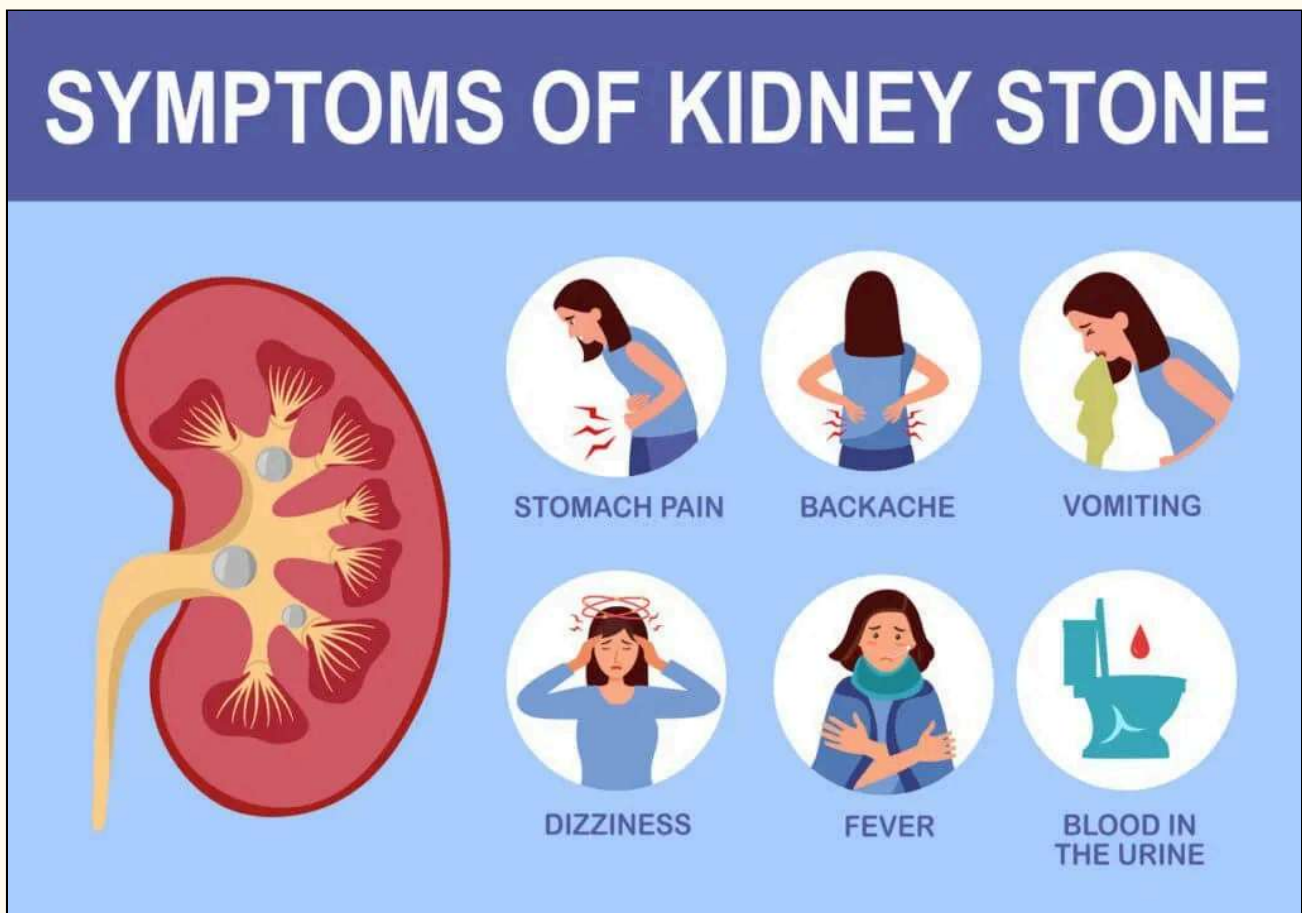
Just a lot of rude and unhinged staff!!
