There's much more. I wish I could record the whole conversation on my phone.

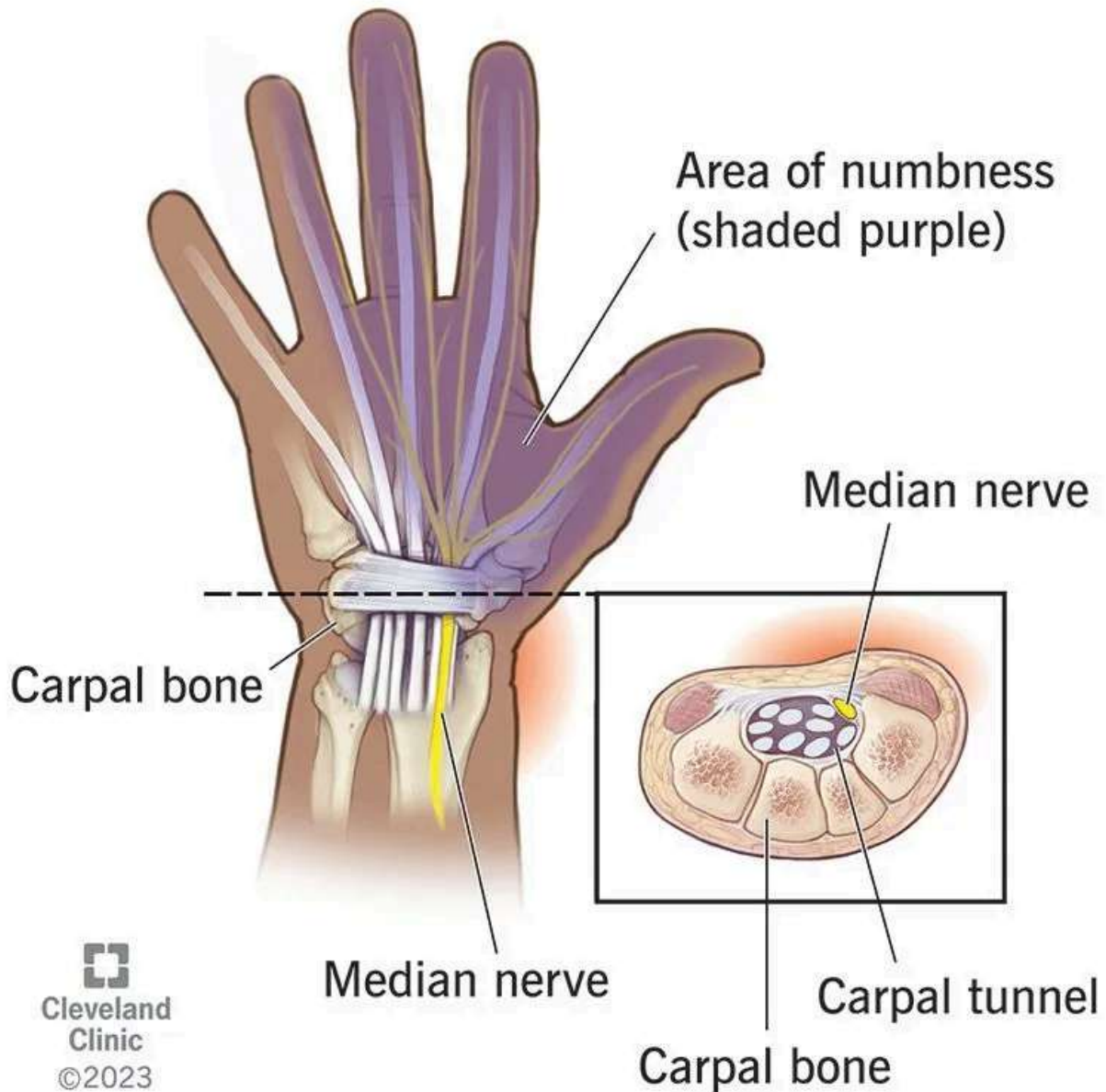
I have NEVER in my life had such a RUDE, UNFRIENDLY & GRUMPY doctor!!!!!!
