This man needs to be removed from seeing clients. I cannot believe he is still employed.

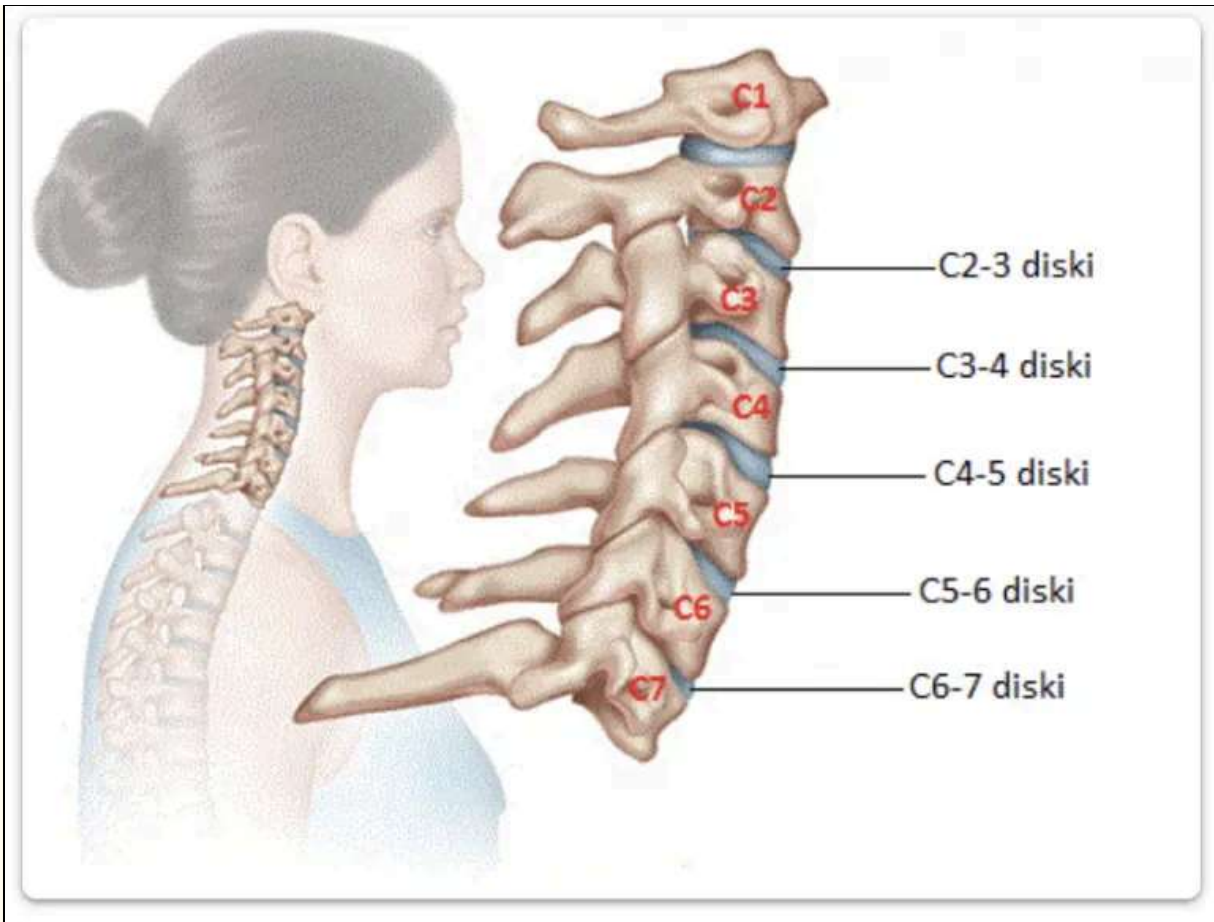
I would not let him cut on me if he was the last surgeon on earth – that is how bad he is.
