Most of the staff were rude except for a couple nurses.

If you rang for the nurse, expect to wait an hour.

The PT (Physical Therapy) staff did very little to help.

My mother barely ate in the hospital, but she gained 40 pounds of water weight!!

She was never put on Lasix or anything to reduce the fluid retention.

She was NOT on oxygen before the hospital.

She also did not get a bath or have her hair combed for nearly 30 days.

Thank God she left the hospital yesterday -- unfortunately on oxygen with a large decubitus ulcer on her spine from lack of movement.

I'm just glad they finally released her before she died there!

This hospital is a very dark place. Stay far, far away!
