



**George County School District**  
**Parent and Family Engagement Policy/**  
**2025-2026**

In support of strengthening student academic achievement, **George County School District**, **receives** Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by Section 1116(a)(2) of the Every Student Succeeds Act (ESSA). The policy establishes the LEA's expectations and objectives for meaningful parent and family engagement and describes how the LEA will implement a number of specific parent and family engagement activities, and it is incorporated into the LEA's plan submitted to the Georgia Department of Education.

**The George County School District** agrees to implement the following requirements as outlined by Section 1116:

These programs, activities, and procedures will be planned and operated with meaningful consultation with parents and family members of participating children.
- Consistent with Section 1116, the school district will work with its schools to ensure that the required school-level parent and family engagement policies meet the requirements of Section 1116(b) of the ESSA, and each include as a component a school-parent compact consistent with Section 1116(d) of the ESEA.
- In carrying out the Title I, Part A parent and family engagement requirements to the extent practicable, the school district and its schools will provide full opportunities for the participation of parents with limited English proficiency, limited literacy, disabilities, of migratory children, who are economically disadvantaged, or are of any racial or ethnic minority background, including providing information and school reports required under Section 1111 of the ESSA in an understandable and uniform format including alternative formats upon request and, to the extent practicable, in a language parents understand.
- If the LEA plan for Title I, Part A, developed under Section 1112 of the ESEA, is not satisfactory to the parents of participating children, the school district will submit any parent

comments with the plan when the school district submits the plan to the state Department of Education.

- The school district will be governed by the following definition of parental involvement and expects that its Title I schools will carry out programs, activities, and procedures in accordance with this definition in Section 8101 of the ESSA:

Parental involvement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring:

- (A) Parents play an integral role in assisting their child's learning
- (B) Parents are encouraged to be actively involved in their child's education at school
- (C) Parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child
- (D) Other activities are carried out, such as those described in Section 1116 of the ESEA

### **THE DISTRICT WILL IMPLEMENT REQUIRED LEA PARENT AND FAMILY ENGAGEMENT POLICY COMPONENTS**

#### **JOINTLY DEVELOPED**

The **George County School District** will take the following actions to involve parents and family members in jointly developing its LEA plan under Section 1112, and the development of support and improvement plans under paragraphs (1) and (2) of Section 1111(d) of the ESEA:

- The school district will invite parents to participate in the annual parental involvement policy meeting.
- The school district will invite parents to participate in the annual Title I planning meeting hosted in the spring of each year to solicit feedback on the policy for possible revisions.
- The parental involvement policy will be posted on the school district's website and placed in the Parent Center for parental access.
- Parent are encouraged to participate in the Comprehensive Needs Assessment each spring.
- State accountability ratings and federal accountability ratings will be made available to parents.
- Parent Center will be open and available to parents weekly.

#### **TECHNICAL ASSISTANCE**

The **George County School District** will provide the following coordination, technical assistance, and other support necessary to assist and build capacity of all Title I, Part A schools in planning and implementing effective parent and family involvement activities to improve student academic achievement and school performance, which may include meaningful consultation with employers, business leaders, and philanthropic organizations, or individuals with expertise in effectively engaging parents and family members in education:



- Parents are invited to attend Annual Open House and Annual Title I Meeting.
- Monthly Administration Meetings
- Each Title I School will have access to translation resources for parents of EL students.
- All purchases utilizing funds earmarked for parent engagement will be approved by the Director of Federal Programs.
- The district's Elementary Curriculum Director and Secondary Curriculum Director will collaborate with Title I schools for the development of parent resources.

## ANNUAL EVALUATION

The **George County School District** will take the following actions to conduct, with the meaningful involvement of parents and family members, an annual evaluation of the content and effectiveness of this parent and family engagement policy in improving the academic quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). The evaluation will also include identifying the needs of parents and family members to assist with the learning of their children, including engaging with school personnel and teachers and strategies to support successful school and family interactions. The school district will use the findings of the evaluation about its parent and family engagement policy to design evidence-based strategies for more effective parental involvement, and to revise, if necessary, its parent and family engagement policies.

- Parent, family and community surveys will be released each spring. Parents, family, and community will have opportunity to provide input on school functions and evaluate the implementation of programs.
- The superintendent, federal programs director, Title I school contacts, administrators and teachers, along with parents, family members and community members will be responsible for conducting the evaluation of policy and programs on an annual basis as part of the Title I planning process.
- Parents, family members, and community members will provide feedback on the content and effectiveness of the parental and family engagement policy and school plans through participation in surveys, Open House, Annual Title I Meeting, PTO, council meetings, and website suggestion box. The school administration and federal programs director will be responsible for these activities.

## RESERVATION OF FUNDS

The **George County School District** will involve the parents and family members of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parent and family engagement is spent and will ensure that not less than 90 percent of the 1 percent reserved goes directly to Title I schools.

George County School District will provide parents and family members opportunity for input in how to spend the 1% parent involvement funds through the annual spring survey

and during the annual Title I parent meeting, as well as meetings throughout the school year.

## **COORDINATION OF SERVICES**

The **George County School District** will coordinate and integrate parent and family engagement strategies with parent and family engagement strategies, to the extent feasible and appropriate, with other relevant Federal, State, and local laws and programs: such as Head Start that encourage and support parents in more fully participating in the education of their children by:

- Staff from the Title I schools will serve on the HeadStart Advisory Board.
- Title I school staff will collaborate annually with HeadStart for the development and implementation of the transition program.

## **BUILDING CAPACITY OF PARENTS**

The **George County School District**, with the assistance of its Title I schools, build parents' capacity for strong parental involvement by providing materials and training on such topics as literacy training and using technology (including education about the harms of copyright piracy) to help parents work with their children to improve their children's academic achievement. Assistance will also be provided to parents in understanding the following topics:

- The challenging State academic standards
- The State and local academic assessments including alternate assessments
- The requirements of Title I, Part A
- How to monitor their child's progress in school?
- How to work with educators?

The district will support schools in parental involvement activities. Assistance will be provided in areas such as the following:

1. *Provide resource materials and trainings at the Parenting Center and local schools.*
2. *Provide weekly and/or monthly newsletters with academic/behavioral suggestions.*
3. *Provide resource information on the school website.*
4. *Parent workshops will be provided at the district level.*
5. *Title I school principal meets to review and collaborate on parental involvement plans.*
6. *The district will advertise upcoming events through social media, radio and district website.*


communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and schools by:


- Professional development opportunities at the beginning of the school and assigned throughout the year;
