Tile, countertops, tub, and shower surround must be washed and shined. All buildup of soap scum must be removed. Medicine cabinets must be cleaned (shelves, mirror, and tracks on cabinet). Tub, basin, shower, and toilet must be cleaned. Tub, shower, and all chrome in bathroom must be shining with no water spots or film. Clear all tub drains, etc. GARBAGE All garbage must be removed prior to vacating. If any furniture, garbage, or recyclables are left in unit after vacating, you will be charged for having this dumped.

KEYS

___All keys including key fobs, mailbox, building, unit, dumpster, etc. should be returned to our office in the Herald Building by **3pm on the last day of your lease.** If keys are not returned by this time, you may be charged for a lock change.

CLEANING AND REPAIR CHARGES

If you do not leave your unit in satisfactory condition, charges will be deducted from your security deposit, or owed to us if your security deposit is insufficient to cover the charges. Maintenance and janitorial labor changes will be incurred per the terms of your lease. Replacement of materials or parts will be changed at cost for replacements.
