

# **Business Development Grant Application**

### **GENERAL INFORMATION**

Up to a total of \$2500 in matching grant money may be awarded to one or more selected businesses registered within the city of Palmyra. Funds may be used for any business expense at the discretion of the Grant Committee that will review all applications. The grant program is directed at for-profit businesses. All applicants must demonstrate the ability to obtain additional financing from customary lenders.

Grant money will be given to the recipient in the form of reimbursement and will be disbursed only after adequate documentation including, but not limited to, receipts are submitted. Recipients will be or agree to become a member of the Palmyra Chamber of Commerce.

### \*\*\* Grant recipients must access the Chamber Business Grant within one year of award. \*\*\*

#### **RULES AND GUIDELINES**

The Grant Committee may disqualify any application they believe violates the letter or spirit of the Business Development Grant Program guidelines in its sole discretion.

Conflict of Interest Policy: The Committee agrees not to initiate a professional relationship with Applicants who have an active application in the Business Development Grant Program. An application is considered active until the Committee has made a decision about it or until it has been withdrawn by the Applicant. A Committee member will refrain from discussion about and voting on an Applicant to the Business Development Grant Program if a Committee Member has an existing personal or business relationship with the Applicant.

The selection committee will base the Business Development Grant Program on

- Concept & Innovation
- Viability
- Financials
- Sustainability
- Economic Impact.

The Committee may ask the Applicant to come in and talk about the project with them and/or the Palmyra Chamber of Commerce Board of Directors. A one-hour consultation with SBDC will be required for startups.
