#### Regular Meetings

Regular meetings of Council and  
Committee of the Whole shall be held at  
5:00 pm on alternating Wednesdays.

#### Notice of Meetings

Public Notice of all meetings shall be given  
by notification of future meetings in  
previous agendas, and posting the agenda  
on the Township website at least 48 hours  
in advance of the meeting.

#### Delegations (Items not on the Agenda)

The Clerk shall receive every request to be a  
delegation by Thursday of the week  
preceding the meeting and shall include the  
complete name, address, telephone number,  
and/or email address, of the person  
requesting the opportunity to be a  
delegation, as well as the reasons for the  
delegation, and, if applicable, the name,  
address and telephone number of any  
person, corporation or organization  
represented.

A maximum of TEN minutes shall be allotted  
for each delegation to present their position.

#### Special Meetings

The Mayor may at any time summon a special  
meeting of Council or Committee of the  
Whole.

#### Delegations (Items on the Agenda)

Any person who wishes to appear before  
Council regarding an item on the current  
agenda shall make a written application to the  
Clerk, by 3:00 pm, the day of the meeting, to  
be placed on the agenda to appear before  
Council at the meeting at which it will be  
dealing with the item of interest to the  
delegation.

A maximum of FIVE minutes shall be allotted  
for each delegation to present their position  
of support or opposition to the relevant item  
on the agenda.

#### Correspondence & Petitions

Every written correspondence or petition  
addressed to Council shall be delivered to  
the Clerk no later than Thursday of the  
week preceding the meeting.
