- I. Call to Order at 2:47 p.m. by Commissioner Mark Evert
Roll Call: Present: Commissioner Evert, Commissioner Cameron, Commissioner Finley, Commissioner Surginer, and Commissioner O'Brien. Also present was Fire Chief Donnie Norman.
 - II. Open Public hearing at 2:48 p.m. This is the Travis County Emergency Services District 1 public hearing regarding the tax rate for FY 24-25. Our current tax rate is \$.10/\$100 valuation, and our proposed tax rate will remain at \$.10/\$100 valuation. This is the Travis County Emergency Services District 7 public hearing regarding the tax rate for FY24-25. Our current tax rate is \$0.09100/\$100 valuation, and our proposed tax rate is \$0.099967/\$100 valuation. No citizens were present or commented. Closed Public hearing at 3:03 p.m.
 - III. ESD1: Motion by Commissioner O'Brien to adopt the FY 25-26 Budget for ESD1, seconded by Commissioner Surginer. All voted aye, and the motion passed.
ESD7: Motion by Commissioner O'Brien to adopt the FY 25-26 Budget for ESD7, seconded by Commissioner Surginer. All voted aye, and the motion passed.
 - IV. ESD1: Motion by Commissioner Surginer to adopt the Ad Valorem Tax Rate for Maintenance and Operations at \$0.076300/\$100 valuation, seconded by Commissioner O'Brien. All voted aye, and the motion passed.
ESD7: Motion by Commissioner Evert to adopt the Ad Valorem Tax Rate for Maintenance and Operations at \$0.075222/\$100 valuation, seconded by Commissioner Surginer. All voted aye, and the motion passed.
 - V. ESD1: Motion by Commissioner Surginer to adopt the Ad Valorem Tax Rate for Debt Service at \$0.023700/\$100 valuation, seconded by Commissioner O'Brien. All voted aye, and the motion passed.
ESD7: Motion by Commissioner Evert to adopt the Ad Valorem Tax Rate for Debt Service at \$0.024745/\$100 valuation, seconded by Commissioner Surginer. All voted aye, and the motion passed.
 - VI. ESD1: Motion by Commissioner Surginer that the Tax Rate be increased by adopting a Tax Rate of \$0.10000/\$100, which is effectively a -0.26% increase in the tax rate, seconded by Commissioner O'Brien. All voted aye, and the motion passed.
ESD7: Motion by Commissioner Evert that the Tax Rate be increased by the adoption of a tax rate of \$0.099967/\$100, which is effectively an 3.5% increase in the Tax Rate, seconded by Commissioner Surginer. All voted aye, and the motion passed.
