Section 4: Site Safety Checklist

Please confirm the following conditions will be met:

- ☐ Burn pile is 50 ft from on-site structures (**unless otherwise approved**)
- ☐ Burn site is 300 ft or greater from off-site residences, businesses, livestock, sensitive vegetation, or waterlines (**unless written permission is obtained**)
- ☐ Burn site is downwind of roadways or 300 ft or greater away
- ☐ No overhead hazards (e.g., **power lines, tree canopies**)
- ☐ Burn pile is less than or equal to 6 ft x 6 ft and manageable
- ☐ Only natural vegetation from this property will be burned with **no prohibited materials (trash, treated wood, plastics, furniture, etc.)**
- ☐ Wind speed cannot exceed 15 mph
- ☐ A responsible adult will be present at all times
- ☐ Extinguishing tools (**water hose, extinguisher, shovel, etc.**) will be on-site at all times
- ☐ Operational phone available to call 911 if needed
- ☐ Burn ban status will be confirmed prior to ignition
- ☐ Travis County ESD #1 will be notified on the day of the burn

Section 5: Indemnification & Compliance Acknowledgment

- ☐ I have read and understood all rules and regulations governing outdoor burning within Travis County ESD #1.
- ☐ I agree to comply fully with all safety requirements, fire code provisions, and applicable laws.
