## **Class Schedule**

Participants will complete the instructor monitored online component over a period of thirteen weeks according to a lesson plan with chapter interactions, readings and other activities due weekly. The in-person/face to face skills camp is at Travis County Emergency Services District 1 training field in Lago Vista, Texas and runs Monday through Sunday for ten hours each day for fourteen days. A class schedule will be provided at the start of the academy.

## **Payment**

Payment of the application fee is due at the time of submitting the application document of the course. The full tuition is due at the time of acceptance into the program.

## **Methods of Payment**

Travis County Emergency Services District 1 accepts tuition payment by credit card or debit card.

## **Cancellation and Refund Policy**

Participants that cancel prior to the start of course will be refunded the course tuition fee; the application fee will not be refunded. If Travis County Emergency Services District 1 cancels the course, TCESD1 will refund all the participant money including the \$100.00 application fee.

No refund will be granted for expulsion for non-compliance of Rules and/or Regulations or after the first week of class.
