#### 2024 SCHOLARSHIP

The Three Valley Conservation Trust is a non-profit organization that partners with people and communities to conserve the natural environment and cultural heritage of its service area for the benefit of future generations. The purpose of this scholarship is to provide support for applicants pursuing careers that relate to the mission of the Trust. For example, work in agriculture, conservation, ecology, water management and sustainability represent some but not all of the related careers.

#### AMOUNT:

A \$1,000 scholarship awarded to two successful applicants. This is a one-time award per applicant.

#### APPLICATION:

Submit application directly to the Trust (Three Valley Conservation Trust, P.O. Box 234, Oxford, OH 45056) and are to be received no later than 3/15/2024.

Applications must include:

- 1) Completed application form
- 2) One page essay as described in form
- 3) Two letters of recommendation (mailed directly to the Trust) which speak to the applicant's qualifications and how they relate to the mission of the Trust.

#### **SELECTION:**

Applications will be reviewed by a committee appointed by the Chair, Board of Trustees, Three Valley Conservation Trust and will include at least one board member. The committee bases selection on the applicants' responses and letters of recommendation. Financial need or prior scholastic achievement are not the primary selection criteria.

It is at the committee's discretion to

- 1) Interview the final candidates
- 2) Decide not to award a scholarship, should there not be strong candidates
- Give preference to any applicants who have personally been involved with the work of the Trust and/or applicants whose families have been involved in the Trust (through easements and/or volunteer activities such as monitoring, etc.)
