## WHS Safety Management System

1.     - ii. having a copy in all vehicles
    - iii. regularly reviewing its contents through toolbox meetings and other forms of workplace consultation
    - iv. ensuring that workers follow the systems and procedures contained within this safety management system.

### Compliance

3. All supervisors and workers of the PK Plumbing and Gasfitting Group are to comply with the policies and procedures contained in this Safety Management System. Variation
4. Should a policy or procedure of the PK Plumbing and Gasfitting Group seem incomplete, inaccurate, or wrong the policy or procedure may be varied in the following ways:
  - a) Workers are to stop working on the procedure until rectified.
  - b) Workers are to be consulted on the problem.
  - c) Changes should be made to the policy and procedure documents. This should incorporate the details of the consultation with workers and supervisors. The documents are then to be delivered as drafts to the Health & Safety Committee, Health & Safety representative, or the nominated Safety representative.
  - d) Those changes are ratified by the Health & Safety Committee, Health & Safety Representative, or the nominated Safety representative.
  - e) The updated procedure is distributed to all workers.
  - f) All Safety Management Systems are updated with the new procedure
