YOUR DAY-BY-DAY ITINERARY

August 1: Little Rock/Seoul

Depart from USA on an overnight international flight to South Korea as the pilgrimage to World Youth Day begins. Flights are available to purchase 300 days before travel.

August 2: Arrival in Seoul

Arrive in Seoul and transfer to your hotel. Time permitting, enjoy a walking pilgrimage featuring Myeongdong Cathedral, Bukchon Hanok Village, and Insadong Street. Visit Gyeongbok Palace and significant Korean Martyrs' sites, including Seosomun Martyrs' Shrine and Yakhyeon Catholic Church. If time allows, browse Namdaemun Market or Myeongdong Street before dinner and your overnight stay in Seoul. (D)

August 3: World Youth Day—Opening Ceremonies

Experience the inspiring Opening Ceremonies of World Youth Day, joining pilgrims from around the globe for a joyful celebration of faith through prayer, music, and fellowship. Spend the afternoon participating in official World Youth Day events before returning to your hotel for the evening. (B)

August 4: World Youth Day / Mirinai Shrine

Begin the day participating in World Youth Day events before traveling to the sacred Mirinae Shrine, one of Korea's most important Catholic pilgrimage sites. Visit the St. Andrew Kim Dae-geon Memorial Church, Eucharistic Adoration Chapel, Way of the Rosary, Stations of the Cross, and other inspiring sites honoring Korea's early martyrs. Return to Seoul to continue celebrating World Youth Day before your overnight stay. (B)

August 5: World Youth Day—Arrival of the Holy Father!

Spend the day participating in World Youth Day activities alongside pilgrims from around the world. In the evening, attend the inspiring Welcome Ceremony with the Holy Father, a historic celebration of faith, unity, and fellowship. Overnight in Seoul. (B)

August 6: World Youth Day

Take part in a full day of World Youth Day celebrations, including the vibrant Youth Festival featuring music and cultural performances. In the evening, join pilgrims from around the world for the moving Via Crucis (Way of the Cross). Overnight in Seoul. (B)

August 7: World Youth Day—Prayer Vigil

Participate in World Youth Day events, including the inspiring Pilgrimage Walk. As evening falls, join the Prayer Vigil with the Holy Father, a powerful time of prayer, reflection, and unity with pilgrims from around the world. Overnight in Seoul. (B)

Celebrate the Mass of Sending with the Holy Father, joining bishops, priests, and pilgrims from around the world as the faithful are commissioned to carry the Gospel home. Enjoy additional World Youth Day events before dinner and your final overnight in Seoul. (B/D)

TERMS AND CONDITIONS

Tour prices: All prices in this brochure are based on land rates and exchange rates in effect at the time of printing and on group rates of 30 passengers or more. Tours may depart with less than the required number of passengers, at the discretion of Sue Smith Vacations (doing business and referred to herein as "SSV"), but an additional charge may apply. Passengers will be advised about such surcharges 60 days before departure. All prices are subject to change without notice prior to departure due to major currency fluctuations, changes in fuel prices and/or unforeseen economic circumstances.

Reservations, Deposits and Final Payments: Please complete the Participant Agreement, with full names as they appear on passports, and mail it to us with the required per person deposit plus the cost of insurance. Receipt of your deposit shall act as your agreement to these terms and conditions. Balance is due 90 days before departure date. If final payment is received less than 90 days, a late fee will be assessed in the amount of \$100.00. If final payment is made by credit card (American Express, Visa, MasterCard, and Discover) SSV requires a completed credit card authorization form with a 3.5% processing fee on all credit card payments. All payments made by check should be made payable to Sue Smith Vacations.

Late Reservations: If a booking is made within 60 days of departure, full payment plus applicable taxes and insurance are due at the time of booking. There will be a \$50.00 late processing fee applicable plus cost of any express or overnight mail services. No personal checks will be accepted with reservations received 30 days or less before departure date. Money order, bank check, certified check or credit cards (American Express, Visa, MasterCard and Discover) will be accepted.

Travel Documents: A valid passport (valid for six months after the return date of the trip) is required to travel. Visa is required for US passport holders traveling to some destinations; please contact our office for details. All non-US citizens must contact the appropriate consular office for entry visa requirements pertaining to their trip. In addition, non-US citizens are responsible for complying with requirements for re-entry into the USA. *SSV assumes no responsibility for procurement of passport or visas.* Obtaining and carrying these documents is the sole responsibility of passengers. SSV will not be responsible for any delays, damages and/or losses, including missed portions of your trip due to improper travel documentation.

Final Documents and Tickets: All documents and tickets are only issued upon receipt of final payment and are sent within 3 weeks of departure. Documents and tickets are not guaranteed if final payment and booking form are not received on time.

Air from Home City: All brochure departures are based on Little Rock area airport. SSV can help arrange air transportation from your home city airport. SSV is not responsible for any penalties incurred on domestic tickets not purchased from us, in case of changes in the schedule of the tour. If you are making your own domestic airline tickets, please make sure that your domestic flight time arrives at least 4 hours prior to your international departure time.

Air Changes, Cancellations & Refunds: Airline tickets issued by SSV are highly restrictive and in most instances cannot be reissued, revalidated or exchanged. If a change is possible, a \$75 per person administrative fee, plus any applicable airline change fees, will be assessed once air tickets have been issued. Airline penalties vary depending on carrier.

Airline Seat Assignments and Special Services: There is no advance seat selection. Early check-in is necessary to secure seats with travel companions. Seating is solely under control of the airlines. Some fares used may be eligible for frequent flyer mileage.

Baggage: The company is not responsible for any additional charges collected by the carriers at the airport for luggage fees. We recommend that you take along one suitcase per person with a maximum weight of 50lbs., plus one carry on with maximum dimensions of 9"x14"x22". Airlines also have their own baggage restrictions; please check with the air carrier prior to your departure. All baggage is the passenger's responsibility throughout the tour. SSV is not responsible for loss, theft or damage to your baggage. If a bag is lost or damaged In-flight, the passenger is responsible for notifying the airline directly.

Airline Clause: The airlines concerned will not be held responsible for any act, omission, or event during the time passengers are not aboard their aircraft. The passenger tickets in use by the airline, when issued, shall constitute the sole contract between airline and the purchaser of these tickets and/or passenger. These tours may be sold in connection with the services of any ARC or IATA Airline.

Rooms: Prices shown in the brochure are per person, based on two persons sharing a hotel room. A limited number of single rooms are available at the supplement shown per tour. In some cases, when requested, we may be able to find an appropriate roommate for passengers who have booked as a single person. *If a roommate is not available, you must pay the single room supplement.* While single rooms provide privacy, they are often smaller than twin bedrooms. Triple rooms are available in many hotels for family or friends traveling together. There are no discounts for triple rooms.

Medical Conditions: While we endeavor to provide the highest level of service to all our passengers, we cannot guarantee special facilities or assistance for disabled passengers and it is your responsibility to arrange for such assistance as required. We regret that we cannot provide individual assistance. SSV is not responsible for any medical conditions that may occur prior, during, or after the tour.

Land Only Bookings & Tour Deviations: All SSV packages will include airfare from LIT/XNA and will be added approximately to invoices approximately 300 days before departure. Any deviations from the tour, requested by the client, will be assessed a charge of \$100.00 per person, plus any additional costs the change may incur.

Responsibility: The tour member understands that he or she has no claim against SSV, and its affiliates, for any delay or damage to or loss of property or baggage or injury to or death of persons due to any neglect or willful act of a direct air carrier, hotel, bus company, steamship or cruise company, railroad, transportation company or service company of any kind, or any other person or persons rendering any of the services being offered in connections with these tours. Further, SSV advises that it has no ownership interest whatsoever in any hotel, restaurant, bus company or transportation or service company of any kind outside by SSV, dba Smith Travel Services, Inc, LLC, and its overseas representatives reserve the right without notice to change, amend or cancel any part or all of the tour and the USA, nor does it have any employee outside of the USA. You may see the name SSV affixed to motor vehicles, on signs around the hotel or elsewhere. This use of our name is purely for reasons of identification and does not denote ownership, supervision, or control to make such changes as may be necessary. SSV acts only as an agent in securing hotels, transportation and other travel services from suppliers, and in no event shall SSV in the event of any failure by any person or company to render any transportation, lodging or other travel services to be provided on the tour. The acceptance of the initial service to be provided under the tour shall be considered an acceptance by the tour member of these conditions. If there is a difference between the conditions of SSV and those published by suppliers, the conditions of suppliers shall apply. SSV reserves the right to substitute hotel, cruise ships and air carriers of similar quality, and reserves the right to vary the sequence of sightseeing and/or to re-route the order of cities. In calculating the cost of the trip, SSV has relied on your consent to these terms and in the absence of this release, the cost of the trip would be higher. A contract is made when your reservation and payment are accepted by SSV and any dispute shall be governed by Arkansas law. We reserve the right to decline a person, or remove a person from a tour, if such person presents a significant risk to the health or safety of himself or the group and the person cannot otherwise be reasonably accommodated.

Cancellation Policy and Refunds: We hope that nothing will prevent you from taking your SSV pilgrimage. However, should you need to cancel, your cancellation must be received in writing, via email, or by letter. It will be effective on the date of receipt. If you cancel your tour after you have received your documents and airline tickets, you must return them to SSV before we can process your refund. The following cancellations fees are only for fixed departure date tours published in our brochure. Fees for custom groups and tours may be different, please contact us for details. You are responsible for the cost of any non-refundable airline tickets that have been issued on your behalf plus the following cancellation charges per person:

IMPORTANT: We must receive your premium payment within 10 days of the date we receive your initial deposit for your trip for the Pre-Existing Conditions clause to be waived (provided you are not disabled from travel at the time you pay your premium).

If we cancel: We reserve the right to cancel a specific departure date or whole tour due to lack of participation or for reasons beyond our control such as natural disasters, acts of God or government restrictions. If such an unlikely event should occur, we will offer an alternate departure date or tour program. Should you decline an alternate date or should we cancel the tour outright, the limit of our liability to you will be the refund of all monies received, including any cancellation penalties, except for expenses the company incurs such as airline deposits, cancellation fees, hotels or other services. We will not be liable, however, for costs incurred by you not paid to us, such as visas and passport costs, items of a personal nature, domestic transportation either by ground or air etc. nor will we be liable for any psychological damages, traumas, stress, disappointment, personal and financial loss resulting from our change of departure date or cancellation of a tour. Refunds are not provided for services included, but not used on a trip.

Not Included in the Published Price: Items of personal nature, excess luggage allowance, laundry, room service, travel insurance, passport and visas costs, shore excursions, expenses for additional sightseeing not specified in the itinerary, any incurred medical costs and replacement of items forgotten or stolen while on the tour, and gratuities (a list of suggested tips will be provided with final documents).
