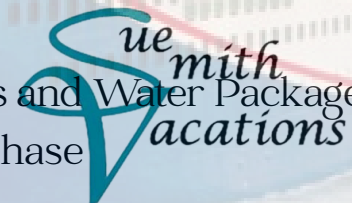

## Cruise Fest 2027 Terms & Conditions

**Tour Prices:** All prices in this brochure are based on land rates and exchange rates in effect at the time of printing and on group rates of 50 passengers. Tours may depart with less than the required number of passengers, at the discretion of Sue Smith Vacations an additional charge may apply. Passengers will be advised about such surcharges 60 days before departure. All prices are subject to change without notice prior to departure due to major currency fluctuations and/or unforeseen economic circumstances.

**Reservations, Deposits and Final Payments:** Please complete the Participant Agreement, with full names as they appear on passports, and mail it to us with the required per-person deposit. Deposit of \$750 per person is required to hold your spot on the tour. Deposits are non-refundable. If cancellation occurs for a covered reason, we will assist you in filing a claim with your travel insurance. A Payment schedule of \$500 per person is due on the 1st of the month in July and August. The final balance is due by October 1, 2026. If final payment is received after due date a late fee will be assessed in the amount of \$50 per late payment. All payments made by check should be made payable to Sue Smith Vacations (referred to herein as SSV). You may call the office with credit card payments or keep a card on file for monthly payment plans. Credit cards will have a 3% convenience fee added by the bank.

**Late Reservations:** If a booking is made after final payment, full payment is due at the time of booking. **Travel Documents:** A valid passport (valid for six months after the return date of the trip) is required to travel. Visa is required for U.S. passport holders traveling to some destinations; please contact our office for details. All non-U.S. citizens must contact the appropriate consular office for entry visa requirements pertaining to their trip. In addition non-U.S. citizens are responsible for complying with requirements for re-entry into the U.S. SSV and its partner vendors assume no responsibility for procurement of passport or visas. Obtaining and carrying these documents is the sole responsibility of passengers. SSV and its partner vendors will not be responsible for any delays, damages and/or losses, including missed portions of your trip due to improper travel documentation. **Final Documents:** All documents and tickets are only issued upon receipt of final payment and are sent within three weeks of departure. Documents are not guaranteed if final payment and booking form are not received on time

**Rooms:** Prices are per person, based on two persons sharing a stateroom. **Single rooms are available at an additional cost**, in some cases, when requested, we may be able to find an appropriate roommate for passengers. Triple rooms are available in many hotels for family or friends traveling together. There are no discounts for triple rooms.
