Co-Chairs Report for 2024

There's been lots going on within the Church Community as well as many activities and events inviting our community at large to join us.

In 2024 ongoing conversations have been taking place: how can we stay afloat and how do we grow the church? There have been meetings with Kathy Davies of PMR. Rev. Scott Reynolds, Growth Animator with Chinook Winds and Pacific Mountain Region visited Zion on April 15th & 16th, Scott led us in Sunday worship and did a presentation on Ethical Wills on April 16th.

The 100th Anniversary Committee was formed and have been actively hosting events leading up to the 100th Anniversary celebrations to take place in June 2025.

The committee organized & decorated a float and participated in the IPE parade, drawing attention to the history of Zion United Church as well as the many things Zion currently has to offer the community. Some members participated in the Recreational Fair held at the Curling Club in September with a display depicting the life and activities of our church.

A task force/working committee was created in the summer of 2024 and they are challenged to develop a Five Year Sustainable Ministry plan, work to commence in 2025 in conjunction with the Pacific Mountain Region and our local congregation.

December saw the disbanding of St. Andrews United Church and their decommissioning service, members of our Council and Congregation were there to support our friends & neighbours, willingly and compassionately. We are encouraged by the enthusiasm many from St. Andrews are expressing in actively joining our Faith Community.

It was our pleasure to work with the Armstrong/Spallumcheen Chamber of Commerce hosting the Citizen of the Year tea and providing a warm, welcoming place during Christmas Light Up.

All of our committees have worked hard throughout the year as has our Minister Hati. Thank you to everyone for their contributions and support.



Worship Committee Report for 2024

The past year has seen some continuity and some changes in our congregational worship.

We started the year as two congregations sharing a minister who led two services most Sundays. The worship committee had members from both congregations and met jointly. The first Sunday of each month we held a joint service, alternating between Zion, Armstrong and St. Andrew's, Enderby. Communion was offered on those joint service Sundays.

During the months of July and August, we had joint services with all of July's worship in St. Andrew's and all of August's worship being held in Zion. This has worked well during the summers we shared a minister who was at Camp Mackenzie for most of the month of July.

In the spring, Rev Hati led a Lectionary Bible study in Enderby which was well received.

In 2024 the joint services of Easter (Good Friday and Sunrise, Easter Sunday) were hosted by St. Andrew's.

As part of the Upcoming 100th birthday of the United Church of Canada in 2025, each congregation presented a brief history of their church during a joint service.

Blue Christmas was hosted by St. Andrew's and each church had their own Christmas Eve service. The biggest of changes was the closure of St. Andrew's United Church in Enderby at the end of 2024. They had been in serious study of this for well over a year. The Celebration of Life and official decommissioning service was held December 1. Many area retired ministers took part in the service, particularly in the communion service. St. Andrew's congregation continued to worship there until the end of December.

The final service at St. Andrew's was a joint hymn sing of favourites on Dec 29, 2024.

Zion has received many items from St. Andrew's. Their hymn books are already in use as are some of the communion glasses. There is a collection of banners and other linens which we will be going through carefully to see how they might be best used.

At Zion, we continued with both a Lent project – supporting the school breakfast program in schools and an Advent project - collecting money for the Armstrong Food bank as well as socks, mitts, toques and scarves for the Boys and Girls Club Okanagan (BGCO). These have been thankfully received by those we supported.

As we start 2025, we are looking forward to celebrating the 100th Anniversary of the United Church of Canada June 6-8, but also with smaller events during the year.

Ministry and Personnel Committee

The M&P Committee is a mandatory committee required by the by-laws of the United Church of Canada. It is responsible for supporting, overseeing, and supervising ministry personnel and lay staff.

There are three distinct roles this committee has the responsibility to carry out.

1. **Consultive and supportive role** – to gather and share ideas, brainstorm and gather ideas.
2. **Healthy relationship role** – help ministry personnel, lay employees and members and adherents of the congregation to build positive and trusting, healthy relationships. We work to ensure the opportunity where constructive feedback can be offered and received in a positive way.
3. **Supervisory role** – overseeing and monitoring the effectiveness of staff in relation to the community of faith and to communicate with the governing board or council of the congregation.

As well as communication with our congregation we have the responsibility to stay in touch with the Pastoral Relations committee of the regional council. This regional council for us is the Pacific Mountain Region and our representative is Kathy Davies. Over the past year we have really appreciated the support and knowledge that Kathy has been able to provide.

Another relationship that this committee can nurture is between itself and other committees of the church. We hope to build on this in the coming year as we as a congregation work towards developing our Sustainable Ministry Plan. Building stronger committees that will carry out the work of our church will be included in our focus. As a committee we will be a supportive presence in this process. We will also be available to take on a leadership role in the nurture of our congregation as we journey in discovering how we grow and support each other at this present time.

Our committee was comprised of two members from the St. Andrew's and two members from the Zion congregation. A third member was recruited to supplement the "snowbirds" on this team. We want to Thank Isobel Kay for her involvement and her contribution to this committee.

Good Food Box For the AGM in 2025

The Good Food Box has operated from the Zion United Church Hall basement since it was started in Armstrong. Zion United has generously donated the space for this program and it is much appreciated. Our Armstrong branch is fully staffed by volunteers.

The Good Food Box is a co-operative bulk purchasing and distribution program of fresh produce in the North Okanagan. Our Armstrong branch has steadily grown over the years from a small number of boxes to an average of just over 100 boxes each month. As much produce as possible is purchased from local growers and out of country produce (i.e. oranges and bananas) is purchased through local wholesalers.

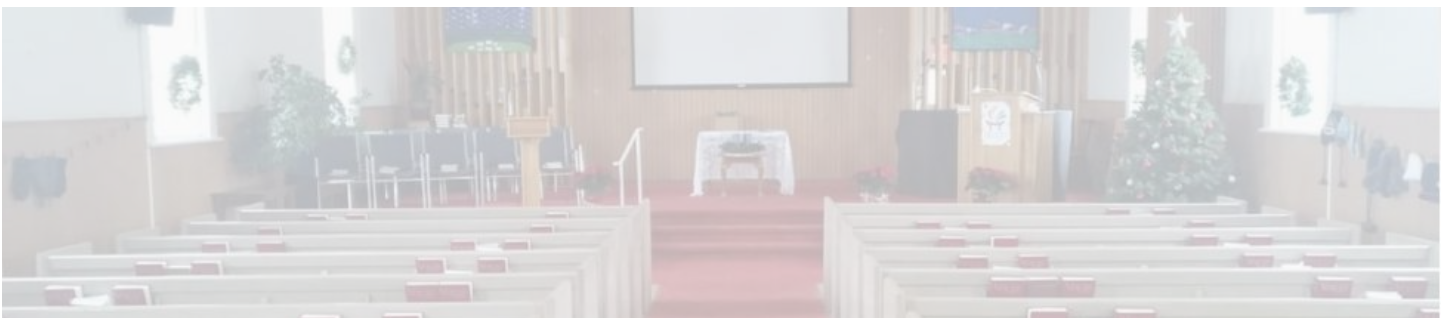
Subsidized boxes are also part of the program, supported by North Okanagan sponsors.

To order a box – large boxes are \$25. And small boxes are \$15. You may order these by:

- go online to the Goodfoodbox.ca, find the North Okanagan and follow the directions.
- pay in cash at the BGCO office beside the Post Office
- pay in cash at the Gathering Grounds Thrift Shop behind Askew's
- Pay in cash when you pick up your box on the third Thursday of the month

The Deadline for ordering is the Tuesday the week before the third Thursday of each month. The third Thursday of each month is the day to pick up the bin from the Zion Hall basement from 1 – 4 p.m.

Zion Property Committee Report 2024

Year 2024 began with a complete overhaul of the kitchenette in the lounge. The walls and ceiling were painted, an upper cabinet was installed, and the carpet was replaced with new flooring. Then the work moved to the hall. The bathrooms received a fresh coat of paint. Faucets in both bathrooms were replaced. The hall and stage walls and wainscotting were painted. New flooring was installed in the entrances to the stage. The stage front was resurfaced with new doors and painted to match the wainscotting. The floor in the hall was professionally cleaned to do a deep cleaning that weekly cleaning can not do.

On the exterior, a new gate between the lounge and hall was built to close off the sidewalk when snow slides from the roof are possible. In February, a broken water line under the sidewalk between the lounge and hall was repaired. This line will be discarded in 2025 when the galvanized and Poly-B pipes are replaced with new pex tubing. A huge thank you to Suzanne, Jim and the others who planted and maintained the flower gardens and lawn. Early in January 2025, motion sensitive lights were installed at the east entrance to the lounge (RCMP side), on the lounge exterior to illuminate the ramp between the lounge and hall, and above the south east deck to illuminate the new south parking area.

Scheduled for 2025 is the painting of the walls in the entrances to the stage and the kitchen, and the interior surfaces of the hall doors and trim. Plumbing upgrades to the hall and lounge will also be completed. A new projector will be installed (suspended from the ceiling) in the sanctuary to allow for better viewing. There is the possibility that one or both of the aging furnaces will need to be replaced this year. Quotes have been received for the replacement of the single pane windows in the hall. This would improve energy efficiency and airflow (windows can be opened, weather permitting).

Pastoral Care Team (PCT) Summary 2024 (Zion United Church)

Pastoral Care is at the core of Christian Ministry.

From the New International Version of Acts 20:28 (NIV) we have:

“So keep watch over yourselves and over all the flock which the Holy Spirit has placed in your care. Be shepherds of the church of God, which he made his own through the death of his Son.”

At Zion United Church (ZUC), Pastoral Care is the ministry of support, care, and presence offered by the Minister, the Pastoral Care Team, and members of the congregation.

At ZUC, we are blessed to have a minister, Rev. Hati Mvundura, who is very passionate about pastoral visitations. Leading by example, he demonstrates to all church members that visits enhance relationships, and strengthen the church community, as a whole.

During 2024, the PCT formally consisted of Rev. Hati, Isobel Kay, Pam Krazanowski, Suzanne Skinner, and Wilma Koersen. We met, as a group, on four occasions. We demonstrated care for God’s people in a variety of ways including:

- Offering spiritual guidance for those attending church, as well as visitations for those unable to attend
- Maintaining ‘check-in’ contact with members of congregation with cards, phone calls, email, or home visits
- Hospital visitations, and bereavement support and follow-up
- Driving of church members to a medical appointment, or other needed destinations
- Taking food to someone who is ill or going through a difficult time
- Engaging with someone who is new to the church
- Promoting, and modeling, a culture of inclusion at our church

In 2024, thirty cards were sent out to congregation members for a variety of major life events (sympathy, major illness, birthday, anniversary, new home) via the ‘Sunshine Lady’. Small Easter lilies were delivered to six church members who are no longer able to attend church. Similarly small poinsettias were delivered at Christmas time to 2 of our shut-ins (90 years or older). Due to the Canada Post Strike of late 2024, no Christmas cards were sent.

Two new initiatives to Pastoral Care were introduced in 2024.

- a. From early January to late March, an informal coffee/cards/chat group was held, bi-weekly, Thursday afternoons (2-4pm) in the ZUC Hall. Attendance ranged from 3-6 attendees. New friendships developed through this group.
- b. A ‘A Widow’s Grief Group’, facilitated by Wendy Adams was formed in late spring. The group met four times in 2024, on a Thursday afternoon. The goal of the group is to provide emotional support, validation, education and coping skills about grief. Attendance ranged from 6-12 attendees.

As a PCT, we recognize, though how all of the ZUC family are participants in our Pastoral Care Ministry. We are reliant on the congregation to share a concern, or celebration, with us. We are also grateful for the many ways in which members ‘help look’ after each other. Working together, we strengthen the community and spirit of our church.

MacKenzie Camp 2024

In 2024, Zion United Church (ZUC) played a crucial role in supporting MacKenzie Camp. Although the camp's peak season runs from June to September, various preparations, meetings, and fundraising activities took place throughout the year to bolster the camp's ministry.

ZUC is fortunate to have Rev. Hati Mvundura as its minister, whose enthusiasm for the camp is evident. On June 2, 2024, he conducted a well-attended joint communion service at MacKenzie Camp, bringing together congregants from St. Andrew's UC (Enderby) and ZUC. Additionally, Rev. Hati served as the camp chaplain in July, participating in planning and leadership sessions while providing pastoral support to campers.

ZUC's primary fundraising initiative for MacKenzie Camp was the annual garage sale held on May 4th, which raised \$1,881.10 through donations from church members, and their friends, for camp sponsorships. Furthermore, in early June, four ZUC members participated in a MacKenzie Camp golf event at the Salmon Arm Golf & Country Club, successfully collecting over \$2,500 in pledges.

ZUC members made notable contributions by assisting with the spring setup, autumn cleanup, grocery deliveries from the wholesale store in Vernon, baking, and various aspects of camp programming. In 2024, two additional board members from Mackenzie Camp were appointed from ZUC, increasing the total to five. We express our deep gratitude for the various contributions of time, skills, and donations received for Mackenzie Camp. As we approach the 2025 camp season, we anticipate ongoing support from our congregation to further enrich the experiences of this essential 1st Third Ministry, emphasizing the core values of compassion, contribution, commitment, and character.

Zion United Church Finance Committee

As requested, I have completed a review of the 2023 and 2024 financial statements of Zion United Church with the kind assistance of Leona Harrison. This “review” is a very cursory review of the general ledger and financial statements. Any queries were forwarded to Leona and were responded to in a timely and complete manner.

To be clear, my procedure should not be considered as an audit or a formal review of the financials in the context of what a professional accounting firm might carry out. It does not attest to the accuracy of balances or transactions, does not ascertain the effectiveness of the church’s internal controls nor does it comment on Zion’s compliance with generally accepted accounting principles relating to non-profit organizations. My review simply gains comfort from the manner in which Zion’s financial statements are produced and the rationale behind the various sums and balances.

My conclusion is that these financial statements are a fair representation of Zion’s overall financial results. They are prepared in a thoughtful and meaningful way and are clear and understandable.

I do have one suggestion. Namely, the Building Committee should submit, to the Finance Committee, a budget outlining yearly expected expenditures from the Building Fund and, in addition, submit a list of wants and needs to do with the building’s maintenance and renovation requirements. This would better assist Zion in planning for its future financial capital needs. Large negative fiscal surprises tend to be building related rather than operationally related and an understanding of building needs focuses the congregation on funding those needs, just the same as a weekly offering shortfall.

Treasurer's Report

First, let me express my deep gratitude to the congregation!

The 2024 Budget predicted an operating deficit of over (\$25,000), but thanks to increased donations and sustained fundraising efforts we ended the year with a deficit of only (\$7,923).

Here are some additional 2024 "Finance Facts":

- Local Offerings were \$71,347, up by \$11,287. Thank you, Zion contributors!
- The Building Fund overdraft of (\$6,428) was brought down to (\$64) through donations, memorials, and fundraising. Again, thank you, Zion contributors!
- Hall Rental revenue of \$3,905 was almost \$200 more than 2023.
- The Fundraising profit of \$6,270 was just a "whisker" less than 2023.
- Sale of Askew's Cards netted \$4,180. Thanks to both sales force and customers.
- We raised \$11,071 for Outreach: Mission & Service \$5,148; Camp Mackenzie \$2,518;

School Food Programs \$1,010; and Christmas Hampers \$2,395.

- Operating Cost increased by \$5,659, comprised mainly of an increase of \$2,983 in Personnel, \$1,835 in Administration and Insurance, and \$990 in programs.
- Utility costs were down \$792, and total property maintenance costs decreased by \$601.
- The PCEET fund earned \$518.54 in interest. \$984 from this fund was used to fund the clergy education allowance.
- In December St. Andrew's advanced \$15,160.54 towards 40% clergy salary support to June 2025. Another \$4,000 - \$5,000 should be forthcoming.

Now let's look at the future as presented in the 2025 Preliminary Budget (see rightmost column in the 2024 Annual Operating Income Statement):

Even with the receipt of \$20,000 from St. Andrew's to cover 40% of clergy salary for six months, the projected operating deficit is (\$30,184.72).

- This translates to \$19,469 shortfall in funding for the additional .4FTE of clergy salary, and an additional \$10,715 to cover other operating expenses.
- Included in this budget is a 13.5% increase in local offerings. This is a slightly smaller increase than was achieved in 2024. Could we challenge ourselves to do better?
- Other types of fundraising have been budgeted essentially the same as 2024. Do we have some new fundraising ideas? Could we do better?
- The 2025 Budget is titled "Preliminary" because we have a tentative commitment from the United Church Pacific Mountain Region to assist with funding clergy salary to the end of 2025. Details regarding the terms and amount of this assistance were not available at the time of writing this report.

As a congregation we have made very encouraging financial progress in 2024.

As we move into 2025 and beyond it is important to maintain that momentum to achieve the goal of a sustainable ministry for our congregation.
