Amber Emm Art Tours (AEAT) organise small-group boutique group tours to Akaroa New Zealand.

AEAT make arrangements with private guest lodges, van hire companies and other independent parties to provide you with the travel services you purchased. Although AEAT takes great care in selecting these suppliers, AEAT is unable to and does not have any control over them and therefore cannot be responsible for their acts or omissions.

The travel services provided are subject to the conditions imposed by the suppliers and their liability is limited by their tariffs, conditions of carriage, tickets and vouchers and international conventions and agreements. AEAT shall not be responsible for any loss, damage or injury, whether physical or mental, resulting from any delay, substitution of equipment, or any act, omission, negligence or commission of any party supplying any of the services or accommodations herein, its agents, servants, employees, subcontractors, or for any claims for such loss, damage or injury, whether physical or mental, arising therefrom, or from any cause that arises by reason of actions of parties other than AEAT, including act of terrorism or act of war.

AEAT has the right to cancel or modify a tour or travel service you have purchased by substituting services or varying the itinerary. Reservation & Payment

Reservation will be confirmed upon receipt of 50% of ticket price per person NON-REFUNDABLE deposit within 60 days of departure . Final payment is due 60 days before arrival. Form of payment accepted is Bank Transfer.

Departure Guarantee

The departures listed each require a minimum of 4 artist guests, to guarantee the departure of the trip. AEAT will advise you of the current trip status at the time of booking. Departures are not fully guaranteed until full payment is made 75 days prior to departure. Should the status of a departure not meet minimum numbers, a full refund of the deposit and/or the full payment you have made will be provided. AEAT will not be responsible for any other consequential loss incurred because of trip cancellation due to lack of numbers.

Changes Changes are not permitted. At the sole discretion of AFAT, a switch between trip departure dates may be offered upon request.

Cancellation/Penalties

Cancellation: 2 months out from departure or more will result in the loss of the deposit. Or will be given the chance to change their trip to the next available tour space.

Cancellation: 6 weeks out or less will result in full loss of tour cost.

Prices

Prices are quoted in \$NZD and are based on the current rate NZD/EUR of exchange at time of deposit. Should the currency increase above 7% a supplement will apply.

Accommodation

Accommodations will be provided in the property mentioned in the flyer, or a similar property. Guests should be aware that services vary according to different standards in various European countries. AEAT reserves the right to make substitutions with hotels of similar or higher ratings.

On this trip you can expect to stay in a small family-run boutique lodge, which will vary a little in standard and facilities. The lodge chosen does not have elevators. However, you can expect to find clean, safe, simple accommodation in the township of Akaroa with a personable English-speaking host.

Each of the 4 bedroom has a private ensuite King size bed the other room has 2 singles this is for 2 artists.

Included in tour

Pick up and drop off from Christchurch airport, accommodation at French Bay house for 7 nights, 2 Dinners , 1 Lunch, 7 Breakfasts , 4 hrs teaching for 6 days , all painting materials supplied and Transport to and from painting locations each day.

Not Included in Tour Price

The cost does not include flights, 5 Dinners, 5 Lunches, gratuities**, local city taxes, items of personal nature, meals, and drinks (unless specified) telephone calls, wines, liquors, soft drinks ,travel insurance.

Gratuities are not required from our team on the ground.

Voucher/Documents

Travel confirmation and transfer details will be sent 30 days prior to commencement.

Travel Documentation

Exclusion of Liability


