Executive Summary

Current YTD Income:

Total Income: \$131,529.98

Other Income (Donations): \$9,288.52

Gross Income: \$140,818.50

Projected Q4 Income:


Cash Calendars: \$12,000 Cooperstown: \$3,000

Projected Year-End Total Income: \$155,818.50


Key Observations

- Overall YTD Performance: Donations kept net income positive despite operating deficit.
- Expense Drivers: Tuition Assistance and Event Expenditures account for 93% of spending.
- Cash Position: Healthy at \$26,804, but margins remain tight.
- Trend: Expenses slightly outpace core income; reliance on donations and Q4 fundraising is critical.
- **Projection Impact:** Expected Q4 income significantly improves outlook, raising projected net income to over \$20K.


2025 YTD Financial Summary
