GENERAL PRICE LIST

THESE PRICES ARE EFFECTIVE January 9, 2026, BUT ARE SUBJECT TO CHANGE WITHOUT PRIOR NOTICE.

The Federal Trade Commission (FTC) and the New York State Department of Health both require that funeral providers on the General Price List make certain disclosures. Although these disclosures are similar, they are not the same. This General Price List contains both sets of the required disclosures. The disclosures required by the FTC, when different from those required by the Department of Health, are preceded by the letters "FTC."

(FTC) "The goods and services shown below are those we can provide our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected."

(NYS) The goods and services shown are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangement you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

(NYS) This list may not include prices for certain items that you select, such as cemetery charges or crematory services, flowers and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.

ALTERNATIVE SERVICES:

The following charges for **direct burial** and **direct cremation** do not include additional items or services, merchandise, facility use, and livery that the customer may wish to select.

DIRECT CREMATION:

Prices range from: **\$2,450.00**
which includes the services as described below, but with *the cremation container supplied by the customer.*

To: **\$9,850.00**
which includes the services as described below, but with *a casket selected from our Funeral Home. (A complete price list will be provided by the funeral home.)*

which includes the local transfer of remains to the funeral home, staff services, securing of necessary authorization, basic local transportation to the crematory, a minimum alternative container for cremation, and return of the remains to the funeral home.

(FTC) "If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials."

(NYS) If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials.

(NYS) The direct cremation prices do not include the crematory charge.

DIRECT (IMMEDIATE) BURIALS:

Prices range from: **\$2,175.00**
which includes the services as described below, but with *the casket and grave liner supplied by the customer.*

To: **\$27,725.00**
Which includes the services as described below, but with *the casket selected from our Funeral Home, and a grave liner. (A complete price list will be provided by the funeral home.)*

which includes the local transfer of remains to the funeral home, staff services, securing of necessary authorizations, basic local transportation to the cemetery, and a *cloth covered casket (special order) and a grave liner.*

(NYS) Direct burial prices do not include cemetery charges.

PREPARATION OF REMAINS:

Keenan Funeral Home requires embalming for viewing and/or open casket funerals.

(FTC) Embalming is not required by law. Embalming may be necessary, however; if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate/direct burial.

(NYS) In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement, which does not require you to pay for embalming such as a direct cremation or direct burial. If you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be required by the funeral firm.

OTHER PREPARATION: (Including use of the preparation room, but excluding embalming)

(NYS) Preparation of the remains, unless selected, is not required for direct cremation or for direct burial.

(NYS) Custodial Care will not be charged on the days when embalming or other preparation of the remains occurs, visitation is held, or a funeral service is conducted.

(FTC) This fee for our basic services will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

(NYS) The charge for our services will be added to the total cost of the funeral arrangements you select. However, this charge will not be added to the cost for direct cremation, direct burial, forwarding of remains, or receiving of remains, because the prices for those services include this charge.

LIMITED SERVICES:

Forwarding remains to another funeral home \$2,175.00

This charge includes the transfer of the remains to the funeral home, staff services, securing necessary authorizations, and local transportation to point of shipment.

NOTE: The charge DOES NOT include embalming, topical disinfectant, shipping charges or additional items of services, merchandise, facility use, livery, or a minimum-shipping container that the customer may wish to select.

Transportation beyond the local point of shipment will be billed at \$3.00, per mile or the actual common carrier charges, depending on the forwarding location. The "local point of shipment" shall mean a location within a 15-mile radius of the funeral establishment from which the remains are being sent.

Receiving remains from another funeral home \$2,175.00

This charge includes the transfer of the remains to the funeral establishment and/or place of local disposition, securing necessary authorizations, and the services of the funeral director and staff.

NOTE: The charge DOES NOT include additional items of services, merchandise, facility use, and livery that the customer may wish to select.

Transportation beyond the local point of shipment will be billed at \$3.00, per mile, or the actual common carrier charges, depending on the receiving location. The "local point of shipment" shall mean a location within a 15-mile radius of the funeral establishment to whom the remains are being sent.

CASH ADVANCES:

(NYS) Services and merchandise provided as cash advance items will be billed at the same amount paid by the funeral firm. We will charge you no more for these items, than is actually paid to the third parties.

CASH ADVANCE ITEMS MUST BE PAID PRIOR TO THE FUNERAL

These include, but are not limited to:

1. Cemetery and/or Crematory Charges
2. Death Certificate Transcripts
3. Clergy Honoraria, Organist, Soloist, Sexton, Cantor, Bag Piper, or Church Charges
4. Newspaper Notices
5. Airfare or Other Public Transportation Charges
6. Telephone and Telegraph Charges
7. Charge for Other Facility Use
8. Limousines Hired for Family Use on Day of Services/Burial

CONTAINERS PURCHASED BY PURCHASER

Containers provided by purchaser must carry Liability Insurance and hold harmless agreement, releasing the funeral home from any liability, should a failure occur causing injury, mental or physical, to any persons including but not limited to funeral home personnel, members of the bereaved family, cemetery, or crematory personnel. The provider shall also be held liable for any/all attorney fees and court costs pertaining to the forementioned items, should the funeral home have any cause to pursue a legal recourse. Our funeral home requires a signed release indicating that the provider shall not hold the funeral home liable for any structural defects, or substandard construction.

WARRANTIES

Daniel Keenan Funeral Home makes no representations or warranties about the protective value of certain caskets, or outer burial containers, other than those made by the manufacturer. The only warranties, expressed or implied, granted in connection with goods sold with this funeral service, are the express written warranties, if any, extended by the manufacturer thereof.
