Rhonda was the first to serve but quickly discovered her traveling career didn't allow for her to serve as she had intended so Brett replaced her. It didn't take long for him to realize why she loved the work of the Community Foundation. Brett

continued to serve for almost 10 years, including two years as the advisory board president. While serving, the Warners saw firsthand the positive impact of the Community Foundation in Pike County.

After serving on the advisory board, the Warners knew that establishing an endowment fund to honor Brett's sister Angela (Angie) would help keep her memory alive while improving the lives of people in Pike County.

The Angela J. Warner Unrestricted Fund, a community good fund, allows the Community Foundation to use the annual distributions to provide grants to local nonprofits.

Angie had diverse philanthropic interests and was involved with organizations supporting youth development, education, and human services in the community. This fund mirrors her lifelong commitment and

involvement in Pike County and allows the Community Foundation to support the community's greatest needs in these areas.

The Warners emphasize that donors do not have to be wealthy to establish an endowment fund. You just need the desire to positively impact the community for many years to come. ## GRANT IN ACTION

### TTR HAVEN OVER THE HILLTOP

If you want to learn about the good work of the Pike County Community Foundation, just ask Marcia Hill, co-director of the TTR Haven Over the Hilltop (TTR). Hill is singing the Community Foundation's praises due to receiving a \$10,000 grant awarded through the Community Good Grants program.

This grant allowed the organization to move forward with their dream for TTR's building in Otwell – the addition of a kitchen. This organization serves people that are caring for a child who is not their own. Whether the caregiver is a relative, a foster parent, or some other individual, TTR is there to help. They also assist parents escaping abusive homes and families in healing from the harmful effects of drug abuse.

TTR will utilize the new kitchen to teach young people cooking skills and encourage participation in preparing refreshments for parent meetings. Hill explained that the addition of the kitchen will allow TTR to use its building as a shelter when needed. "Since starting the organization in 2016, we have learned that whatever our original ideas are, they grow and change

over time," she explained. "I am certain that TTR will ultimately use the kitchen in ways we've yet to consider – ways that will help our families."

TTR's mission is multifaceted. It offers guidance and training for caregivers. It also provides food and clothing for its families. They offer basics that can be hard to come by for individuals who have accepted a child in their home.

Hill said word of TTR's mission is spreading, "Awareness is critical to making the most of what TTR offers." More people are reaching out for help and this is precisely what they want. "To serve families in times when they need it most," said Hill. "This is what prompted my daughter, my husband, and me to start TTR and this is what fuels the fire in us."
