- To support members through capacity building, resource sharing, and professional development initiatives.

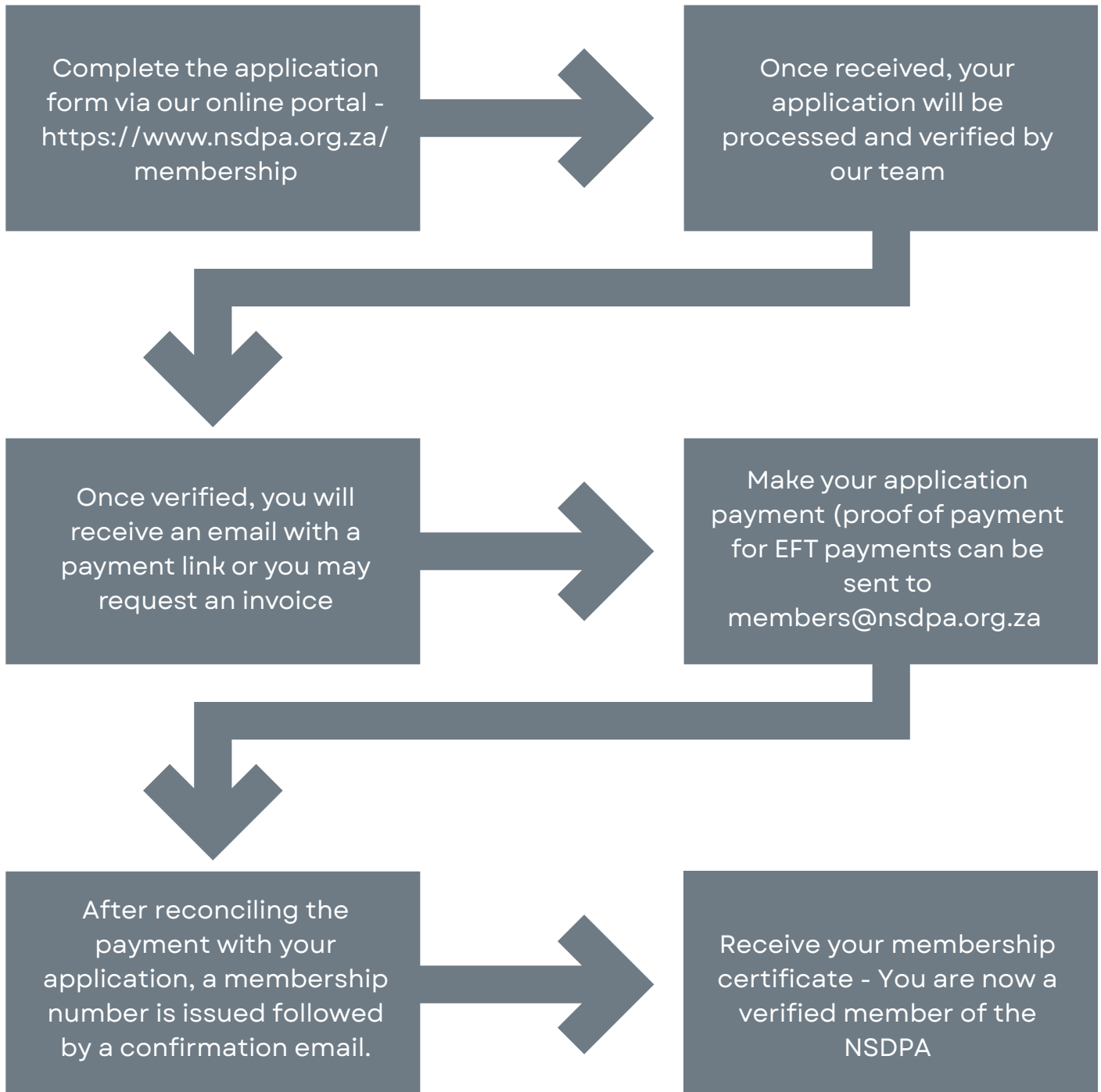
