

ARTICLES OF INCORPORATION

WAL SWACKHAMER - SECRETARY OF STATE

INCLINE PINES CONDOMINIUM HOME OWNERS ASSOCIATION

We, the undersigned, a majority of whom are residents of the State of Nevada, have today associated pursuant to NRS 81.010 through NRS 81.160 and certify as follows:

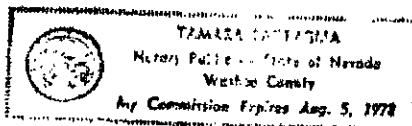
ARTICLE I. NAME. The name of the corporation shall be "Incline Pines Condominium Home Owners Association."

ARTICLE II. PURPOSE. The primary purpose for which the Association is formed is to promote the social, environmental, and recreational welfare of the Incline Pines community. To that end, the Association shall manage, maintain, preserve, and operate for the benefit of the Incline Pines community the real and personal property it acquires and over which it is given such powers by that Condominium Declaration dated December 29, 1972, and recorded in Book 709 of Official Records, Washoe County, Nevada, on February 16, 1973, under Document No. 275965. No part of the net income of the association shall accrue to the private benefit of any individual member. In any and all events the corporation is organized and shall be operated in such a way that its income shall be exempt from federal income taxes pursuant to Section 501(c)(4) of the Internal Revenue Code of 1954 as amended. Nothing contained in the foregoing statement shall ever be construed to authorize the corporation to carry on any act for the individual benefit of any of its members, or to distribute any gains, profits, or dividends to any of its members as such, except upon dissolution or winding up.

ARTICLE III. PRINCIPAL PLACE OF BUSINESS. The principal business of the corporation shall be carried on at Incline Pines, Incline Village, Washoe County, Nevada.

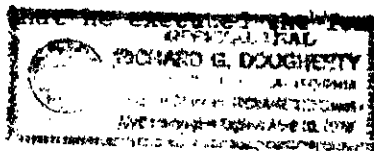

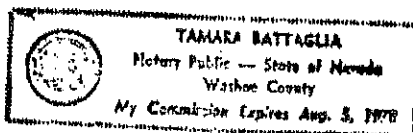

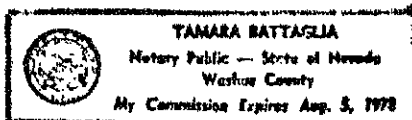
