Fight over mayor's 79% raise escalates

QUINCY – Five citizens are suing the Quincy Board of Registrars in Norfolk Superior Court in Dedham, claiming that hundreds of signatures collected to put the mayor's \$135,000 raise on the ballot were unfairly disqualified.

With the election around the corner, the plaintiffs asked for an Oct. 15 hearing, which the court granted. It will take place at 2 p.m.

Three of the plaintiffs are organizers of Quincy Citizens for Fair Raises, the group working to undo Mayor Thomas Koch's 79% raise, which he ordered for himself in 2024. The plaintiffs are Joe Murphy, Joanne Collins and Steven Perdios.

"Government is supposed to be 'for the people'," Perdios said in a press release accompanying the announcement

of the court action.

"But at every step of the way, our city Government has put roadblocks in front of the will of the people. We shouldn't have to take the city to court to get them to do the right thing. It was something we never wanted, but the voice of the people should be heard."

The other two plaintiffs are registered voters who signed the petition,

MARSHFIELD - Hoping to give seniors better control over their growing use of smartphones, tablets and computers, the Marshfield Senior Center is offering a full week of workshops on new opportunities and increasing risks in the ever-changing tech world.

Starting on Monday morning, Oct. 20, and running through Friday, Oct. 24, the center will present daily workshops, including one-on-one help, on cybersecurity, smartphone tools, photo apps and Facebook social media.
