

## Lee County enacts burn ban due to dry conditions

Commissioners vote to ban outdoor burning as drought index reaches 637 out of 800

Lee County has enacted a burn ban for all unincorporated areas and municipalities effective immediately due to increasingly dry conditions throughout Southwest Florida. The Lee Board of County Commissioners voted to enact the ban at a regularly scheduled meeting January 20<sup>th</sup>, 2026.

The county's ordinance bans "outdoor burning ignition sources," including campfires, bonfires and trash burning, fireworks. Grills for food are not included.

Officials ask all county residents to be mindful of dry conditions and to use good judgment to mitigate potential for significant wildfires.

For the county to enact a burn ban, certain conditions must be met, including a Keetch-Byram Drought Index (KBDI) that reached or exceeds a value of 600. Lee's index value was a mean average of 637 out of 800 Monday afternoon.


This ban does not apply to prescribed burns authorized by the Florida Forest Service.

All other South West Florida Counties initiated burn bans earlier.

Southwest Florida experienced its sixth-driest year in 2025, with dry conditions continuing into 2026.

## Burn bans: What you can and cannot do

**A small spark can go a long way in these dry conditions.**

Without significant rainfall, and cold fronts followed by dry air every 4 to 7 days, drought conditions across SWFL continue to worsen. Nearly every community with the exception of parts of Collier county are now in severe drought.

"It's important to note that in times when it's super dry right now one tiny little spark can cause a potentially very dangerous fire," explained Megan Price, the new Public Education and Information Officer for Lehigh Acres Fire Control and Rescue District.

A little spark is exactly what happened on Tuesday afternoon in Lehigh Acres, when a 3.5-acre fire was sparked accidentally by construction equipment. Because it was in a residential area, Price says it was all hands-on deck to ensure no one was in harm's way.

That fire happened just hours after Lee County issued an official Burn ban, the final county in Southwest Florida to enact the ban.

"Right now all of Lee County is under a burn ban. Any burning is a no go. Absolutely no burning of any kind outside right now is allowed. That includes yard debris and even recreational fires. And that burn ban is in effect until further notice," said Price.

Grilling, however, is okay, so long as there is a cover with no open flame.

Price says that for those who choose to ignore the bans, expect monetary fines. Should a fire get out of hand, any damage and firefighting costs could also be charged.

Bottom line, be cautious and stay vigilant. If you see smoke, don't hesitate to call 911. With these dry conditions, any spark could quickly ignite and spread.

## Hendry County increases fees for burn ban violations

Hendry County residents who violate the burn ban could face fines of \$500 for the first offense and \$2,500 for subsequent offenses. At the Jan. 13 meeting of the Hendry County Commissioners, County Attorney Matt Raulerson explained the change to the ordinance increased the fines for burn ban violations from \$100 to \$500 for the first offense and \$2,500 for any subsequent offense.


The ordinance authorizes enforcement by fire departments, the Hendry County Code Enforcement Office and the Hendry County Sheriff's Office.

## Manatees at risk from cold, pollution and herbicides

Manatee deaths are on the rise again in Florida, according to data released by the Florida Fish and Wildlife Conservation Commission (FWC). According to FWC data, 628 manatee deaths were reported in 2025 in Florida, compared to 556 in 2024 and 546 in 2023.

Florida manatee deaths peaked in 2021 with 1,086 manatees dying that year and dropped to 787 in 2022.

In 2025, many of the dead manatees were not necropsied – 232 of the carcasses were not recovered -- so cause of death was not determined. Many of the manatee deaths were very young with 135 reported perinatal manatee deaths. Watercraft collisions were responsible for 97 manatee deaths in 2025 in Florida, compared to 96 deaths in 2024.

Cold stress killed more than twice as many manatees in 2025, with 33 cold stress deaths reported, than in 2024, with 14 cold stress deaths. Manatees experience cold stress when water temperatures fall below 68 degrees Fahrenheit. During cold weather, they seek warmer waters near natural springs, which stay a constant 70 degrees year-round. Manatees also gather near power plants to enjoy the warm water from the outflows.

Accidents with boat locks or flood gates killed 9 manatees in 2025, down from 17 deaths in 2024.

Lack of food continues to stress Florida manatees in the Indian River Lagoon, where nutrient pollution feeds the “brown tide” algae that shade out the sea grass. The state continues efforts to remove septic tanks near waterways to reduce the nutrient load in runoff.

A University of Florida study published in February 2025 found glyphosate, a commonly used herbicide, may threaten manatee health. The researchers found that glyphosate can reduce immune cell activity by more than 27.3%, potentially compromising the threatened species’ ability to fend off disease.

Glyphosate is one of the chemicals FWC vendors spray into Florida lakes and waterways to control the spread of invasive non-native plants. In 2025, one manatee death was reported in Hendry County; three in Okeechobee County; and seven in Glades County.

The manatee deaths in Hendry County were on Oct. 31, in the Caloosahatchee River, with undetermined cause. The carcass was not necropsied.

*Editor's note: Reported deaths in Lee County:*

*Manatee deaths in Lee County, Florida, including the Caloosahatchee River area, were high in 2025, with reports indicating Lee County was among the hardest-hit areas, facing issues primarily from boat strikes and water quality. While statewide figures showed an increase, Lee County stood out, recording over 100 deaths by late 2025, with many attributed to watercraft collisions, though many cases (over 50%) lacked definitive necropsy results.*

*Lee County Totals: Over 100 deaths (e.g., 113 recorded by early Jan 2026).*

*Statewide Totals: Over 600 deaths.*

*Primary Causes: Boat strikes were a leading cause in Lee County, with reports also highlighting water quality issues and pollution (like red tide/algal blooms) as underlying factors affecting seagrass.*



*Unusual Mortality Events: While not a declared event like 2021, the numbers in Lee County were concerning, with many deaths occurring in Pine Island Sound and Matlacha Pass.*

*Specific Incidents in the Caloosahatchee:*

*One early 2025 record noted a manatee death on the Caloosahatchee River near Moore Haven due to "Human Related: Other" causes, indicating human interaction.*

*Ongoing Concerns:*

*Boaters were urged to slow down and obey speed zones.*

*Environmental advocates pointed to nutrient pollution from agricultural runoffs (like from Lake Okeechobee down the Caloosahatchee) fueling harmful algal blooms, which starve manatees of seagrass.*

# What's Brewing in Alva? A New Local Business

Along-vacant building along State Road 80 is getting a new lease on life, and with it, Alva is preparing to welcome a new locally owned business.

Anarchy Aleworks is preparing to open at 21450 Palm Beach Boulevard, in a building that owner John Ford admits "used to look much different" than it does today. The space, once divided into multiple businesses, has since been remodeled and reconfigured into a brewery and taproom.

Ford, who has spent his career as a pharmacist, said brewing has been a long-time passion. "I've been home brewing just for a hobby for about 30-something years," he said. After selling the specialty pharmacy and infusion business he and his wife built in Fort Myers, Ford said he was ready for a new chapter. "I wanted something to do and felt too young just to sit around, be retired," he said. "I thought, well, we'll start a brewery... I could get paid for it."

Ford said he initially debated whether to buy or lease, eventually choosing to rent to avoid bank loans and investors. "For me to buy property, I'd have had to go to the bank and get a loan. And I didn't wanna do all that," he said. The opportunity came through a personal connection made at a beer festival in Gainesville, which led him to the Alva property owner.

While Alva initially felt "kind of out of the way," Ford said traffic counts and nearby growth helped change his mind. "There are 23,000 cars a day that go past this place," he said, pointing to surrounding communities such as Babcock Ranch, Portico, River Hall, and Verandah. "You've got a lot of people that are out here that haven't really had anything to do. They had to go into Fort Myers to do it."

The brewery's name, Anarchy Aleworks, is one Ford has held onto for years. "I've had that name registered with the state... since '09, I think," he said. While acknowledging that the word "anarchy" can raise concerns, Ford said it reflects a personal philoso-

phy rather than chaos. "A lot of people think it means chaos and disorder, but it just means no government. That's all it means," he said. "I'm not changing the name. I've had it for 17 years now."

Ford said the brewery's goal is simple. "Just to be a place that people wanna spend time at," he said. Rather than operating a full restaurant, Anarchy Aleworks will host food trucks. "I didn't wanna run a restaurant because a restaurant's a hard business to be in," he said.

Live music is also part of the plan. Business manager Tia Ford said she is booking local musicians for the weekly schedule, with performances primarily planned for weekends. Music will be staged on the outdoor patio when possible, with flexibility to move inside if weather requires. "We're trying to support local as much as possible," she said.


The space is designed to be welcoming to families. "I wanna make this place where it's dog-friendly, kid-friendly," Ford said. "We'll have

games for the kids... I wanna make it a place where people come and hang out and feel like this is better than sitting at home."

Anarchy Aleworks will feature 22 taps, with Ford planning to open with 14 house-brewed beers, along with guest taps, cider, and other options. Wine will be served using preservation dispensers. "We wanted to do dispensers just because of the quality," Ford said. "Once you open that bottle of wine, it's gonna be good until it's gone."

Much of the build-out has been hands-on. "We built this bar," Ford said. "Blake and I built that. We finished the whole bar." He emphasized that the business has no investors and no bank loans. "I just need to be profitable. That's it."

While an exact opening date has not yet been announced, the family said renovations are nearing completion, with initial plans calling for a Wednesday-through-Sunday schedule and hours that may adjust as demand becomes clearer. ☀



## Canadian tourists' decline impacts Florida's Gulf Coast

The migration of Canadian tourists to Florida's Gulf Coast has slowed considerably over the past year, impacting the local rental market and prompting some seasonal residents to sell their homes. Fewer Canadian flags are seen along the Gulf Coast as many Canadians have decided to put their homes up for sale.

Cheryl Urquhart, a seasonal resident since 2010, expressed her frustration, saying, "With this situation of the leadership with the USA and the way they treat Canadians, we're not valued at all." This sentiment has led her to put her North Fort Myers home on the market.

"I'm not ready to go, but I feel like we're being forced to go," Urquhart said.

New data from the Florida Convention and Visitors Bureau indicates a 15% decrease in Canadian visitors to the U.S. Phil James, a Canadian who visits yearly, noted that many are visiting discreetly due to trade tensions.

"If you go down and your neighbors know you were in Florida, you might want to try and keep it secret because of the trade tensions," he said.

The decline in Canadian tourists is affecting the Florida rental market.

Dorit Dormayer, a top Florida property management specialist, observed, "We have Canadian guests who stopped renting after last winter." Despite this, the Florida Visitors and Convention Bureau reports a slight increase in overall tourism compared to last year.

Dormayer also noted a decrease in European bookings for the summer, saying, "I have talked to a lot of colleagues in Cape Coral who are seeing the same."

The market now relies more on U.S. travelers to visit the Sunshine State.

# Who Holds The Levers Of Power In Lee County?

## APPOINTMENTS, POWER, AND THE 2026 RECKONING: HOW LEE COUNTY GOT HERE AND WHAT VOTERS DECIDE NEXT

The appointment of Trish Petrosky to the Lee County Commission's District 5 seat has drawn attention not only to one vacancy, but to the systems that quietly shape who governs Lee County, and how much influence voters ultimately have in that process.

While the appointment followed state law after the death of Commissioner Mike Greenwell in October 2025, the timing of the appointment and the structure of county governance have prompted questions that extend beyond a single seat. Those questions touch on recurring appointments, the effects of at-large voting, long-standing approaches to budget oversight, and a 2026 ballot measure that could fundamentally change how commissioners are elected.

What emerges is less a story about one appointee than a broader look at how process, structure, and continuity interact, often long before voters ever cast a ballot.

## A VACANCY, AN APPOINTMENT, AND AN UNEXAMINED PROCESS

The District 5 seat became vacant following the death of Commissioner

Mike Greenwell. Under Florida law, the Governor is authorized to appoint a replacement to serve until the next election.

Public records show that the Petrosky family listed their San Carlos home for sale on September 25, 2025, and entered into a contract to purchase property in Alva, within District 5, days before Greenwell's death. The transaction closed on October 29, less than three weeks after the vacancy occurred.

On December 13, Governor Ron DeSantis announced Petrosky's appointment. The Governor's office did not release a list of applicants, interview schedules, or selection criteria.

Petrosky has stated publicly that her move to Alva was coincidental and that she had long been interested in public service, despite having no prior elected or appointed political experience. While the timeline alone does not establish intent, it raised questions among some residents about how the appointment decision was made and who was considered.

## DISTRICT VOTES VS. COUNTY-WIDE OUTCOMES

The appointment reopened debate over representation in District 5. In the most recent election, Amanda Cochran won approximately 65 percent of the District 5 vote and led countywide Election Day totals. She ultimately lost after absentee and mail-in ballots were counted.

For many residents, the contrast highlighted a recurring concern: that district-level voter preference can be outweighed by countywide dynamics, particularly in rural areas where land-use and infrastructure decisions have long-term effects.

## FROM APPOINTMENT TO INCUMBENCY: HOW STRUCTURE SHAPES OUTCOMES

Appointments are not unusual in Lee County government, and their influence often extends well beyond the moment a vacancy is filled.

Commissioner Mike Greenwell entered office through appointment in 2022 following the death of Commissioner Frank Mann, then went on to win election in 2024. That sequence reflects a broader pattern in which appointments function not just as temporary bridges, but as entry points to incumbency.

The same pattern appears outside the County Commission. Lee County Sheriff Carmine Marceno was appointed to the office in 2018 by then-Governor Rick Scott after then-Sheriff Mike Scott stepped down. Marceno, who

had been serving as Undersheriff, later ran for the position and won election in 2020.

Critics argue that appointments followed by elections provide structural advantages, including early visibility, institutional familiarity, and the authority of office before voters have an opportunity to compare candidates in a contested race. Supporters counter that appointments promote continuity and stability, particularly in complex organizations such as county government and law enforcement. In each case, the process itself is authorized under state law.

Lee County's at-large voting system amplifies these effects. Because all county voters participate in district commission races, perceived incumbency and countywide name recognition can outweigh district-level familiarity. Appointed officials appear on the ballot as sitting officeholders, with visibility established before voters ever cast a vote.

### A DOCUMENTED WEB OF POLITICAL CONSULTING AND INFLUENCE

Public records reviewed by East Lee News show that several key actors involved in land-use policy, electoral politics, and the District 5 appointment have a common political consulting firm.

Neal Communities has retained TM Strategic Consulting for lobbying related to utilities and development issues in Lee County. State Representative Tiffany Espinoza has also retained TM Strategic for political consulting services. Campaign finance records further show that members of the Lee County Board of County Commissioners have engaged the firm for campaign-related work in recent election cycles.

TM Strategic is led by veteran political consultant Terry Miller, who authored the political biography used to publicly introduce Commissioner Trish Petrosky following her appointment and has served as a primary public voice describing her priorities.

In January 2025, Rep. Espinoza sponsored legislation creating the Duke Farms Stewardship District on behalf of Neal Communities. The special district encompasses nearly 1,300 acres in rural Alva and authorizes long-term assessments and bonding authority to finance infrastructure. Despite organized opposition from residents, the bill passed, and the district was established.

Critics argue that overlapping roles among developers, elected officials, appointed officials, and shared political consultants raise questions about how influence operates in Lee County, particularly when appointments, land-use decisions, and campaign infrastructure intersect. Supporters counter that the use of experienced political consultants is common in Florida politics and does not, by itself, indicate improper conduct.

### BUDGET POWER, PUBLIC SAFETY, AND REAL-WORLD COSTS

Petrosky's public positioning includes strong support for law enforcement, a stance widely shared among county officials and one that carries significant political weight in Lee County.

In media interviews following the appointment, Miller described Petrosky as "a good team player" who supports law enforcement and would "do a good job" on the commission, emphasizing familiar themes such as keeping taxes low, cutting wasteful spending, and backing public safety. That messaging aligns with a long-standing political consensus in the county.

That consensus exists alongside concrete fiscal and safety outcomes.

Public budget records show that the

Lee County Sheriff's Office represents one of the largest components of county government spending, exceeding most other departments combined. Year after year, Sheriff's Office budgets have been approved by the Board of County Commissioners largely as presented, with few substantive amendments and limited public discussion linking funding levels to measurable outcomes such as traffic enforcement effectiveness or crash reduction.

Critics argue that this pattern functions as a *de facto* rubber-stamping of one of the county's most powerful agencies, not necessarily out of malice, but because questioning law-enforcement budgets has become politically risky in a county where "support for law enforcement" operates as a near-universal litmus test.

At the same time, Lee County continues to rank among Florida counties with the highest numbers of fatal and serious traffic crashes. In recent years, roadway deaths have averaged roughly one every few days. Traffic safety advocates note that enforcement visibility in many parts of the county, particularly in fast-growing and rural areas, remains inconsistent despite rising budgets and staffing levels.

The consequences are not abstract. Fatal and serious crashes carry direct human costs for families and long-term financial costs for the broader public. Florida consistently ranks among the states with the highest auto insurance premiums in the nation, and crash avoidance is widely recognized as a major driver of those rates. Residents ultimately absorb those costs through higher premiums, medical expenses, lost income, and long-term disability impacts.

Some residents argue that the combination of rising law-enforcement budgets, limited outcome-based scrutiny, and persistent safety failures reveals a structural disconnect between spending and results. Others contend that factors such as population growth, road design, and tourism complicate enforcement efforts.

What remains clear is that sustained political consensus around "supporting law enforcement," reinforced through campaign messaging and consultant framing, has made it difficult to have a frank public conversation about whether existing strategies are saving lives at a rate commensurate with their cost.

### A STRUCTURAL CHOICE ON THE 2026 BALLOT

Voters will have an opportunity to address these underlying dynamics directly in the November 3, 2026, general election.

A county-wide ballot question authorized by House Bill 4001 (HB 4001), approved by the Florida Legislature and signed into law, will ask whether Lee County should transition from at-large county commission elections to single-member districts beginning in 2028.

Lee County is currently one of only two Florida counties with populations over 500,000 that still elect all commissioners at large.

Supporters argue that single-member districts would allow each district to elect a representative with direct knowledge of local challenges, improve accountability, and reduce pressure for municipal corporations driven by perceived lack of representation. Opponents maintain that at-large elections promote countywide cohesion.

The decision will rest with voters.

### THE LARGER QUESTION

As of publication, Neal Communities and Rep. Espinoza have not issued public responses addressing concerns raised by residents regarding the appointment and the broader political context. Commissioner Petrosky has stated publicly that the timing of her relocation to Alva was coincidental, but has not provided further detail addressing questions about the sequence of events surrounding her move and appointment.

For many residents, the central issue is not whether any single appointment complied with the law, but whether the systems governing appointments, elections, land-use policy, and budget oversight operate transparently, and whether voters are given meaningful opportunities to evaluate those systems before outcomes are effectively set.

### WHEN PROCESS SHAPES OUTCOMES

In Lee County, how decisions are made often matters as much as the decisions themselves.

Appointments place individuals in positions of authority before voters have a say. At-large elections spread account-

ability across the entire county rather than anchoring it within individual districts. Budgets, including those tied to public safety, are approved year after year, often without sustained public discussion about whether spending is producing measurable results. Each of these practices is lawful on its own. Together, they form a system that can move major decisions forward with limited public friction.

For voters, the challenge is not a lack of information. It is that the information is scattered. Appointments, land-use legislation, campaign consulting, and budget approvals move through separate processes, even when their impacts converge in the same rural communities and neighborhoods.

As a result, residents are often left to evaluate outcomes after the fact, rather than being part of a transparent conversation before decisions are made.

That dynamic will come into sharper focus in 2026, when Lee County voters are asked to decide whether to retain at-large elections or move to single-member districts. The outcome of that vote will shape not only future appointments, but how accountability, representation, and decision-making function across the county in the years ahead.

### EDITOR'S NOTE:

This article examines the intersection of appointments, election structures, budget practice, and political consulting in Lee County. It does not allege wrongdoing by any individual. Instead, it focuses on documented processes and systems that shape representation and accountability, particularly as voters prepare to decide the future of county governance in the 2026 election.

### Blue-green Algae (Cyanobacteria)

Cyanobacteria is one of the oldest types of lifeforms on Earth and is found primarily in freshwater systems. There are thousands of species of cyanobacteria, and many are known to produce a variety of toxins.

Cyanobacteria is a photosynthetic microorganism that processes sunlight, nitrogen and phosphorous to live. They can regulate their position in the water column for optimal light and thrive in warm, nutrient-rich fresh or brackish water with low turbulence.

Microcystis and Anabaena are two of the most common cyanobacteria found in estuarine systems today. These bacteria are known to produce cyanotoxins dangerous to humans and animals.

Microcystin and Anatoxin are classes of hepatotoxin and neurotoxin, affecting the liver and brain, respectively.

Human and animal exposure to Cyanotoxins comes in three primary forms of contact:

Dermal contact, Inhalation or aspiration from aerosolized surface water, Ingestion

Recently, a growing field of study is focusing on BMAA (beta-Methylamino-L-alanine), which is an amino acid produced by cyanobacteria. BMAA is a “slower working” toxin that has been linked to potentially terminal neurodegenerative disorders such as Alzheimer’s, ALS and Parkinson’s disease in humans.

Calusa Waterkeeper is particularly interested in examining the potential human health risks from chronic cyanobacteria exposure in Southwest Florida and we are uniquely situated as an organization to do so.

When a potentially harmful algae bloom appears, it is typical to try and first identify the dominant species. For certain cyanobacteria and dinoflagellates, we are sometimes able to identify species microscopically or ask affiliates at SCCF

(Sanibel-Captiva Conservation Foundation) or FGCU (Florida Gulf Coast University) for assistance in identification.



AAd Hoc Water Testing

Having an idea of what you want to test for is important, because the effort and costs for assessment of multiple toxins can add up quickly. When we deem that a test for cyanotoxins is prudent, we solicit a third-party lab for that analysis. Results are usually returned within 3 days to a week, depending on the assay, and there is a fee for determining each species or type of toxin.

Monitoring the air for toxins related to harmful algal blooms is essentially a brand-new field of study. After the dreadful dual states-of-emergency caused by blue green algae and red tide in Southwest

Florida in 2018, several researchers became interested in performing air testing here, including some of our colleagues at Florida Gulf Coast University and Brain Chemistry Labs. Two of our original documentary series, Troubled Waters and Waterborne, explore aspects of this research.

In 2021, we designed a novel device called ADAM (Aerosol Detector for Algae Monitoring), which is used to detect aerosolized cyanotoxins. Calusa Waterkeeper volunteers with experience in the engineering and medical research fields worked closely with John Cassani to develop and build three ADAM units from scratch. These are highly portable kits designed to capture air samples over 24-hour deployments.

## Lords of Winter

### A glimpse into the winter life of elk

Rocky Mountain National Park-Light snow falls from the sky into the woodland clearing as the day's remaining sun makes its way through the somber, gray clouds slowly drifting over the peaks above. A frigid breeze gently blows across the treetops, causing the creak of lower trunks and branches rubbing together to create a rhythmic tune. In the distance a lone woodpecker drums its cadence in search of a meal, and the cry of a gray jay makes for a lone lyric in the collective music of nature as it heads back to its nesting shelter for the night.

As this subtle symphony carries through the forest, the sound of a snapping twig breaks the mesmerizing enchantment, then another, and then once more. A slow but steady crunch of snow is discerned, just barely audible through the music. Not the heavy step of a booted foot, but the patient, methodical movement of beings who have intimately known this forest as home for time eternal. One by one, a small band of bull elk enters the snow-blanketed glade and spreads out for a late afternoon meal that will carry them through the long night ahead.

Winter living in the mountains is no easy task, even for a creature seemingly well accustomed to it such as our majestic elk. While herds often tend to migrate to lower elevations for the season, some prefer to keep to the higher country above the foothills. This is more often the case for the small bachelor herds that break off from the main group after the fall rut.

Migrations tend to be spurned by a need for ample food supplies more than a general escape from the harsher climates higher up. If there is ample food available, there isn't as much of a need to head down the mountain.

When the smaller summer herds of females, babies and yearlings gather for the rut, they tend to remain in that larger group throughout the winter along with the herd bulls. This larger grouping can sometimes hold numbers in the hundreds. With a population of that size, mountain living becomes far less sustainable, ultimately forcing

a move that can sometimes take them to the very base of the foothills and the far less snowy grasslands at the edge of the plains.

Bachelor herds typically consist of far lower numbers, usually around a dozen or so, but occasionally gathering as many as 20-30 or more bulls of varying age. I've had the pleasure of spending time with some larger groups as they wintered around the ranch pastures on the outskirts of Estes Park. Locally, I have only seen the smaller groupings, and those sightings tend to be rare.

Those that stay don't tend to wander far in a given day. Survival in the wild is reliant upon conservation of energy. With winter food sources being scarce, long-distance travel would consume far too much of the energy necessary to stay alive.



These herds can often be found near larger mountain meadows in valleys or smaller glades in the higher slopes. If the snow is not too deep, they will use their antlers to dig down to the grass below. While not rich in nutrients like the lush growth of spring and summer, anything helps. When grass is unreachable, they will turn to pine needles and twigs and even bark for sustenance.

The clearings of meadows and glades also provide a source of warmth during the daylight hours, a place to soak in whatever sunlight they may as they graze. If conditions are good enough, they might even enjoy an afternoon bed for an hour or so. If snow is deep, they will remain close to the forest edge, as a trudge too far out into a larger meadow may consume too much energy. They also tend to keep the forest close, retreating to the trees as the cover provides shelter from the oft brutal nightly winter winds.

When I spend time with these beautiful creatures any time of the year, I am always in humble awe at their fortitude, knowing the conditions they endure to live in this mountain kingdom. I am often reminded of a quote about them from one of my favorite naturalist authors, Craig Childs, in his book *The Animal Dialogues*:

"The elk that you glimpse in the summer, those at the forest edge, are survivors of winter, only the strongest. You see one just before dusk that summer, standing at the perimeter of the meadow so it can step back to the forest and vanish. You can't help imagining the still, frozen nights behind it, so cold that the slightest motion is monumental. I have found their bodies, half drifted over in snow, no sign of animal attack or injury. Just toppled over one night with ice working into their lungs. You wouldn't want to stand outside for more than a few minutes in that kind of weather. If you lived through only one of those winters the way this elk has, you would write books about it. You would become a shaman. You would be forever changed. That elk from the winter stands there on the summer evening, watching from beside the forest. It keeps its story to itself."

## How to Encourage Quieter Voices in Your Meetings

Every meeting has a few people who sit back, listen closely, and say almost nothing. They nod, take notes, maybe offer a comment after the meeting—but rarely speak up during the actual discussion. It's easy to assume they're shy or not interested. But often, they're observing, reflecting, or waiting for space that never quite comes.

In community groups, where we count on every voice to shape the work, helping quieter folks feel welcome to contribute is just as important as managing the over-talkers.

Here are a few simple strategies to draw out the quieter voices in your group—without putting anyone on the spot:

### **1. Ask for Written Input First**

Before opening the floor, give everyone a minute or two to write down their thoughts. Then invite people to share, starting with volunteers. This gives people time to think and lowers the pressure of responding “off the cuff.”

### **2. Use Small Groups or Pairs**

Quieter folks often open up in smaller settings. Try using breakout groups or dyads to discuss a topic before coming back to the full group. Ask each group to share one insight, not a full report-out.

### **3. Watch Your Wait Time**

After asking a question, pause for a full 5–7 seconds before filling the silence. It can feel awkward, but that short wait gives people time to gather their thoughts, especially those who think before they speak.

### **4. Acknowledge Non-Verbal Contributions**

A smile, a nod, a note in the chat—these all count. Say things like, “I saw a lot of heads nodding—anyone want to expand on that?” or “Looks like there’s agreement in the chat—can someone read a few comments out loud?”

### **5. Follow Up Outside the Meeting**

Sometimes, people need time or a quieter channel to share. A simple email saying, “I noticed you were thoughtful during our meeting—anything you’d like to add now that you’ve had time to reflect?” can go a long way.


## 6. Create a Safe Environment

Over time, people speak up more when they know their input is welcome and won't be talked over. Set a tone of curiosity, not criticism. Celebrate contributions, even short ones, and don't pressure people to perform.

Remember: being quiet isn't a flaw—it's often a sign of deep thinking. The goal isn't to make everyone talk the same amount. It's to create enough space and safety for people to contribute in the ways that work for them.

# **BEST GROUper SANDWICH**

## **Ingredients:**

### **Chipotle mayonnaise:**

1/2 cup mayonnaise  
2 teaspoons chipotle hot sauce  
One and a half teaspoons fresh lemon juice  
1/4 teaspoon garlic powder  
1/4 teaspoon ground chipotle chili pepper

### **Two Sandwiches :**

1 tablespoon butter at room temperature

Two gourmet buns

3\4 teaspoon salt

1/2 teaspoon black pepper

2 (8 ounce) grouper fillets.

Four Romaine or buttery lettuce leaves.

Four thick tomato slices

### **Directions**

For the mayonnaise, stir together all ingredients in a small bowl and refrigerate 30 minutes or up to a week.

Heat a grill type pan over medium high heat.



For the sandwiches – butter the cut sides of the buns and place in pan and brown for one to two minutes

Sprinkle salt and pepper all over the fish, rub to coat. Place in pan and cook over medium high until the fish is browned and flakes easily with a fork. This should take about three or four minutes per side.

Lightly toast the buns if possible.

Spread one to 2 tablespoons of the mayo onto the cut sides of the buns. On bottom half of buns, layer the lettuce, tomato and fish covered with the top half of the buns and serve.

## IS THAT VIDEO REAL OR NOT?

In our continuing discussion on artificial intelligence, or AI, this month we will cover videos created using artificial intelligence. These videos are commonly known as deepfakes; the definition of deepfakes includes images or sound in which a person's face, body, or voice has been **digitally** altered and are often used **maliciously** or to spread false information. According to research from the digital identity firm Signicat, deepfakes have surged by over **2,100%** since **generative AI** went mainstream in 2022. For the purposes of this article, we will be covering deepfake videos.

### EXAMPLES OF DEEPFAKE VIDEOS

Do you remember when video evidence was incontrovertible proof of what was shown on the video? Video proof can no longer be used as stand-alone evidence due to deepfakes; videos are supportive along with witness testimony and other accompanying evidence. There are many forms of deepfake videos, as noted in the list below and how those can be used.

**Face-Swap Deepfakes:** These videos overlay the face of one person onto the body of another body in motion. The AI neural networks are adept at matching expressions frame by frame with the body in motion, creating realistic looking video. Some of these deepfakes are just for fun, but others can be used for malicious purposes, like ruining a reputation or spreading false information.

**Lip-Syncing and Audio Overlays:** Sometimes called puppeteering, lip-sync deepfakes rearrange mouth movements to match audio, which may be manipulated or completely synthesized. Combined with voice cloning, which we covered last month, the "person" on the video appears to speak but the words were never spoken by any person.

**Full-Body Reenactment:** These videos feature models generated completely by AI, encapsulating one actor's posture, mannerisms, and movement, and ascribing those to a different individual. These deepfakes feature a person or people who appear to be performing tasks or involved in activities which they never did. Although movies and television use this in filming, the malevolent use is that of staged evidence and bogus alibi videos.

## SCAMS USING DEEPFAKE VIDEOS

**Investment Scams:** Watch out for investment requests from your favorite stars. Scammers create deepfake videos, employing the likenesses of financial gurus or celebrities urging viewers to invest in phony schemes, or "exclusive" deals. After the money is sent or the personal information is provided, the scammer can no longer be found, with no return for the victim. An example is a recent scam involving the "CEO" of a crypto company. A video the recruit investors featuring the "CEO" was actually an avatar reciting a script, all programmed with AI.

**Romance Scams:** Use caution when looking for a relationship online. If you meet someone who seems charming and too good to be true, they may be. After creating fake accounts, the scammer uses AI to generate photos, videos and even video chats that may be deepfakes to build relationships. After gaining the trust of their victim, the scammer begins to ask for money or personal financial information.

**Fraud:** Scammers are using AI deepfakes to commit fraud on social media. By manipulating video and audio of content creators, they create new content that appears to be the original creator selling a (non-existent) product for a (bogus) cause. The deepfake videos target the creator's following or audience.

Among the most deepfaked celebrities is Taylor Swift, who "appeared" in a series of social media ads offering free Le Creuset cookware. Participants only had to provide their personal information and pay for shipping. Unfortunately, the videos were fake, and she never made such an offer. Scammers scored the financial and personal information of thousands of Swifties, in addition to the cash.


## DETECTING DEEPFAKES

How can you, the layperson, determine if a video is a deepfake? Here are a few examples you can employ without having to purchase extensive digital equipment.

**Human observation:** Your first line of defense in determining if a video is a deepfake is by watching closely. Look for clues that the figure in the video is an illusion, such as unnatural actions, facial features in which the expression is mismatched or distorted, and inconsistent movement. Do the hair and teeth look real? Are the eye movements natural? Pay attention to subtle anomalies in skin texture, blinking patterns, or mismatched reflections.

**Context cues:** Consider the background in the video. Are there no shadows when there should be? Or are the shadows not consistent with the lighting? Notice if the audio and video are out of sync. If there are objects moving, does the movement make sense?

**Cross Reference the Source:** If you see a suspicious video clip indicating the presence of someone, check the official source of the location to prove or disprove the claim. Press releases often contain alternative camera angles to prove such claims. Mainstream media relies on such cross-checks in the name of credibility.

## WHAT TO DO WHEN YOUR LOVED ONE WAS PICKED UP BY ICE



### **First, report the raid!**

Contact your local community organization if you have one and share the raid information. If you do not know of any organizations, you can report the raid to the Immigrant Defense Project (IDP) at 212-725-6422. Be ready to provide details about the raid.

**Second, retrieve your loved one's information.** It is important to have your loved one's complete name, date of birth, country of origin, and their A-Number if possible. An A-Number begins with an "A" and is followed by eight or nine digits. This is an identifying number issued by the Department of Homeland Security for anyone who has had contact with any immigration agency.

**Q: WHAT HAPPENS IMMEDIATELY AFTER ICE DETAINS MY LOVED ONE?**

**A:** If ICE arrests your loved one, they will first be taken to an ICE office for processing and then to a jail where they will be detained. Families will often get a call from their loved one a few hours after the arrest.

**Q: HOW DO WE KNOW WHEN THE FIRST COURT DATE WILL BE?**

**A:** If your loved one does NOT have an order of removal, in most cases they will be placed in removal proceedings, which means they can fight their case in front of an immigration judge while detained. You can find out when and where the court date will be by calling the Executive Office for Immigration Review (EOIR) Automated System at 1-800-898-7180 or by visiting EOIR's automated website: <https://acis.eoir.justice.gov/en/>.

**Q: HOW WILL THEY GET A LAWYER?**

**A:** Most detained people are unrepresented, because the U.S. government does not provide an immigration lawyer, even if the person cannot afford one. In New York, some detained non-citizens will be appointed an immigration attorney through the New York Immigrant Family Unity Project (NYIFUP) after their first court date but before their second court date. This program provides a free attorney to individuals who are detained and do NOT have a prior order of removal (see the information sheet on NYIFUP included on page 27). *Important: if you hire a private attorney before the first court date, you will be disqualified from NYIFUP, even if you cannot afford to pay that attorney in the future.*

**Q: SHOULD WE TALK TO AN IMMIGRATION ATTORNEY NOW?**

**A:** If a loved one has an order of removal you should consult with an immigration attorney right away. It is important to determine whether the loved one already has a prior order of deportation because they will be at imminent risk of deportation and might need immediate attorney intervention.

**Q: HOW LONG WILL THEY BE DETAINED?**

**A:** If a loved one qualifies for a way to legally stop the deportation in court, they may be detained for many months and sometimes years, all while fighting their case. Under immigration law, some people qualify for a "bond hearing" within the first few months to try and fight their case from the outside while other people are not eligible. Even with a "bond hearing" many people will not be released or they may not be able to afford the bond amount set. Families should make financial plans in order to have money ready for bond and support themselves, for a potentially long period of time, without their loved one's income.

**Q: HOW CAN I VISIT THEM AND SEND THEM MONEY?**

**A:** Each jail has different rules. Specific updated information can be found here: <https://www.ice.gov/detention-facilities>. In the following page you can find information for the most common detention centers.

**Q: CAN WE PREPARE NOW WHILE WAITING FOR COURT?**

**A:** Yes. There are documents that the family can start to collect that may help. In addition, if the loved one had an ongoing obligation to report (maybe to criminal court to pay a fee, probation, a rehabilitative program, etc.), it is important to let the point of contact for that reporting know that your loved one is detained. This can be a long to do list- and a great way for organizers or community members to support the family through this process.

Often, those with heart wounds experience exhaustion, increased irritability or, feeling overwhelmed, isolated, or weighed down by grief or seemingly unending need.


These reactions require the security of a safe fellowship space to facilitate healing. The group will be led by compassionate, faith-filled facilitators who are trained in Bible based trauma healing.



## Colon Cancer

FGCU Community & Public Health Nursing Students

**01** **Signs/Symptoms of Colon Cancer**  
Blood in stool, changes in bowel habits (constipation/diarrhea), unexplained weight loss

**02** **How to Screen for it**  
The best way to detect colon cancer is through a colonoscopy- it usually starts at 45 years old. If your initial colonoscopy is normal, you only need one every 10 years

**03** **Risk factors**  
High intake of red meats, not enough fiber, alcohol use, smoking, family history, ulcerative colitis, crohn's disease. African Americans are 20% more likely to get colon cancer

**04** **Ways to prevent colon cancer**  
Eat food high in fiber (beans, broccoli, carrots, apples, almonds, lentils). Reduce smoking or alcohol use

**05** **Report Changes Early**  
Don't wait—if you have any of these symptoms and are at risk for colon cancer make sure to get screened.

## BREAST CANCER



Breast Cancer is the most common diagnosed cancer and the 2nd leading cancer resulting in death.

**COMMON RISK FACTORS**  
Though a woman's chance of developing breast cancer is only 13%, there are certain factors that increase one's risk. Things such as alcohol consumption and decreased physical activity are examples of lifestyle factors while unchangeable risk factors include genetic predisposition and an early start of menstruation.

**EARLY DIAGNOSTICS AND TREATMENTS**  
Early diagnosis is key to improving outcomes in breast cancer patients. Imaging techniques such as an MRI or ultrasound, or a tissue biopsy may be needed to formally diagnose one with breast cancer. Possible treatments for breast cancer patients include chemotherapy, radiation, and breast reconstruction surgery.

**SELF-BREAST EXAM**  
Inspect the breasts for any changes in size, shape, and contour. Observe for dimpling, skin irritation, and nipple inversion or discharge. Then palpate in circular motions starting from the outer breast edge towards the nipple in an up-and-down manner. Note any lumps, knots, or tenderness and cover all areas of breasts and armpit.



**WHAT IS A MAMMOGRAM?**  
A mammogram is a breast X-ray. It is the best screening test for identifying breast cancer at an early stage. It is recommended to start having mammograms at the age of 40 years old. A mammogram should be done every 1-2 years after that. If you have risk factors such as a family history of breast cancer; talk with your doctor to have a screening mammogram sooner than 40 years old.



## Before you donate funds to ANY relief organization, Protect Yourself

Give to established charities or groups whose work you know and trust.

Be aware of organizations with copycat names or names similar to reputable organizations.

Be wary of new organizations that claim to aid victims of recent high-profile disasters.

Do your research. Use the Federal Trade Commission's resources to examine the track record of a charity.

Give using a check or credit card. If a charity or organization asks you to donate through cash, gift card, virtual currency, or wire transfer, it's probably a scam. Learn more about this trick from the FTC.

Practice good cyber hygiene:

Don't click links or open email attachments from someone you don't know.

Manually type out links instead of clicking on them.

Don't provide any personal information in response to an email, robocall, or robotext.

Check the website's address—most legitimate charity organization websites use .org, not .com.

After a natural disaster or other emergency, carefully vet any contractors before hiring them to work on your home or business.
