

# A bit of ALVA History

## Steamboating the Caloosahatchee

In 1908 the Menge Steamship Company of Fort Myers, Florida slid the new *SS Uneeda* down the ways at their busy shipyard to begin hauling freight, passengers and mail between packing houses, villages, ranch and farm docks along the Caloosahatchee River from Pine Island Sound up the Caloosahatchee River almost to Lake Okeechobee.

From 1888 until 1916 the Uneeda and others of the thirty-some steamers built by the Menge or the Hansen Companies at their Orange River Basin yards in Tice, including the more famous *Thomas A. Edison,* moored at the Alva General Store dock, next to the ferry landing on the north side of the river. Long before there was a true road where four lane Route 80 is now these steamers were the only physical link beyond horseback and hiking on dirt trails from Alva to Fort Myers.

Today she is believed buried in pieces, somewhere in the mud of the Orange River, surrounded by the rotted pilings and building remains of the old Menge Company yards.

The site of the yards is a natural basin in the Orange River you can see from your car by carefully looking to your right as you head toward Fort Myers on Route 80 just west of the Orange River bridge and east of I-75. The actual address in 5601 Palm Beach Boulevard.

By boat, head into the mouth of the Orange River at Orange Harbor Mobile Home Community, and keep bearing right to head toward the basin. It is strongly recommended that boats do not enter the basin itself but use the river channel to pass it by as sunken hulks like the Uneeda, and other underwater debris, has been known to take out a boat's bottom, or at least snag or destroy props.

In the early 2000's it was hoped that this historic site would be developed for tourists with the rebuilt Menge shipyard railway and adjacent Hansen shipyard buildings rebuilt as shops and restaurants. This plan seems to now be a part of Fort Myers history like the shipyards themselves; sunk in the mud.




## Out with the old and in with the new!

A few dozen Alva property owners were actually in the Lehigh Acres Fire Control District Map, thus taking much needed revenue from property taxes from Alva Fire and giving it to Lehigh Acres Fire. Not only were some Alva residents sending their Fire money to Lehigh Acres, but they also had to pay LAMSID (Lehigh Acres Municipal Services Improvement District) about \$103/per ACRE, total waste of money for Alva residents to be paying for Lehigh Acres Water. 2 neighbors on Bateman Rd alone were paying \$800 & \$900+ Annually to LAMSID, but no more!

Local residents took their concerns to Matt Caldwell who was able to help get this fixed and now Alva residents make sure their tax money is going to Alva Fire

## Lake discharges begin in March

— It's not summertime but the U.S. Army Corps of Engineers is already discharging water from Lake Okeechobee into the St Lucie Estuary.



Water is currently flowing through the St. Lucie Lock for the next three weeks.

The Army Corps of Engineers said they are lowering lake levels now before it becomes filled with toxic algae.

Last summer, discharges from Lake Okeechobee brought harmful blue-green algae into the St. Lucie Estuary.

Even though it is the dry season, it has been wetter than usual in some areas of Florida this winter.

The Army Corps says lake levels rose half a foot in the last month to nearly 13 feet.
