The news is that the BOCC is having a WORKSHOP meeting to which the public is invited in June. Alva INC will announce the date and time to anyone on their email list.

Anyone may attend this meeting but only those members of the public who attend the previous board meeting, check the Lee County website for that day and time, and register to speak at the workshop may so speak. Roxanne Gause shared a review of the FDOT plans, not yet finalized, for the major rte 31, Bayshore Road and North River Road connections to a new bridge configuration over the Caloosahatchee. Included are plans for an enlarged connection of rte 31 and Palm Beach Blvd. We were reminded once more that the current 5,000 homes in the permit process or approved and being built are only the beginning of the development of Lee County's last rural area.

Olga 20/20 Land: Sheriff's Livestock Impoundment Yard

Holly Schwartz asked the crowd to not find fault with the sheriff's request to use 8 acres of the 92-acre Fort Myers Shores 20/20 preserve for a criminal investigation impoundment area for animals of all sizes. Holly shared that the Sheriff's department needed the land and was entitled to ask for 20/20 preserve space by law.

Formerly the Sheriff's department has used space, now inadequate, on Ortiz Blvd in Fort Myers.

What was wrong about this situation was that the Conservation Land and Space Advisory Committee made their decision to give this space without public input. This preserve was being used by the public for river access for canoes and kayaks and nature hikes.

The issue is legally closed now, but Alva INC will demand that correct procedures be followed in the future for full public disclosure.

Roxanne Gause shared that the Caloosa 80 RV project at Bateman and Rte 80 on the south side of the river has a long uphill battle with the county to get approval for their up to 700 site resort-campground. Municipal water and sewer will be required and having it run east from River Hall along rte 80 is now doubtful. A very long list of counties 'insufficiencies' has been sent to the owner beyond the water and sewer issues as well. It is possible that the county and owner will be ready to come back together by August of this year.

sat where this building, a former Woodmen of the World Clubhouse, now stands.

Shari Hunt also updated the meeting about the Cary-Duke-Povia (Neal Communities) 700 plus gated community project on rte 78 at Olga. The acquisition of the already approved Owl Creek development by Neal from DR Horton is moving forward with a yet undisclosed new site plan.

---

Perhaps the largest, and newest, project in Alva is also the most surprising. None of Alva INC's members or board learned of the Lee County School Board's decision to revisit the construction of a 2,000 student Middle and High School (identified as NNN) on Joel Road south of Tuckahoe. All learned of it through a news release by the district.

Denise Eberle has investigated this project and found that it will compare with the new Gateway High School which, several years ago, was built there instead of at this Alva location.

The school board has owned these 102 acres on Joel for a few years so it is no wonder that they wish to use it. However, Denise pointed out that it is a long way from any infrastructure and is swampy, which will require lots of land development.

Ms. Eberle also shared that the school and some news agencies are incorrectly stating that the project is in Lehigh Acres. However, Lehigh Acres begins at 23<sup>rd</sup> Street, well below this land. The development of this school in Alva, for 98% Lehigh Acres and elsewhere students make no sense. She suggests they look south and west of current development in Lehigh Acres. However, they do own THIS land already.

The school itself is not a problem for Alva, according to Denise and many at the meeting, as the students and staff would create most traffic going south into Lehigh Acres.

The real issue is the expected proliferation of retail, fast food, etc businesses that the location of the school would bring to Alva. A possible Riverdale-like expansion of commercial property. Denise also pointed out that with the school built here there will be much more pressure to build in and around Alva.

Much discussion from attenders and board members of Alva INC concluded the meeting around the idea of taking more control of our own area by incorporating as a community, separate from the total control the County Commissioners now have over development here.

Many pointed out the need for more control. Others shared the costs of us paying for our own leadership, security, sanitation, etc versus the costs of being under county rule. The legal costs of the process itself would no doubt be high.

A final concern is that such a process is being discussed too late, and Alva, with only over 3,000 residents and a very small commercial tax base, would be hard pressed to make it happen.

I imagine the project will be discussed further at future Alva INC meetings, and around the neighborhood and at the Diner, at Leo's and the Alva Village Market between meetings.

# Sheriff's animal impound facility near ALVA and OLGA draws scrutiny



# Under-the-radar development in Lee County raises concerns

You may have heard of the Marceno Motel – the Fort Myers lockup where high-profile Lee County Sheriff Carmine Marceno houses (alleged) criminals – but how about Carmine's Corral?

Carved from a Caloosahatchee waterfront preserve on a quiet Olga Road, the new Lee County Sheriff's Office Agricultural Crimes Livestock Impoundment Yard will house animals caught

in legal crossfire.

Though none have yet been moved in, neighbors and preserve advocates are raising concerns. They don't question the need for such a facility, but are dismayed at the way it came about: with neither a heads-up for the volunteer board that advises the county on its preserves, nor any advance notice for its neighbors.

## **Surprise! Lee County still has livestock**

The 5.8-acre state-of-the-art stockyard was built for animals involved in active investigations, the sheriff 's office says. In the past, such critters have been held at the Ortiz Avenue jail in Fort Myers. Though Lee County may be best known for its beaches, barrier islands and canal-crisscrossed Cape Coral, agriculture persists here. Residents still run cattle and ride horseback as their kids raise 4-H hogs and chickens, mostly in inland areas. And sometimes, those animals get out, get rustled or get mistreated. That's where the LCSO comes in.

It happens more often than you might think. "The Agriculture Crimes Unit receives calls on a daily basis for investigations ranging to animal cruelty/abuse, livestock running at large, farm theft, etc.," writes spokesman Nestor Montoya in an email. Last year alone, the ag unit responded to 2,490 calls for service, Montoya said.

### 'Decisions made in secret'

Preserve advocates are crying foul. Barbara Manzo, retired director of the county's parks and recreation department sums up the objections: "We do not approve of decisions made in secret." Manzo, who now works with the nonprofit Eyes on Conservation 20/20, a watchdog for the county preserve program, said her group understands the need to work with the

sheriff, "but this was a bad decision. It was made without informing anyone. The (advisory) committee did not have any notice about it either."

Some are also troubled by conservation land – especially a riverfront preserve – used for this purpose. When the county's Conservation 20/20 program paid \$2.6 million for the 91 acres that would become the Olga Shores Preserve in 2017, the idea was to "conserve, protect, and restore the natural resources ... so they are a productive, functional, and biologically diverse ecosystem." With a facility like this, "there are land management and restoration plan considerations that should have been presented to (the board)," said environmental policy associate Holly Schwartz with the Sanibel-Captiva Conservation Foundation, which closely monitors the health of the Caloosahatchee. "That is their very function as written in the ordinance." Yet that never happened.

## 'They violated the intended use of the land'

In the six years it's been open, the Olga Shores Preserve has become an area favorite. Hikers, fat-tire bikers and birders all enjoy it, including near neighbor Jon Smiley and his family.

Smiley has no trouble with cattle on conservation land, but the stockade has changed the preserve's character. "The second LCSO brought in infrastructure, they violated the intended use of the land," Smiley wrote in an email. "They have installed semi-loads of cattle panels, squeeze chutes, signage, fencing and more.

"They are storing equipment on premises as well. This is no longer a preserve. This is a working cattle operation on land that was clearly intended for public use. Period."



Smiley is also quick to point out that as a former corrections deputy, he's "110% pro-law enforcement and the farthest thing from a politically involved/motivated person. However, what has happened at the County 20/20 preserve is completely out of line and needs to be addressed."

## Then again, it's not a gated community, some say

Jennifer Brummer takes the long view. Her family's Olga roots go deep — at one time, their homestead ran from the river to what's now State Road 80. She grew up playing on the 30 acres owned by her Uncle Floyd Wilson directly across from the preserve.

"The way I see it, as long as they're not putting in a development, they're fine," she said, "and if it's housing abused livestock, even better."

## What about all the poop near the already polluted Caloosahatchee?

The county has 15 active cattle leases on Conservation 20/20 parcels, but in terms of manure concentration, a wide-ranging herd is one thing; penned cattle are another. Though the agreement between the county and the sheriff 's office details things like who pays the electric

bill (the sheriff ) and who maintains the fencing around the livestock area (the county) the animals' waste isn't addressed.

It can be significant. According to a paper published in The Florida Cattleman and Livestock Journal, cattle produce between 66 and 96 pounds of poop and up to 5.5 gallons of urine a day per animal.

"Improperly managed pasture runoff may adversely affect the quality of our lakes and streams," according to Florida's Department of Agriculture and Consumer Services in a best management practices handbook it created for ranchers. "Concentrated animal areas such as cow pens and other temporary holding areas have the potential to produce large pollutant loads."

## What's this all costing?

The sheriff 's office paid nothing for the 5.8 acres, since the county already owned it and the two agreed to an open-ended deal.



The LCSO paid for the added improvements, The double-fenced, state-of the art facility, with a high-end tubular metal corral, mechanized handling chutes and a multi-stall shed came to \$71,840.26, according to sheriff 's office public records.

A multi-bay goose-neck livestock trailer also is parked near a spacious pole barn the county once promised would be for preserve-goers, but is now blocked off. County documents show it was originally intended to be a public pavilion. (The preserve's web page still advertises the potential picnics.) Also, off-limits now: a huge Ficus that once offered some of the best tree-climbing in Lee County. It's now safely behind barbed wire-topped stock fence.

## Multiple safety concerns

For years, Smiley's children have enjoyed the preserve. They hike there, fish from the riverbanks and photograph wildlife. Now, he's having second thoughts about that. "With regular sightings of inmate workers on the property (without visible corrections officers watching them) it raises another concern and further complicates allowing the land usage to my children," Smiley wrote in an email.

He points out that "Impounded livestock traditionally means that an animal has been mistreated, neglected, or abandoned (and) associated with individuals that don't have the best interest of animal or human life in mind.

"What is going to deter the owner of an impounded animal from coming onto the preserve to 'steal" their livestock back?"

# South Florida Water Management District fires contractor, what's in store for giant C-43 reservoir?

Construction of the C-43 reservoir is on hold after the South Florida Water Management District fired the contractor for the half-billion-dollar-plus job in early May. The district announced the contract termination Monday. Work won't halt for long, promises Chauncey Goss, who chairs the district's governing board. As it searches for a new firm – or firms, "We're not stopping the project," said Goss, "and the end result is we're going to be finished quicker."

In the coming weeks, "We're going to make sure the site is maintained, we're going to make sure we don't go backwards and we're going to move forward with finding a (replacement)."

## What led to the contractor being fired?

It came down to chronic delays, said South Florida Water Management District Communications Director Sean Cooley, who said his agency "was forced to make the difficult decision of terminating our contract (after) the contractor simply couldn't stay on schedule and would not make the necessary changes to get back on schedule or prevent further delays."

Cooley said the contracting outfit, known as C-43 Water Management Builders, which included Lane Construction and Webuild, was averaging "an additional 20 days of delay for every month on the job, which would result in a project delivery upwards of three years late. Such poor performance is contrary to the contract and is unacceptable."

Lane disagrees. "The district's statement is false and self-serving at best," wrote spokeswoman Lauralee Heck-man in an email. "It was the district, and not the contractor, who caused over a year of project delays and millions of dollars of cost overruns that Florida taxpayers ultimately will have to bear. Rather than work with us in good faith and with fair dealing to take care of these problems, the district wrongfully blamed the contractor, and then terminated the contract despite having complimented our immense efforts to successfully complete this project.

"Make no mistake, we will defend ourselves and hold the district accountable for their senseless actions," Heck-man wrote.

### A moving finish line

The \$560 million-plus job has been troubled for years. In 2017, the district projected it would be done by 2022. When it hired Lane in 2019, the promised end moved to July 2024, which was later pushed to October of that year. At a district board meeting last March, 2023, Lane CEO Mark Schiller got an earful about the pace of work, but promised his company would get things back on track.

In March of this year, the district gave the contractor one more chance to shape up, in the form of a cure notice, essentially a final warning. Again, Lane said it was trying to keep working on a recovery plan, and blamed the district for the delays.

### How the C-43 reservoir fits into the big water quality picture

The reservoir is part of a massive package of water quality improvements ordered by Gov. Ron DeSantis just after he took office in 2019. The reservoir was a part of that, designed to help the Caloosahatchee by storing rainfall, then releasing it during the dry season.

C-43 is the official name for the river, a human-engineered link between Lake Okeechobee and the Gulf of Mexico that regularly suffers from too little freshwater as well as multi-source pollution within its watershed. A healthier river means a cleaner estuary, which means better water for Sanibel, Fort Myers Beach and the region's other barrier islands and coastline.

In an emailed statement, Calusa Waterkeeper Codty Pierce said his nonprofit "has no information or insight regarding the need to change contractors. We do support completion of the project because it is a key component of the Ever-glades restoration plan that will help reduce harmful discharges into the Caloosahatchee," he wrote. "So, we are eager to see the project get back on track and moving forward."

That's what the district wants too – in fact, that's why it fired Lane. "The take-away is we're going to find a new contractor," board chair Goss said. "That's the reason we're doing this. We just don't think they could finish it ... their time period was not acceptable to us.

Given the significance of the river and its estuary Cooley says, completion of the reservoir is a top priority for the district. That's as it should be, says engineer Kevin Shimp, president of Thomas Marine Construction, one of the subcontractors on the project.

"It's just a great thing for our river, because we can't reverse the past, we can't put the old waterfalls back and we can't fix it the way nature intended, but we sure can improve it. This a big, big part of that," Shimp said. "At the end of the day, it's got to be completed and it's got to be done right so it functions and we all get the benefit."

# How to identify Florida's most venomous snakes; why you'll be seeing more

At this time of year, you may begin to see more snakes slithering around your home. A local expert explains why that is, how you can tell if the snakes are venomous, and what to do if they are.

"As the rain picks up, and some wetlands start to fill up, snakes need to get on the move to find a new place to stay high and dry, maybe to find water and maybe to find some prey animals," said Ella Guedouar, a graduate snake biologist at Florida Gulf Coast University.

A high and dry location could well be your home. Guedouar identified one fearsome specimen, recently captured by a man

named Mike Falcone in a Fort Myers neighborhood, as a cottonmouth, roughly two years old. "That is a venomous viper; it's a water snake," Guedouar said. "You can kind of see this band on the eye, and the triangle-shaped head is a good way to tell what that is."

Another reason you may notice a more active snake population in the coming weeks: The adults will be out looking for mates. "We're coming to the end of mating season, so we're seeing a lot of activity with snakes because they're looking for their mates, just trying to get that in while the weather's good," Guedouar said. "Because then the females do need time to go find a nice place to lay their eggs or give birth." The egg-laying won't happen until the end of summer, but for now, they're hitting the streets.

Guedouar says the two venomous snakes you're most likely to see are cottonmouths (also known as water

moccasins) and eastern diamondback rattlesnakes. "The way that you can tell those is the diamondback is gonna be this really big snake with diamonds on its back and a rattle at the end," Guedouar said.

A lot of non-venomous snakes, however, have evolved to resemble venomous species to ward off predators. And some venomous snakes change their appearance as they age. "The best rule of thumb is just to not touch a snake, especially if you don't know what it is," Guedouar said. "In the case of the cottonmouth, they are lighter colored as juveniles, and then as they grow bigger, they'll get fatter and darker colored."



The eastern diamondback rattlesnake looks roughly the same its whole life. And if they end up on your property, Guedouar says not to reach for a shovel. "You can spray it with the hose; they do not like being sprayed in the face with water," Guedouar said. "That's a safe distance for you to be from the snake and get it to move away, or take a broom and push it away."

As much as you may want to keep snakes away, the biologist stresses their importance in our environment. "I get the safety concern because it can be a concern for little kids or dogs that are in the yard, but the reality is they are here; we are on their land," Guedouar said. "We need to learn to live with them... From my experience working with snakes, the snakes are so much more afraid of you than we are afraid of them. "

# Fish and Wildlife Commission sets Burmese python hunt for 10 days in August

Dust off your rusty machetes and polish the edge of your best hunting knife: The annual public python hunt is coming later this summer.

"Since the first Florida Python Challenge in 2013, we have reached a countless number of people across the globe, alerting them to the negative impacts caused by Burmese pythons and other invasive species in Florida," said Florida Fish and Wildlife Conservation Commission chair Rodney Barreto in a press released sent out Wednesday.

This year's hunt will take place from Aug. 4 through Aug. 13, and there are categories for professional and amateur hunters.

FWC says the 2022 hunt removed 231 pythons from the Everglades, with nearly 1,000 people from 32 states and even Latvia taking part in the 10-day hunt.

Over the past 20 years, the Burmese python has established itself as perhaps the most damaging of all invasive animals found in Florida.

In hopes of trimming the population while raising public awareness, the state of Florida holds an annual hunt.

Florida has more invasive species than most countries, and the Burmese python may be the most destructive foreign animal in the entire historic Everglades, which stretches from Lake Okeechobee to Florida Bay.

### All kills must be done humanely

Even though Burmese pythons don't belong in Florida, you still must treat them humanely. Many hunters use a 4-inch hunting knife to slice off the head in a way that kills the snake immediately.

They hold the python just behind the skull with one hand and slice through the snake with the other.

It can be a bloody mess, and the snakes will try to bite you and may spray you with liquid feces.

### It's legal to hunt year-round

Although the state holds an annual hunt, it is legal to hunt pythons ever day of the year on public lands and on more than two dozen properties managed by FWC.

Summer can be a productive time for hunting as the next generation hatched recently, so there will be plenty of small snakes on the landscape.

Many of the largest snakes are caught during winter months, when snakes will slither onto concrete surfaces, like roads, to warm themselves.

FWC says more than 18,000 snakes have been removed by hunters over the past two decades.

### These snakes get big

Burmese pythons can grow to more than 18 feet and weigh more than 200 pounds. If that sounds like a sizeable animal, that's because it is.

Pythons are at the very tip of the food chain here, and they're generalist predators that will eat nearly anything. So, while you may fear alligators, crocodiles, bears or panthers, pythons are the biggest beasts in the woods here.

### You can make money

This year the state is giving out a total of \$30,000 in cash and prizes.

Professional hunters registered with the state are paid year-round for snakes they capture and kill.

Note to folks along the Caloosahatchee: The pythons are coming north, so you are protecting your families and native wildlife, and pets when you hunt them.

# Look out: It's manatee mating season; also, some wild myths and facts

Watch out for massive piles of manatees at local beaches this summer as mating season for the sea cow has arrived.

These gentle herbivores get lost in love during the summer months, and they're practically oblivious to any nearby human activity when they're mating.

A dozen or more manatees will gather in the gentle summer surf, and they may stay in that location for a day or more.



Some marine mammals will beach themselves when they're sick, and some whales are known to follow the sick individual to the beach because their social ties are so strong.

But the manatees you might see piled up on local beaches this summer aren't sick or injured. Quite the opposite: they're creating the next generation of sea cows.

The gatherings consist mostly of several males chasing one female.

As manatees are protected by state and federal laws and are one of the most popular creatures in Florida, here are five facts about sea cows and their place in Florida lore.

### Were manatees brought to Florida?

A common myth floating around the Sunshine State is that manatees are an invasive species that were brought here to eat and help control invasive plants.

That's completely false as manatees have been swimming in Florida waters for eons, according to Mote Marine Laboratory in Sarasota.

Mote also mentions online the rumor that manatees were brought here to feed rail workers a century or so ago, and that they're called West Indian manatees because the come from the west part of the Indian Ocean.

### How many are left in Florida?

Counting manatees is difficult as they spend much of their lives submerged in murky waters.

The U.S. Fish and Wildlife Service estimates that there are 6,300 manatees in Florida and about 13,000 throughout its entire range, which includes much of the East Coast of the United States.

The Florida population has grown rapidly in the past 25 years, with the first estimate of manatees here tallying 1,267 sea cows in 1991.

They're also found in the southeastern U.S., eastern Mexico, Guatemala, Belize, Honduras, Costa Rica, Panamá, Nicaragua, Colombia, Venezuela, Guyana, Suriname, French Guiana, Brazil, Trinidad and Tobago, Jamaica, Cuba, Haiti, the Dominican Republic, Puerto Rico and in the Bahamas, according to FWS.

### There is only one subspecies in the Sunshine State

Although three different manatees are found around the world — the West Indian (found here), the African manatee and the Amazonian manatee — only one subspecies is found here.

The Florida manatee (Trichechus manatus latirostris) is a subspecies of the West Indian manatee, according to FWS.

The Antillean manatee (Trichechus manatus manatus) is the other subspecies, and it's found from the Caribbean south to Brazil in South America.

### They're called sea cows because they eat grass

These gentle herbivores keep it simple when it comes to their diet, which consists of various types of sea grasses.

And they have no natural predators here, so they're free to roam the coast and look for pockets of what's left of the state's coastal grass systems.

### You can look, but don't touch

Manatees are protected under the Marine Mammal Protection Act, among other laws. The basic premise is that it's illegal to do anything to a manatee that will change its behavior.

That could be anything from chasing one in your kayak to actually sitting on one for a photo opp.

And don't get into the group for any reason as it is against the law and potentially dangerous as manatees can grow up to 3,500 pounds.

Subject: Veto Request on Fertilizer Ordinances

Dear Governor DeSantis:

On behalf of Captains For Clean Water and our community of supporters, we respectfully request that you veto the following proviso language found in line item 146, page 55 of SB 2500:

From the funds in Specific Appropriation 146, \$250,000 in nonrecurring funds shall be used by the University of Florida Institute of Food and Agricultural Sciences (IFAS) to evaluate the effectiveness of the timing of seasonal fertilizer restrictions on urban landscapes toward achieving nutrient target objectives for waterbodies statewide. IFAS must submit a final report, including results and recommendations, by December 31, 2023, to the chair of the Senate Appropriations Committee and the chair of the House Appropriations Committee.

AND

Page 86, lines 2455-2460 of the implementing bill, SB 2502:

Section 85. In order to implement Specific Appropriation 146 of the 2023-2024 General Appropriations Act, a county or municipal government may not adopt or amend a fertilizer management ordinance, pursuant to s. 403.9337, Florida Statutes, which provides for a prohibited application period not in existence on June 30, 2023. This section expires July 1, 2024.

The hallmark of this administration has been to further and protect clean and usable waterways throughout the state. The proviso language in 146 does nothing to ensure clean and usable waterways in the state of Florida. The potential short and long-term implications of this proposed language on water quality are unknown at this time yet have the potential to result in devastating impacts on waterbodies statewide.

We encourage you to safeguard the momentum you've achieved on restoring and protecting Florida's environment by vetoing this language. Thank you for your careful consideration.

# ALVA's OWN Ross Chastain's timeline of controversies: Why NASCAR driver has become Cup Series' latest villain

(NASCAR - David Suggs)



## There's a new villain in the NASCAR Cup Series.

He's prickly as a pinecone, though he tries to disarm fans with an ever-mischievous smile. He's one of the series' best drivers but also one of its most controversial.

Ross Chastain has earned quite a reputation since making his Cup debut in 2017. The Trackhouse Racing driver has become a household name in stock car racing by pairing fast cars with an ultra-aggressive approach. He fell just short of a championship last year, finishing second in the final race.

He has become one of NASCAR's most polarizing personalities. Perhaps it's the watermelon tosses off his car's roof when he wins races. Or maybe it's his belligerence; Chastain has gotten into it with nearly every big name in NASCAR, from Denny Hamlin to Kyle Larson. He punched rookie Noah Gragson in the face.

Love him or hate him, fans can't stop watching. Here's what you need to know about the Cup Series' most talked-about driver right now:

### Who does Ross Chastain drive for?

Given his ebullient personality, Chastain needed a team capable of promoting his brand. Fortunately for him, he found that in Trackhouse Racing. It doesn't have the name recognition of Hendrick Motorsports, Joe Gibbs Racing or Richard Childress Racing, but Trackhouse is an emerging force in the world of stock car racing. Owned by Miami's 13th-best rapper (Pitbull) and former Cup Series driver Justin Marks, Trackhouse has been a bulwark against blue-chip organizations like Hendrick.

Founded in 2021, the organization deploys two teams in the Cup Series: Chastain's in the No. 1 car and Daniel Suarez's in the No. 99 car.

### **Ross Chastain timeline of controversies**

2015: Chastain introduced himself to the NASCAR world in the Xfinity Series. After finishing 32nd in the U.S. Cellular 250 at Iowa Speedway, he got into an altercation with Ryan Reed, who claimed that the watermelon farmer dumped him into the wall in Turns 3 and 4 on the final lap of the race. Chastain's excuse: it was a green-white-checkered finish.

2017: As Chastain's stock rose in the Xfinity Series, the carnage increased. There was a war of words between he and Jeremy Clements after they pair got into each other under caution at Bristol.

Chastain also showed that he wasn't afraid to duke it out. When he and Brendan Gaughan made contact at Texas. Gaughan grabbed Chastain's shoulder after the race, prompting Chastain to declare he was always going to defend himself if someone were to get physical with him. Keep that in mind for later.

2018: Another Xfinity Series race, another confrontation. Chastain ruffled feathers after putting Joey Gase into the grass during the last lap at Mid-Ohio. That set Gase off, with the No. 35 driver driving his car toward Chastain's No. 4 vehicle on pit road with people on the track. Gase attempted to accost

Chastain but was met with brute force: one of Chastain's crew members drove him into the ground with a perfectly timed tackle.

Chastain followed up his dust-up with Gase by jostling with 2014 Cup Series champion Kevin Harvick at Darlington. During the final stage of an Xfinity race, Chastain dumped Harvick into the middle of the track while racing for the lead. Harvick was less than pleased; he claimed Chastain wouldn't get a chance to race in "really fast" cars again.



Chastain's playoff hopes that year came to an end at

Dover, but he made sure to go out with a bang, sending Matt Tifft into Chase Briscoe in the final stage of the final race of the Round of 12. Tifft made sure to get payback, bumping into Chastain after the cooldown lap. He claimed his foot "slipped" off the clutch.

2019: Things were fairly quiet for Chastain this year, save for a collision with Justin Allgaier at Watkins Glen. Chastain spun Allgaier out at the end of Stage 1, a move that Allgaier thought was intentional. Allgaier responded in kind, sending Chastain into the tire barrier in the final moments of the race. Chastain's No. 4 car was totaled, Allgaier got his payback and the world got yet another look at Chastain's aggression.

2022: This was a breakout campaign for Chastain. Not only did he establish himself as one of the fastest drivers in the Cup Series, he also made headlines for his pugnacious style. In a short period of time, he went from afterthought to perhaps the most feared driver in the field. Granted, a lot of that apprehension came from his propensity for ramming into other drivers' vehicles.

He opened the year with a flourish, butting heads with Ryan Blaney and Martin Truex Jr. after contact at Richmond and Dover, respectively. Then came the real kindling for the inferno: his drive at Gateway.

Chastain was a wrecking ball that day, with not one, but two skirmishes. First, sent Denny Hamlin's No. 11 car careening into the wall. He followed that up by spinning out Chase Elliott, a maneuver that really put him in the crosshairs of his fellow Cup Series competitors.

Chastain then cemented his status as one of the Cup Series' top antagonists. And like any great villain, he made sure to leave a trail of wreckage in his wake.

His next victim was Austin Dillon, in a major wreck at Atlanta that sprung from a show of force by Chastain.

"Looks like we were just a casualty of Ross Chastain," Dillon said after being knocked out of the race.

Then came some more Hamlin-Chastain theatrics, this time at Pocono. Hamlin was the aggressor that day, getting next to Chastain's bumper. Chastain went twirling, Hamlin won the race, Chastain tallied a DNF and the racing world was abuzz.

"I think that's something that has been owed to me for a few months now," Chastain said post-race.

Things went quiet on the Chastain front for a few weeks, until he made a detour at The Brickyard.

Chastain tried to cut through an access road on the Indianapolis Motor Speedway Road course. He was promptly handed a 30-second penalty. Then again, if you ain't cheating, you ain't trying.

Chastain saved his best (worst?) for the playoffs. He pulled off one of the most dramatic moves in NASCAR history, his now-infamous "video game" gambit to snag the final spot in the Championship 4



from Hamlin. The now-illegal action represents one of the greatest moments in the sport's history, one that left even his fellow Cup Series drivers speechless.

That wasn't the only time Chastain got under a driver's skin in the postseason. In the championship race at Phoenix, he got into fellow Championship 4 driver Chase Elliott, sending Elliott's No. 9 Chevrolet spinning. Elliott finished 28th.

2023: If anyone thought Chastain was going to ease up on the throttle in 2023, they must have not seen him race. The No. 1 has been a lightning rod for criticism since the start of the season.

He helped precipitate Kyle Larson's massive wreck at Talladega in April, running into Noah Gragson. The move resulted in Larson's car looking like it had been struck by a cannonball.

Then came the fisticuffs. Chastain hit Gragson with a sweet right hand at Kansas, putting an end to post-race proceedings. Gragson confronted Chastain after the two made contact in the Advent Health 400.

Shortly thereafter, Chastain made waves again at Darlington. He put himself and his fellow Chevrolet drivers at Hendrick Motorsports in increasingly awkward positions with his wheel work.

"Why did he run us right into the fence?" Larson's crew chief, Cliff Daniels, asked after Larson was knocked out the race.

"Make those three races he's taken us out of, Chevrolet. Three races," Daniels said. He was alluding to Talladega and an incident and Dover in addition to Darlington.

Hendrick Motorsports owner Rick Hendrick said after the race that Chastain can expect payback for his antics.

"He's got a lot of talent, but he's making a lot of enemies out here," Hendrick said.

A few days later, Chastain told reporters he had spoken with Hendrick and Larson.

"One day, I hope I'm able to laugh with him about it," Chastain said. "Look, it's still crazy for me that Rick Hendrick knows my name. Right now, it's for the wrong reasons, but seriously."

Love him, hate him or somewhere in between, people can't take their eyes off him. They keep talking about him. That can only be a good thing for NASCAR.

# SAFETY AT THE GAS STATION

Thefts at gas stations, across the United States, remain a concern for law enforcement. Like many other crimes of opportunity, an unlocked vehicle with personal items in sight makes for a quick and easy target.

Whether you are simply distracted while pumping gas or inside paying, thieves wait for the opportunity to quickly open your vehicle door and grab anything and everything of value. Car thieves sit in waiting for the opportunity to occupy and steal a running and/or unlocked vehicle.

Many elect to use their refueling time as an opportunity to catch up on missed text messages, listening to voice mail and returning phone calls. These distractions make one an easier target. Choosing well-lit fuel stations with surveillance cameras decrease the appeal to criminals.

Whenever possible, purchase fuel during daytime hours and do so from a station that offers significant visibility to the roadway. Select a pump closest to the structure. This increases your visibility to cashiers and staff that work inside. Additionally, due to their proximity to the register, these pumps are generally free of skimming devices. Locking your vehicle doors and keeping valuables out of sight make it extremely difficult for thieves to enter your car or truck. Take your keys with you...do not leave them in the ignition or leave fobs on the seat.

Be certain to terminate your credit card transaction, at the pump, prior to leaving and ensure that the pump handle is fully seated in order to complete your transaction.

# **Every Small town has its well-known characters**

Nadene- Does anyone remember the hermit who we used to call old man Wakefield? It was back in the 1950's and 60's.

He lived deep in the woods near my aunt and uncle. He would sit on their front porch each day and read their paper.

My aunt would do his shopping and even give him a haircut. I remember being so intrigued by him as a kid, and am to this day. He was truly a mystery man.

I have no idea how long he lived there. I know that he died in the house. I don't know what year what year.

Dan- at one time my uncle owned all of Tuckahoe Road (South of the Alva Diner at the end of paved Packinghouse Road).

The shack old man Wakefield lived in had no power, running water or phone. It wasn't right on Tuckahoe, but back in the woods near this house which is still there.



Ken DeWalt-Several years ago my wife Ramona and I were traveling through Southwest Texas to visit one of the least visited National Parks in America. Big Bend, on the Rio Grande.



We were south of Fort Stockton and it was time for a break so as we entered the small desert town of Marathon, we began looking for lunch. But EVERYTHING in town but the hotel was closed. Why? It wasn't a Sunday. The answer came from the one server at the empty Gage Hotel dining room.

Everyone in the town, at least 98% of the entire area's residents were at this church shown to the right.

The town's oldest resident, a hermit of the desert, had died that week. He had been known to three generations of neighbors as one of the nicest, most willing to work at odd jobs, favorite of kids and adults, full of old-time wisdom and great local stories, and faithful attender in this church.

This street and every open space for a quarter mile was jammed with vehicles.

Sometimes the town hermit, character, beggar, is the best liked resident in the village.



# BUCKINGHAM FIREWORKS CAKE

# **Ingredients**

## **CAKE:**

- Cooking spray
- 1 cup (8 oz.) salted butter, softened
- 2 cups granulated sugar
- 4 large eggs, at room temperature
- 3 cups (about12 3/4 oz.) allpurpose flour
- 1 tablespoon baking powder
- 1/2 teaspoon table salt
- 1 cup whole milk
- 2 teaspoons vanilla extract

# **FILLINGS:**



- 1 teaspoon cornstarch, divided
- 1 teaspoon water, divided
- 6 ounces fresh blueberries
- 2/3 cup granulated sugar, divided



- 3 tablespoons fresh orange juice (from 1 orange), divided
- 3 tablespoons fresh lemon juice (from 1 lemon), divided
- 1/4 teaspoon table salt, divided
- 1 cup chopped fresh strawberries (from 1 3/4 cups whole strawberries)

## **FROSTING:**

- 1 (8-oz.) container mascarpone cheese
- 2 teaspoons vanilla extract
- 1/2 cup (about 2 oz.) powdered sugar, divided
- 2 cups heavy cream

## **GARNISHES**

Fresh local blueberries and strawberries

## **Directions**

1. Prepare the Cake: Preheat oven to 350°F. Generously coat a 9-x 13-inch baking pan with cooking spray. Line bottom of baking pan with parchment paper; coat paper with cooking spray. Beat butter with a stand mixer fitted with a paddle attachment on medium speed until creamy, about 1 minute. Gradually add sugar, beating

until light and fluffy, about 2 minutes. Add eggs 1 at a time, beating until just blended after each addition.

- 2. Whisk together flour, baking powder, and salt in a bowl. Add flour mixture to butter mixture alternately with milk, beginning and ending with flour mixture, beating on low speed until just blended after each addition. Stir in vanilla. Pour batter into prepared baking pan.
- 3. Bake in preheated oven until a wooden pick inserted in center of Cake comes out clean, 30 to 40 minutes. Transfer Cake in baking pan to a wire rack; let cool 10 minutes. Invert Cake onto wire rack; let cool completely, about 1 hour.
- 4. Prepare the Fillings: Stir together 1/2 teaspoon each of the



cornstarch and water in a small bowl; set aside. Stir together blueberries, 1/3 cup of the sugar, 1 1/2 tablespoons of the orange juice, 1 1/2 tablespoons of the lemon juice, and 1/8 teaspoon of the salt in a medium saucepan. Bring mixture to a simmer over

medium, stirring constantly. Continue simmering, stirring occasionally, until sugar dissolves, about 5 minutes. Stir in cornstarch-water mixture; simmer, stirring constantly, until mixture thickens slightly, 30 seconds to 1 minute. Remove from heat; let cool 15 minutes. Process mixture using an immersion blender until smooth, about 30 seconds. (Alternatively, transfer mixture to a blender, and blend until smooth.) Pour mixture into a bowl; cover and chill until cold, about 1 hour. Meanwhile, repeat procedure with remaining cornstarch, water, sugar, orange juice, lemon juice, and salt, using chopped strawberries in place of the blueberries.

- 5. Assemble the Cake: Place Cake on a serving plate. Using a 1/4-inch-wide wooden dowel or the round handle of a wooden spoon, poke holes spaced 1 inch apart over the entire Cake surface, poking at least three-quarters of the way through the Cake, but not poking all the way to the bottom. Spoon blueberry and strawberry Fillings alternately in lengthwise rows over Cake surface, being sure to fill all holes. Chill, uncovered, 1 hour.
- 6. Prepare the Frosting: Beat mascarpone cheese, vanilla, and 1/4 cup powdered of the sugar with a stand mixer fitted with a whisk attachment on medium speed until just combined, about 30 seconds. Add heavy cream; beat on medium speed until foamy, about 30 seconds. Increase speed to medium-high; gradually add remaining 1/4 cup powdered sugar, beating until stiff peaks form, about 1 minute, 30 seconds. (Do not overbeat.)
- 7. Spread Frosting evenly around sides of chilled Cake. Dollop remaining Frosting onto top of Cake, carefully spreading over top. Garnish with fresh blueberries and strawberries.

## Other Ways to Dispose of an Old American Flag


If you have concerns about burning the flag (whether environmental- or safety-related), you can consider this way to retire it:

# CRACKDOWN ON MOVING SCAMS



The Federal Motor Carrier Safety Administration (FMCSA) recently announced the launch of Operation Protect Your Move, a nationwide crackdown on scam movers ahead of the busy summer moving season. The crackdown comes in response to frequent complaints alleging some companies of using deceptive business practices that are causing consumers to pay higher fees, experience delays in receiving their household goods, or in some cases not receiving their possessions at all. The FMSCA has also seen an uptick in complaints of movers holding household possessions hostage to extort exorbitant additional charges from consumers.

FMCSA is deploying dozens of investigators across the country in an enforcement sweep to address these complaints and address complaints against moving companies and brokers that are not in compliance with federal safety and consumer protection regulations and statutes while transporting household goods. The Operation covers both movers and the brokers that purport to connect consumers to local movers but instead facilitate fraud by promoting scams.

The agency will formally document violations and has the authority to review and revoke the licenses of movers and brokers. Cases involving potential criminal misconduct may be referred to the U.S. Department of Justice for further investigation. Additionally, FMCSA will work directly with consumers to guide them through the process and help get their money and goods back.

In Florida, intrastate movers and moving brokers are required to comply with The Household Moving Services Act, Section 570, Florida Statutes. Under this statute, intrastate moving companies and moving brokers are required to register with the Florida Department of Agriculture and Consumer Services prior to conducting business as a mover or moving broker or advertising to engage in the business of moving or offering to move. Florida law also requires intrastate movers to do the following:

- Provide a written estimate covering the total cost of the move.
- Provide a written contract before performing any services.
- Disclose limitation of liability in writing at the time the estimate or contract for services is rendered.
- Accept a minimum of two of the following three forms of payment:
  - Cash, cashier's check, money order, traveler's check
  - Valid personal check
  - Valid credit card

Consumers who decide to use a professional mover should do some advance planning and research to protect themselves from unnecessary expenses.

- Plan Ahead When Possible Have at least three companies provide estimates with an on-site visit. Avoid
  companies that are only willing to do an estimate over the phone or internet.
- Do Your Homework Research whether the company is registered at <u>FloridaConsumerHelp.com</u> or by calling 1-800-HELP-FLA or 1-800-FL-AYUDA en Español.
- Read Before You Sign Remember, the contract and estimate must be signed and dated by both parties; your signature indicates that you acknowledge and accept its terms. Read the entire contract and estimate thoroughly, ask questions, and do not sign it if you have doubts about anything.
- Be Aware of Scams Scams can occur whether you are dealing directly with a moving company or using a
  broker. One such scam occurs when a moving company quotes a low price in order to secure your business,
  then increases the cost substantially after loading your household goods onto the truck. Keep a copy of your
  contract with you during the move to be able to show law enforcement if necessary. It is a third-degree felony
  for a mover to refuse to relinquish your household goods if law enforcement has determined you have tendered
  payment in the amount of the written estimate or contract.

 Make complaints in writing – Consumers who are not satisfied should make the mover aware of their claim, in writing, as quickly as possible. If the company does not handle your claim satisfactorily, you may also file a complaint with the Division of Consumer Services at FloridaConsumerHelp.com.




