The undersigned agrees to collect a five percent (5%) tax on all rents or leases for temporary lodging of less than thirty (30) days. The undersigned agrees to collect a three percent (3%) tax on all liquor by-the-drink which includes alcohol or spirits, beer and wine, sold on the premises for human consumption. The undersigned agrees to collect a two percent (2%) tax on each sale made at retail exempting only those sales already exempt by State law under Chapter 36, Title 63, Idaho Code and further exempting groceries and building materials as defined in Section 2 of Ordinance 2015-11 and further exempting lease purchase agreements or leases with the option to purchase of motor vehicles. The undersigned further agrees to remit the above five percent (5%) tax on rents or leases, three percent (3%) tax on liquor by-the-drink and two percent (2%) on retail sales for each calendar month on or before the 25th day of the succeeding month to the City Clerk of the Lava Hot Springs, Idaho.
