Engineering Progress Report – Keller Associates

Bryan Phinney – Rooftop Bar we have worked with Hudson Saffell and got that taken care of. Goldberg- Gary has been working on it. Junto we are working on it. The 4th street has put on hold. We are waiting on products, possibly August. Water status changed yesterday, we are starting on the update. Wastewater study are still on hold for another month or two. We did the the 50% grant from DEQ. When we submit an invoice to the city DEQ will reimburse half to the city. The studies will take 12-24 months. My goal is 8 – 10 months. Lagoon seepage test – waiting on the weather to clear. On the new well we have agreed to be able to do two test sited. We tried for the back of the property so it wasn't so significant an impact. We are hoping for 125 gallons per minute. That is less than we need but it is the reality. We need 250 - 300 gallons per minute.
