No permits will be issued by the city until all Departments sign off.

- 10) IDENTIFICATION OF THE USE OF THE STRUCTURE OF THE PARCEL RPRLAH 3001701 IF SUCH USE SITE PLAN OR CONSTRUCTION DRAWINGS REQUIRE ADDITIONAL REVIEW BY CITY DEPARTMENTS AND/OR AN AMMENDED SITE PLAN INCLUDING ANY PLANNING COMMISSION RECOMMENDATIONS OR CITY COUNCIL APPROVAL. SUCH REVIEWS AND APPROVAL SHALL OCCUR BEFORE ANY SITE CHANGES OR GRADING ON SAID PARCEL. Planning Grant Study for Water & Sewer

Bryan Phinney (engineer for Keller Asso)- A water & sewer study required every 5 years. We are proposing this because Idaho received money for projects. This year all applications for studies have been approved, usually only 20% get approved. In order to be approved for future project we need a current study (our water study is 5 years old and sewer is 7 years old) to be eligible for future grants.

Discussion continues identifying other projects that we could get grant help on if we have current studies. Bryan Phinney- We have not seen funding like this since the 1970's. These are a 50/50 match. We need to let them know by Sept. 2nd if you are interested.
