Mayor Thomson – No, just listen. You just read that I have the right as the Mayor to appoint or to remove in which case you need to validate. Leah Navarro – MUST CONFIRM

Leah Navarro - So, Canda is still the City Clerk?

Leah Navarro – She didn't quit she resigned. And then she resigned again and you said...You kept her on until we did the budget.

Mayor Thomson – Everyone kept her on. You guys accepted her resignation...her retirement. You don't have to accept her retirement. She retired.

Leah Navarro – No, we did not. She had a letter of resignation that has never been accepted.

Mayor Thomson – She is no longer here. She is not an employee. So either accept her resignation, accept her retirement, accept whatever you want to accept.
