

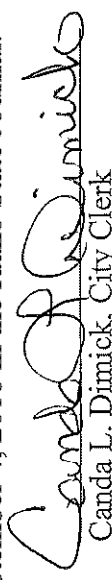
NOTICE OF PUBLIC HEARING
PROPOSED BUDGET FOR FISCAL YEAR 2018-2019 (FY2019)
CITY OF LAVA HOT SPRINGS, IDAHO

A PUBLIC HEARING PURSUANT TO Idaho Code 50-1002 will be held for the consideration of the proposed budget for the fiscal year from October 1, 2018 to September 30, 2019. The hearing will be held at Lava City Hall, 115 West Elm Street, Lava Hot Springs, Idaho at 6:30 p.m., on September 5, 2018. All interested persons are invited to appear and show cause, if any, why such budget should not be adopted. Copies of the proposed City budget in detail are available at Lava City Hall during regular office hours, 9 a.m. to 2 p.m., week days. Lava City Hall is accessible to persons with disabilities. Anyone desiring accommodations for disabilities related to the budget documents or to the hearing, please contact the City Clerk's office (208)776-5820 at least 48 hours prior to the public hearing.
