Paddle Scotland is the Governing Body for paddlesport in Scotland. We are a membership organisation comprising more than 4,000 individual members including over 2,300 qualified coaches.

We have a network of 80 affiliated clubs and delivery partners throughout Scotland offering a range of paddlesport disciplines.















As a people-focussed and volunteer-led organisation, we strive to support and educate everyone who paddles in Scotland.

Our aim is to cultivate an inclusive community people want to be part of, with opportunities for all to grow, develop and progress in paddlesport.



As outlined in our 'Paddlesport for All' strategy, we believe that paddlesport is something that everyone should be able to enjoy regardless of background or circumstances.

We want to **make the sport more accessible** and work in partnership with other organisations to seek out how to remove real and perceived barriers that prevent people taking up and flourishing in our sport.



We are in the process of renewing our long-term strategy and the new strategy will focus on **developing a thriving paddlesport community** throughout Scotland.

It is likely to encompass a continued focus on developing people, connecting and listening to our membership and partners, refreshing how we support clubs and paddlers and promoting responsible paddlesport.

The Scottish paddlesport community is a vibrant, strong and welcoming community of people and organisations and we achieve more when we work together.





- The Chair of the Board of Paddle Scotland holds a **pivotal leadership role**, responsible for ensuring the effective operation of the Board and strong governance across the organisation.
- The Chair is appointed for a **3 year term** and is expected to commit **2-3** days per month to the role including circa **8 board meetings** per year.
- As the leader of the Board, the Chair sets the tone for ethical conduct, oversees the development and delivery of the organisation's strategic objectives, and ensures that the Board functions efficiently, making informed, balanced decisions.
- The Chair will support the recruitment of a permanent CEO and work closely with them to provide guidance and support while maintaining a clear distinction between governance and management. They are also responsible for facilitating open, inclusive discussion among Board members, ensuring proper oversight of risk and compliance, and representing the Board in high-level external relations with stakeholders, government bodies, and other partners.









Board Direction and Team Management

Provide Supervision and Guidance:

- to the Board of Directors, fostering a cohesive and productive team dynamic. Encourage the Board's involvement.
- in strategic planning and key decision-making processes. Utilise the strengths of Board members.
- to enhance overall effectiveness.

Line Management and Governance Oversight

- Line manage the CEO, including conducting annual performance reviews and maintaining a strong working relationship with the senior team.
- Ensure accountability and implementation of recommendations from the governance review of Paddle Scotland.
- Act as a bridge between the Board and the CEO, overseeing the implementation of governance review initiatives.

Meetings and Effectiveness

- Chair meetings of the Paddle Scotland Board.
- Chair Annual General Meetings and General Meetings of Paddle Scotland.
- Conduct an annual review of Board effectiveness and ensure the appropriate mix of skills for effective governance.
- Collaborate with the CEO to develop meeting agendas and plans.

Reporting and Communication

- Act as a project sponsor for various initiatives, leveraging external knowledge and experience to drive innovation within the organisation.
- Plan for the continuous development of Paddle Scotland, including reviewing the long-term vision and strategy.



Role Responsibilities

External Relations and Compliance

- Develop and maintain external relationships with key partners, particularly the Paddle UK, the other Home Nations for the sport and sportscotland.
- Ensure Paddle Scotland complies with standards of good corporate governance, including risk management and fulfilling any independent audit requirements.
- Act as a Director of Paddle Scotland, working in the organisation's best interests in line with the Companies Act 2006 and the Ethical Standards in Public Life etc. (Scotland) Act 2000.

Representation and Networking

- Represent Paddle Scotland at various meetings and events, contributing to the organisation's profile and impact.
- Participate in wider network events within the Scottish sporting system, contributing to the growth and development of paddlesport in the country.

Other

- Ensure Safeguarding & Wellbeing and Equality, Diversity and Inclusion are visibly supported and encouraged.
- Travel across Scotland and overnight accommodation may be required as part of this role.
